About clemency

If you have been convicted of a crime, you may apply for clemency to request forgiveness or reduce your sentence. The Governor has the power to pardon a conviction or commute a criminal sentence based on recommendations from the Board of Pardons.

- **Pardon:** Total forgiveness of the conviction. It restores the rights and privileges forfeited.
- Commutation: Reduces or modifies your sentence. It does not erase the conviction.

What type of clemency should I request?

Convicted of a criminal offense in the past

• Pardon: This is complete forgiveness for the crime. It restores your rights and privileges.

Currently on parole

- Commute parole: This ends parole supervision.
- **Pardon:** This is complete forgiveness for the crime. It restores your rights and privileges. Anyone can apply for a pardon, but if you are still on parole, we recommend applying for a commutation since it is designed to modify or reduce parole terms.

Currently in prison

- **Commute life imprisonment:** This may reduce your life sentence to life on parole or a consecutive sentence. For example, a life sentence without the possibility of parole could be commuted to life on parole.
- **Commute death sentence:** This will reduce your death sentence to a life sentence without the possibility of parole. This spares the individual from execution but does not overturn the conviction or release them from incarceration.
- **Commute minimum sentence:** This may reduce the minimum time a person is required to serve prior to parole eligibility. For example, if your sentence is "10 to 20 years in prison," this could reduce the minimum lower end of the range to be eligible for parole sooner. This type of clemency may be sought by applicants who haven't served their minimum sentence.
- **Commute maximum sentence:** This may reduce the maximum time a person is required to serve. For example, if your sentence is "10 to 20 years in prison," this could reduce the higher end of the range to be released sooner. This type of clemency may be sought by applicants who have served their minimum sentence but are still incarcerated.
- **Pardon:** This is complete forgiveness for the crime. It restores your rights and privileges. Anyone can apply for a pardon, but if you are still serving your sentence, we recommend applying for a commutation since it is designed to reduce or adjust active sentences.

Before you apply

Gather required court documents

You must provide the following documents for your application to be reviewed. Incarcerated applicants do not need to submit court documents.

You must provide the following documents:

- Criminal complaint
- Affidavit of probable cause
- Criminal information/indictment
- Final plea or verdict
- Sentencing order
- Documentation of your financial obligation status

If the court does not have these documents, they must provide a letter confirming they are unavailable. If you were sentenced by a Magisterial District Judge and your case is older than seven years, you are not required to get a letter.

Any unpaid fines, fees, or restitution may delay your application. It's strongly encouraged to pay these before applying.

Prepare personal statement and documents

Write a personal statement explaining why you are requesting clemency and how your life has changed since the offense. You may also include:

- Letters of support.
- Certificates or diplomas from education or training programs.

Apply for clemency

Complete the application packet and mail or email it to the Board of Pardons.

I understand that if my charges are covered by Limited Access or Clean Slate laws (18 Pa.C.S. §§ 9122.1 and/or 9122.2), some details about my convictions or non-conviction records may still be shared during a public hearing if I am granted one. This is because hearings by the Pennsylvania Board of Pardons are public under the Pennsylvania Constitution and Board regulations.

If any corrections are needed to complete my application, I give permission for the Board of Pardons to make those corrections for me. By signing, I also agree to the following:

- Only the convictions listed in Section 4 of my application will be considered for clemency.
- My application won't be accepted unless all questions are answered, all required documents are included, and the Board of Pardons' rules are followed.

I give up the protections of Limited Access and Clean Slate laws for this process, so the Board can fully review my application and ensure it follows legal requirements if sent to the Governor.

7. Finalize your application

Before mailing your completed application, confirm that all sections are completed, and your documents are included.

You must mail all required documents with your application or email them to <u>BOPclemency@pa.gov</u>.

Documents

All non-incarcerated applicants are required to submit these documents:

- Criminal complaint
- Affidavit of probable cause
- Criminal information/indictment
- Final plea or verdict
- Sentencing order
- Documentation of your financial obligation status

If the court does not have these documents, they must provide a letter confirming they are unavailable. If you were sentenced by a Magisterial District Judge and your case is older than seven years, you are not required to get a letter.

These documents are not required but can support your application:

- Letters of support
- Certificates or diplomas from education or training programs

What happens after you apply

It will take a few years for a decision to be made on your clemency application. These are the steps of the process.

Board of Pardons reviews your application
After submission, you will receive a confirmation let

After submission, you will receive a confirmation letter. Incomplete applications will not be reviewed until all requirements are met. The longest wait in the process is between the Board of Pardons reviewing your application and the Department of Corrections investigating your case.

2) The Department of Corrections investigates your case

Staff will interview you over the phone and gather information on your personal status, criminal history, and driving record.

(3) Merit review

The Board evaluates your application and votes on whether to grant a public hearing. Applicants are not required to attend this public vote by the Board.

Public hearing
Applicants attend a virtual hearing to answer the Board's questions. If your case

receives enough votes, it is forwarded to the Governor.

Governor's decision

The Governor makes the final decision to approve or deny your clemency request.
