

**Status of Appropriations
Special Funds
June 30, 2026**

In order to accommodate the year-end rollover and payroll processes in SAP, the Accounting System was closed for posting period 12 on July 1, 2026, and period 13 on July 24, 2026, with the resulting SAP Fund (appropriation) balances carried forward at that time, prior to the completion of all reconciliation processes. Any adjustments to the accounting system for discrepancies disclosed by the reconciliation process will be posted to SAP during the 2026-27 fiscal year.

Supplemental appropriations to the 2025-26 fiscal year, which were signed into law as part of the General Appropriation Act of 2026 on July 12, 2026, are reflected in the June 30, 2026, Status of Appropriations.
