

**STATEMENT OF WORK
TRAINING SERVICES
INVITATION TO QUALIFY (ITQ) CONTRACT**

OVERVIEW: The purpose of this Training Services ITQ is to qualify responsible and responsive Contractors to perform training services to Commonwealth of Pennsylvania’s executive agencies. In addition, Local Public Procurement Units, as defined by the Commonwealth Procurement Code, may use this contract in accordance with the COSTARS Provision contained in the terms and conditions. Training includes, but is not limited to, assisting in the development, design, and implementation of training programs to enhance the skills development of personnel to better service the needs of the Commonwealth. The Commonwealth may add additional categories as a need arises.

Staff augmentation is not permitted under this contract.

QUALIFICATIONS: Contractors interested in becoming an ITQ Contractor must meet the following requirement. Failure to meet the below requirement will result in the application being rejected. Each Contractor that meets the minimum qualifications will be awarded a contract. Award of a contract to a Contractor is not a guarantee of business.

- Contractor must provide documentation showing two (2) years of experience from the commodity code selected under Service Categories.

SERVICE CATEGORIES: Contractors will need to pick the appropriate commodity code(s) to qualify for this contract. Contractors will select the appropriate code(s) under the Business Details section of the qualification process. The Commonwealth may add additional commodity codes as the need arises. ***Contractor must have an area of expertise in one or more of the following curricula:**

The purpose of this curriculum is to enable participants to effectively identify roadway, vehicle, and scene evidence found at motor vehicle collision and crime scenes, document evidence in an effective manner, and use the evidence to produce workable forensic maps and models. The curriculum goes further to use mathematical concepts and industry accepted methods of investigation to draw inferences as to how and why motor vehicle collisions have occurred as a means of drawing conclusions as to causation and fault.

Forensic Documentation & Mapping – Courses or curriculum address aspects of collision and crime scene documentation to include methodology of evidence identification and collection, the use of forensic mapping equipment, and preparation of court demonstratives such as forensic maps, 3-dimensional models, and animations/simulations.

Mathematical Concepts – Courses or curriculum address the understanding and use of basic and complex mathematical concepts and general rules of physics as they relate to the motion of objects, their interactions with one another, and the post-interaction displacement. Such concepts may include, but not limited to, algebraic expressions and concepts, geometry, trigonometry, and general physics concepts.

Vehicle Inspection & Examination – Courses or curriculum address the mechanic construction and dynamic design of various vehicle types, their capabilities and short-comings of various vehicle types, and how to examine and evaluate vehicle patency and potential failure, pre- and post-collision.

REQUEST FOR QUOTES (RFO) PROCEDURES: Commonwealth Agencies will issue an RFQ to qualified Contractors, through the Commonwealth’s Custom Portal, powered by the JAGGAER system. Contractors will respond to the RFQ in the system. The requesting Agencies may require the qualified Contractors to furnish, upon request, additional documentation in the RFQ. The qualified Contractors selected for the RFQ process will receive a Purchase Order (PO) and will supply the service to meet the specific requirements as indicated in the RFQ.

Agencies will exercise a scoring method based upon the criteria set forth in the RFQ. The Scoring Methods are defined as follows:

- Best Value
 - Refers to the process of selecting the quote which provides the greatest value to the agency based on evaluating and comparing all pertinent criteria, including cost, so that the Contractor whose overall proposal best suits the agency's needs is selected for each individual project; and
- Low Cost
 - Refers to the lowest cost quoted from all proposals received that are deemed both responsive and responsible for the project.

ALL PURCHASE ORDERS SHOULD STATE THE FOLLOWING:

CONTRACT-007.02 Estimated Quantities (Nov 30 2006) It shall be understood and agreed that any quantities listed in the Contract are estimated only and may be increased or decreased in accordance with the actual requirements of the Commonwealth and that the Commonwealth in accepting any bid or portion thereof, contracts only and agrees to purchase only the materials and services in such quantities as represent the actual requirements of the Commonwealth. The Commonwealth reserves the right to purchase materials and services covered under the Contract through a separate competitive procurement procedure, whenever Commonwealth deems it to be in its best interest.
