Dear Chairmen:

I am pleased to present the annual report on the Department of General Services' (DGS) efforts related to the Downtown Location Law of 2000 and subsequent amendments. With a workforce of nearly 75,000 employees, state government clearly plays a role in generating economic opportunities for businesses and communities across Pennsylvania, and through the Downtown Location Law, positively supports local efforts to revitalize downtowns and strengthens community tax bases.

In October 2013, I had the opportunity to testify before the Senate Urban Affairs and Housing Committee and discuss the successes and challenges of the Downtown Location Law. While the intent of the act is to encourage office locations in traditional business districts, little effort had been taken to reflect the steady reduction in Commonwealth space needs over the past decade. Advances in technology, hiring freezes and general operational realignments had created significant amounts of underutilized space. Since 2011, DGS has made space reduction a priority and eliminated over 526,000 sq. ft. representing \$9 million in annualized savings. This is nearly a 6% cut in space in three and a half years.

Although the space reduction initiative has been a great success to date, it has slowed efforts to relocate to downtown areas by reducing the number of new lease opportunities. Agencies are relying less on storefronts and bricks-and-mortar and moving toward internet and mobile technology-based business solutions. These changes have enabled the Commonwealth to maintain a smaller state workforce, while still delivering critical services to Pennsylvanians. We

believe these fiscal and technology trends will continue to influence operational models for years to come.

While those are some of the challenges we face, one thing that has not been reduced is our commitment to providing economic opportunities when we are able to do so. DGS has reviewed the Commonwealth's lease portfolio and space needs and updated the Department's downtown location policies to meaningfully improve the definition of downtown areas. Furthermore, as new lease solicitations are issued, DGS is requiring downtown locations be included in the requested solicitation areas and agencies weigh the economic and social benefit to the community as an evaluation criterion.

Due to inconsistent application of the definition of "downtown" and erroneous lease data, DGS has determined that past reporting was substantially inaccurate. The Department has implemented new lease management software and developed clearer definitions to better identify downtown and traditional business districts, as well as exempt uses under policy, e.g. warehouses, liquor stores, State Police barracks, Department of Transportation maintenance facilities, Department of Military and Veterans Affairs' armories and Department of Conservation and Natural Resources facilities. Together with square footage and expenditure data, the new guidelines allow this year's report to more accurately portray DGS's efforts to comply with the law and further its intent to support Pennsylvania's downtowns. Because of these changes, comparative numbers are not included from prior years.

With your support, the Department of General Services remains committed to encouraging state agencies to locate offices downtown and reinvest in our communities.

**Downtown Location Report

Lease Summary

The Commonwealth has 475 non-liquor store leases. Each lease is classified into one of four categories based on the Department's Downtown Location Law (DLL) Guidelines. (See Attachment A.) In addition to defining a downtown area, the guidelines permit limited automatic exemptions for agencies with missions that make downtown locations impractical or have overriding legal requirements that dictate their location. These exemptions are liquor stores, State Police barracks, Probation and Parole offices, Community Corrections Centers, warehouse space, PennDOT maintenance facilities, Department of Military and Veterans Affairs facilities and Department of Conservation and Natural Resources facilities.

** For the purposes of this year's report, the 'Leases' category does not include the approximately 610 leases for stores operated by the Pennsylvania Liquor Control Board which are exempt by policy from the provisions of the DLL. Effective November 1, 2013, the Department resumed responsibility for managing the leasing process for the PLCB and has initiated a project to integrate the PLCB's leases into the same inventory management application used by DGS to manage other Commonwealth leases. The project is estimated to be completed by June 2015 and data will be included in next year's report.*

*** Exact occupancy rates/ employee populations are unknown. For comparative and illustrative purposes, 300 ft² per employee is used as an average occupancy rate, and thus, an employee population can be derived from the amount of leased space.*

Current Leases in Effect Prior to Downtown Location Law

The Downtown Location Law went into effect on August 21, 2000. The Commonwealth's standard office lease is typically an initial 10-year term with one or two 5-year renewal options. Therefore, it is possible that numerous leases were already in place prior to the DLL becoming law. The Commonwealth negotiates longer lease terms to obtain the best rental rates and keep moving and renovation expenses to a minimum. Although strongly encouraged, state agencies are not required to issue a solicitation for new space after all lease options have been used. Prior to any lease extension, offices in consultation with DGS review the cost and functionality of the existing location versus relocating and the associated one-time and ongoing expenses for a new office.

Although in effect for 14 years, the chart below illustrates how long it can take to fully implement the DLL when factoring in the possible twenty-plus year lifespan of a lease. As a percentage of Non-Downtown and Exempt Non-Downtown leases, pre-DLL leases represent 47% and 56%, respectively, of all leases in those categories.

Downtown vs. Non-Downtown

When the DLL was implemented, its intent was to help revitalize Pennsylvania's communities and traditional business districts by redirecting Commonwealth resources. In past reports, DGS merely reported on numbers of leases. While generally useful for broad comparative purposes, the number of leases is not an accurate representation of state's efforts. For example, some agencies create multiple leases for administrative and accounting convenience. Such practices inflate the number of leases and do not account for total square footage leased, the cost of the space and the number of employees housed in the office.

The Department has chosen to provide additional lease metrics to give better context to the effects of the DLL. As evidenced by the data below, the Downtown vs. Non-Downtown lease numbers are roughly 52% to 48%. However, the total square footage and rental cost for the space tells a far more impressive story. Space in downtown areas represents two-thirds of all Commonwealth leased space and 72% of the money spent on rent. When only looking at non-exempt leases, these figures surge to over 80%! This means that agencies recognize the importance of placing access to state services along with larger regional offices in urban centers.

Perhaps more importantly, the larger offices mean larger numbers of employees working near and spending money at businesses located in those areas. The Commonwealth does not track personnel data in a manner that can be aligned with the leasing data used in this report.

However, an estimated employee population can be inferred by using a relatively conservative average occupancy rate of 300 ft² per employee. This means that the DLL employs approximately 18,630 state workers near downtown businesses, shops and restaurants.

Exempt vs. Non-Exempt

By policy, certain leases are automatically exempted from the requirement of locating in downtown areas, but agencies with these exemptions are still encouraged to look for leases in business districts when practical. It should be noted that all but 14 of the 121 exempt non-downtown leases are law enforcement and public safety related. In comparing Exempt vs. Non-Exempt leases, the total represents only a third of all leases and about one-quarter of the total square footage and cost.

DOWNTOWN LOCATION LAW GUIDELINES
STATEMENT OF POLICY
(REVISED July 1, 2014)

Introduction

The “Downtown Location Law”, Act 32 of 2000, and as amended by Act 72 of 2012, was designed to facilitate the revitalization of traditional central and neighborhood business districts throughout the Commonwealth. The Department of General Services (DGS) has the responsibility to establish guidelines to encourage state agencies to locate in downtown areas. Further, the Department has the authority to take all measures necessary to ensure the goals of this legislation are met. The following guidelines will provide direction to agencies to comply with the Downtown Location Law.

Functional Use

The policy, as it relates to the functional use of a facility, whether owned or leased, is:

- (1) All space needed to accommodate routine agency functions and the employees engaged in those functions, and which space requires standard, non-specialized work areas shall be considered “office space” and covered by the Downtown Location Act.
- (2) Liquor stores, State Police barracks, Probation and Parole offices, Community Corrections Centers, warehouse space, PennDOT maintenance facilities, Department of Military and Veterans Affairs facilities and Department of Conservation and Natural Resources facilities are excluded.
- (3) Agencies may request an exemption to the requirements of the Downtown Location Act on a case-by-case basis. DGS will evaluate each request and determine if the exemption will be granted.

Location of Facilities

The policy is to encourage agencies to locate in traditional downtown locations, where feasible, or in established business districts within the geographic limits of certain cities to promote reuse and redevelopment, support of local business, and avoid contributing to the effects of urban sprawl. DGS considers downtown areas as defined by the Downtown Location Act to be:

- (1) The central business district of a city, borough, incorporated town or township. The central business district is typically a contiguous area within the core of a municipality with identifiable factors including, but not limited to, a recognizable sense of place, a pedestrian orientation, and a historic significance. A city may have more than one central business district, which has historically served as a hub of economic, social or civic activity.
- (2) In cities of the first, second or third class, the entire geographic area of the city.

Agencies when setting the parameters for the desired facility location should consider the following:

- (1) The requirements of the agency.
- (2) Servicing clientele needs.
- (3) Local economic considerations.
- (4) The availability of suitable space in a downtown area.
- (5) Competitiveness in the marketplace.
- (6) Cost to the Commonwealth.
- (7) Safety to persons using the office facility.
- (8) The availability of public transportation.
- (9) Compatibility with the economic revitalization plan for the downtown area.
- (10) Local zoning ordinances.
- (11) The likelihood of natural disasters and preventative and emergency response measures thereto.
- (12) Comments from existing public and private sector organizations committed to community, downtown revitalization and historic preservation as identified by the Department of Community and Economic Development.

Any solicitation requirements that DGS determines, in its discretion, have no overriding operational necessity and act as a deterrent to locating to downtown locations will be prohibited. All advertisements for new “office space” will contain the phrase “Downtown locations will be considered”.

New “Office” Facilities

When constructing new facilities, the using agency should consider:

- (1) Rehabilitating or reusing existing structures within a downtown area.
Consideration may include reasonable efforts to:
 - (i) Rehabilitate or rebuild the structure’s façade, if appropriate, in a way that maintains the architectural integrity of the building and the streetscape.
 - (ii) Ensure that the structure meets the requirements of the Americans with Disabilities Act of 1990 (Public Law 101-336, 104 Stat. 327) in a manner that respects the architectural integrity of the building.
- (2) Build on available land within a downtown area. Consideration may include reasonable efforts to:
 - (i) Have the scale and façade of the new structure built to blend with the existing streetscape.
 - (ii) Ensure that the structure meets the requirements of the Americans with Disabilities Act of 1990 in a manner that respects the architectural integrity of the surrounding buildings.

The Bureau of Real Estate will send updates regarding the implementation of these guidelines by memorandum.
