Commonwealth Reviewer Preparation

What has been done so far?

- December 2024: all participating agency and unit reviewers were identified.
- January 3rd, 2025: Optional WIOA Reviewer Informational Sessions notifications were sent
- February 2025: Optional WIOA Reviewer Informational Sessions were held
 - Newer Reviewers sessions were held on 2/4/25, 2/5/25, and 2/7/25
 - Seasoned Reviewer session was held on 2/3/25

- Local Area Plan in Microsoft Word
 - Excluding narrative from L5.4

Post-Submission Administrative Process

WIOA Plan Content Agreement

- Commonwealth partners review the submitted plan(s)
- Feedback is provided to Local Boards
 - A Master Feedback Document is always sent
 - A Q/A Hour may be Scheduled
- Local Boards make revisions
- WIOA Plan Content is Agreed Upon





Post-Submission Administrative Process

30-Day Public Notice

- Local Boards are notified when Plans are ready for Public Comment Period
- Public Comment Requirements
- Plan of Action after Public Comment Ends





Post-Submission Administrative Process

L&I Approval Letter

- Final Submission of items on WIOA Plan Submission Check List
- Final Planning Package Review
- L&I Provides Approval Letter





Post-Submission Administrative Process

Public Posting of Approved Plans

- Local Boards have 90 days after receiving approval
- The following items must be posted:
 - BWDA Approval Letter
 - If applicable, Approved Regional Plan
 - Approved Local Area Plan, including:
 - Attachment 1
 - Attachment 2
 - Attachment 3





Commonwealth Review Schedule

- Commonwealth Review Start Date: 2/24/25
 - Southeast review completion date: 3/14/25
 - Southwest review completion date: 3/28/25
 - Northeast review completion date: 4/11/25
 - South Central review completion date: 4/30/25
 - Northwest review completion date: 4/30/25
 - Southern Alleghenies, Northern Tier, Central, North Central, and Lehigh Valley: review completion date: 5/16/25
