① Claims always begin on Sundays. This is the Sunday of the week when you opened your claim.

② Your claim ending date is always a Saturday which is 52 weeks after the Claim Effective Date.

③ The final date to appeal is critical. If you plan to appeal, it must be on or prior to this date to be considered timely. Late appeals are accepted, but an Appeals Referee will decide if your reason for filing late is acceptable before the rest of your case will be considered. Appeals instructions begin on pages 6/7. You may receive multiple determinations. Always refer to the most recent.

④ Financially Eligible means you can move to the next step, and we will review your separation. Financially Ineligible means you did not earn enough in the required time frame. You will not move to the next step and you will not be able to collect benefits. You can reapply for benefits after you've earned a longer history of wages, but not before the next calendar quarter.

⑤ This grid shows values only if you are financially eligible.

- WBR is the weekly payment amount, if otherwise eligible.
- PBC is the maximum amount you can earn in part-time employment and still collect full UC benefits.
- MBA is the most you can collect on this claim over the 52-week benefit year.
- Maximum Number of Full Weeks is the number of weeks you can expect to get paid, if the full WBR is collected each week. Part-time earnings that reduce payments can extend the number of weeks.
- Dependent Allowance is the extra amount you get each week, if you told us you have a dependent child(ren) or spouse.
