UPDATE ON VEHICLE IDENTIFICATION NUMBERS BEGINNING WITH "L" EXCEPTION FOR YAMAHA MOTOR CORPORATION

This is a follow up to the notification sent in the September 2008 Driver and Vehicle Services Update bulletin, 08-05 which required all title applications for any two or three-wheeled motorcycles, motor-driven cycles, motor scooters or motorized pedal-cycles (MOPED) with a vehicle identification number (VIN) that begins with the letter "L" to be forwarded to the Special Services Unit for examination.

While the policy regarding the special examination of these title applications remains in place, the following exception is effective immediately for:

Yamaha vehicles identified with a VIN beginning with the letters "LPR" and are designated as model XF50, XC50, YW50, YW125 and YJ125. These applications may be processed online and temporary registration may be issued if requested.

As MCOs for additional makes and models of vehicles are found to be in compliance with NHTSA filings, you will be notified via another special bulletin.

REQUIREMENT TO RETAIN COPY OF FRONT AND BACK OF IDENTIFICATION CREDENTIALS

Title 67, Chapter 43.5 (f)(3) states "a copy of the document used for identification" must be retained at the place of business of the issuing agent for at least 3 years."

Effective immediately, issuing agents are required to retain a photocopy of both the front and back of the acceptable identification credential.
