Act 89 2013– Consumer Price Index (CPI) Fee Adjustments Affecting Renewal Notices

Act 89 of 2013, which became law on November 25, 2013, biennially amends many sections of Title 75. Act 89 represents an investment in Pennsylvania's future: increasing public safety, driving commerce, creating jobs, and providing reliable funding for our transportation needs without leaving the bill to our future generations.

Based on the 2025 CPI, effective July 1, 2025, the act amends the following sections of the Vehicle Code:

- Section 1927 fee for transfer of registration adjusts from \$10 to \$11
- Section 1929 fee for replacement registration plates and Amateur Radio Operation registration plates adjust from \$13 to \$14
- Section 1952(a) fee for Pennsylvania Certificates of Title adjusts from \$67 to \$72
- Section 1953 fee for recording a lien adjusts from \$33 to \$36
- Section 1955(a)(1) fee for paid information adjusts from \$14 to \$15
- Section 1956(a) fee for certified paid information adjusts from \$44 to \$47
- Section 1957 fee for return check transaction adjusts from \$48 to \$51 (fee is in addition to the \$20 Uncollectible Check Penalty)
- Section 1958(a) fees for inspection stickers are adjusted as follows:
 - Annual inspection stickers from \$11 to \$12
 - \circ Semi-annual inspection stickers from \$9 to \$10
- Section 1959(b) fee for additional places of business for messenger service adjusts from \$122 to \$130
- Section 1959(c) fee for a transfer of a messenger service location adjusts from \$25 to \$27

- Section 1369.3 fee for Veterans of an Allied Foreign Country registration plates adjusts from \$25 to \$27
- Section 1369.4 fee for USA Semiquincentennial registration plates from \$56 to \$58
- Section 1923 fee for Antique, Classic and Collectible registration plates adjust from \$96 to \$102
- Section 1928 fee for Temporary registration plates adjusts from \$19 to \$20
- Section 1930 fee for Legislative registration plates adjusts from \$97 to \$103
- Section 1931(a) fee to personalize standard issued registration plates adjust from \$97 to \$103
- Section 1931(b) fee for special organizational registration plates, including Pennsylvania Hunting Heritage and Pennsylvania Appalachian Trail registration plates adjusts from \$32 to \$34
- Section 1931.1 fee for Street Rod registration plates adjusts from \$65 to \$69
