SPECIAL ORGANIZATION REGISTRATION PLATES

PennDOT began accepting applications for the following newly designed special organization registration plates. The newly designed registration plates showcase Pennsylvania as the birthplace of America and features the Liberty Bell. The organization's name is printed at the bottom of the plate. The organization's logo appears in an approximate 3" X 3" canvas area on the left side of the plate using graphic printing that offers color and intricate detail.

The following plates are now available to be ordered:



Swing Phi Swing Social Fellowship Inc.: The plate configuration will continue to consist of the two-character stacked designation of "DD," followed by five numbers starting with the number two "2." Applicants must obtain form MV-904SP, "Application for Special Organization Registration

Plate," from the organization and pay any applicable fees, including the required fee to the department for processing. Only those Applications signed by M. Krissy Coles may be processed.

Additionally, PennDOT has approved the redesign of the logo on the following special organization plates. The newly designed registration plates showcase Pennsylvania as the birthplace of America and features the Liberty Bell. The organization's name is printed at the bottom of the plate. The organization's logo appears in an approximate 3" X 3" canvas area on the left side of the plate using graphic printing that offers color and intricate detail.

Slippery Rock University Foundation: The plate configuration will continue to consist of the two-character stacked designation of "SR," followed by five numbers starting with the number zero "0." Applicants must obtain form MV-904SP, "Application for Special Organization Registration Plate," from the organization and

pay any applicable fees, including the required fee to the department for processing. Only those Applications signed by Kelly Bailey may be processed.



Porsche Club of America: The plate configuration will continue to consist of the two-character stacked designation of "PC," followed by five numbers starting with the number zero "0." Applicants must obtain form MV-904SP, "Application for Special Organization Registration Plate," from the organization and pay any

applicable fees, including the required fee to the department for processing. Only those Applications signed by Joe Kucincki may be processed.



Elizabethtown College: The plate configuration will continue to consist of the two-character stacked designation of "EC," followed by five numbers starting with the number zero "0." Applicants must obtain form MV-904SP, "Application for Special Organization Registration Plate," from the organization and pay any

applicable fees, including the required fee to the department for processing. Only those Applications signed by Mark Clapper may be processed.



American Motorcyclist Association: The plate configuration will continue to consist of the two-character stacked designation of "AM," followed by five numbers starting with the number zero "0." Applicants must obtain form MV-904SP, "Application for Special Organization Registration Plate," from the organization and pay any

applicable fees, including the required fee to the department for processing. Only those Applications signed by Max Colchin may be processed.



Pennsylvania State Nurses Association: The plate configuration will continue to consist of the two-character stacked designation of "RN," followed by five numbers starting with the number zero "0." Applicants must obtain form MV-904SP, "Application for Special Organization Registration Plate," from the organization and

pay any applicable fees, including the required fee to the department for processing. Only those Applications signed by Stephanie Maurer may be processed.
