TOPICS IN THIS BULLETIN: New Campaign Inspection Stickers

New Campaign Inspection Stickers are available October 1, 2024

Between now and October 1, 2024, you should be careful not to order more inspection stickers than necessary to perform annual inspections through December 31, 2024, and semi-annual inspections through June 30, 2025. Please manage your sticker inventory to assure you have sufficient 2024-2025 inventory to last through December 2024 or until you receive your 2025-2026 stickers.

2025-2026 stickers may be used simultaneously with the 2024-2025 stickers. 2024-2025 stickers may be used for inspections on vehicles with expiry dates up to December 2024. 2025-2026 stickers are needed by November 1st for vehicles with a January 2025 expiry. Once you begin to use the new 2025-2026 stickers, a separate MV-431 or MV-480 must be started.

Please plan your inventory to allow up to 14 business days for delivery of your inspection sticker orders.

Please be aware that if your payment is made with a check returned for insufficient funds, your inspection privileges are subject to suspension in accordance with the schedule of penalties found in Section 175.51 of the Vehicle Equipment and Inspection Regulations.

ONLINE INSPECTION STICKER ORDERS

Online ordering of **2025-2026 safety or emissions inspection stickers begins October 1, 2024.**

Please do not attempt to place online orders for 2025-2026 safety or emissions inspection stickers prior to October 1, 2024. All orders processed prior to October 1, 2024, will receive 2024-2025 safety and emissions inspection stickers.

ORDERING INSPECTION STICKERS BY MAIL

For stations that wish to continue ordering through the mail, you may place your mail-in orders now for 2025-2026 safety or emissions inspection stickers. **If you wish to order 2025-2026 safety or emissions inspection stickers, please write 2025-2026 in large numbers across the top left of your MV-436A Inspection Sticker and Insert Order Form.** Unless you indicate **2025-2026** at the top left of the form, your order will be processed for 2024-2025 stickers. MV-436A forms marked 2025-2026 will not be processed before October 1, 2024.

REMINDERS:

PLEASE NOTE THAT WHEN ORDERING STICKERS, THEY ARE ORDERED BY SHEETS, NOT BY INDIVIDUAL STICKERS. EACH SHEET CONTAINS 10 STICKERS. FOR EXAMPLE, 4 SHEETS OF EMISSION STICKERS EQUALS 40 STICKERS. YOUR ORDER MAY BE REJECTED FOR EXCESSIVE QUANTITIES. PLEASE REVIEW YOUR ORDER BEFORE SUBMITTING TO ENSURE THE ORDER IS CORRECT.

2024-2025 CAMPAIGN STICKERS IN THE AI, IM AND AO SERIES, CANNOT BE USED FOR ANY REASON AFTER DECEMBER 31, 2024.

2024-2025 SI STICKERS MAY BE USED UNTIL JUNE 30, 2025.

2025-2026 STICKERS MUST BE FOR AI, IM AND AO SERIES STARTING JANUARY 1, 2025.

ALL STICKERS PURCHASED ON OR AFTER OCTOBER 1, 2024 WILL BE NEW CAMPAIGN STICKERS (2025-2026).

2024-2025 CAMPAIGN STICKERS WILL NO LONGER BE AVAILABLE FOR PURCHASE ON OR AFTER OCTOBER 1, 2024.

Instructions for Ordering Stickers Online for the First Time

If you wish to order safety or emissions inspection stickers online, but have not yet registered to do so, please see the following instructions. The vehicle inspection system allows for voluntary participation by stations to order stickers and inserts online and pay by using a credit or debit card. Access process instructions are below.

- The station owner will need to log into www.inspections.penndot.pa.gov to begin the registration process.
- The first screen that will appear is a **Sign-in Page** with an option to register. Select **REGISTER**.
- The next page will ask, "What Type of User Are You?" Select **BUSINESS PARTNER**.
- The **Business Partner Registration: Organization Identification** page will appear. As you are not currently registered on the on-line inspection system, you are required to register the station.
- As a new user, you will need to provide your organization's information to get started. Follow the prompts to enter your organization's name (Station Name), Federal Employer Identification Number (FEIN), the City and Zip Code of where your station is located. Select the **NEXT** button and continue to answer the appropriate questions in the **User Profile Information** and **Access Selection**. Under the *Organization Role Selection*, you can select yourself or you can choose to delegate access to another person. Your justification is to "access the Inspections Application". Once completed, select **FINISH**. Your request will officially be submitted.

Once approved, you will receive an email notification acknowledging your participation and will be provided a temporary password, valid for only 24 hours. Check your email daily for your notification, which is sent Monday through Friday during normal office hours. You will use the login ID and temporary password for your initial access.
