EDS Marc Ferraro and Chairman Taylor presented the PA Achievement Award to Mrs. Susan Meighen DMVA-PIRO (Outreach and Reintegration), and Ms. Kathy Knaub DMVA-PIRO for their outstanding and dedicated work for PA Veterans.

#### **Chairman's Opening Remarks**

#### **Chairman Nicholas Taylor**

Chairman Taylor opened by congratulating Mrs. Meighen and Ms. Knaub for receiving their awards and their outstanding work for PA Veterans. And welcoming new commander of the IAWV Mr. Stanley Majocka.

Chairman Taylor advised the members that beginning with the April 2023 meeting the SVC meeting will be streamed live utilizing MS Teams, invitations to MS Teams will be sent out along with the option to dial into the meeting. Instructions on how to secure Teams and how Teams works. Chairman Taylor also directed the members to the informational card at their seats; he advised them to use it as a resource for veterans' registry, and VetConnect resources on the webpage. He also requested members to share the information with their organizations and requested they use the resources as well.

Chairman Taylor requested the DMVA develop a QR Code for easy access to the DMVA website (it was noted that is in process). Chairman Taylor advised the members that the committees are established, the chairs of the committees have received the direction for their committees, and the members assigned. The Women Veterans' committee is still in process Chairman is working with MAL Kaye and DAG-VA, and the Transportation

committee will need to have a DAV member added. All SVC members will receive copies of the appointment orders of committees and assigned members.

### **TAG's Opening Remarks**

**EDS Marc Ferraro** 

EDS Ferraro congratulated the awardees, Mrs. Meighen, and Ms. Knaub. He informed the members that TAG was in Europe attending a conference. He then briefed the members that TAG will continue in his position, and the current leadership team will remain the same. He also informed members that Ms. Elizabeth Pettis will be leaving to take a position with the Office of Chief Counsel in Harrisburg, and Mr. Jeffrey Wallitsch will be the temporary chief counsel at FIG.

EDS Ferraro informed members that TAG had participated with Military Family Day and with Veterans involved in agriculture at the Farm Show in January. EDS briefed members that currently PANG has 800 troops deployed through the theaters of operation, including along the southwest border of U.S.

EDS reported that the PA Senate had stood up their VAEP committee and Senator Mastriano is Chairperson and Senator Muth is minority Co-Chairperson. The PA House is still forming committees. He said the Governor will release his budge on March 8, 2023, and DMVA has not seen the budget yet.

EDS told the members that the Delaware Valley Veteran Home celebrated their 20<sup>th</sup> year anniversary which included the employees, and particularly the employee who had been there since its opening. He noted the great job BVH Executive Director Mr. Davis and Director Ms. Raymond in bring it all about.

**Deputy Adjutant General-VA Remarks** 

DAG-VA gave a shout out to the Northeast PIRO team for their outstanding job for holding a Mind Over Matters meeting which was directed at suicide prevention and substance abuse treatment. DAG-VA said over a 100 people attended. She noted that northeastern PA has one of the highest ratings for suicide/substance abuse problem. Several Veterans shared their personal stories, and how they overcame their problems with the help of The American Legion. DAG-VA informed the members how yoga, art therapy and music therapy had been instrumental in helping veterans struggling with suicide and substance abuse.

DAG-VA noted that GAC-VS had a great meeting and noted Governor Shapiro's Deputy Chief of Staff for Public Safety Mr. Mike Pipe attended the meeting, and she was looking forward to working with him.

DAG-VA informed the members that she and DMVA staff will be meeting with their counterparts from other states at the NASDVA conferences. She noted this gives all advocates throughout the U.S. to push together on behalf of veterans.

She then gave a shout out to PIRO Director Mr. Mutschler and his team for an outstanding job they did at the Farm Show.

### **DMVA PPL**

Mr. Woody informed the members that the legislature had not official met, and the PA House hadn't formed any committees to date. He said it appeared the emerging issue from the Office of the Governor was homelessness. The Governor's Office will be working with the DMVA on homelessness.

Mr. Woody said he would defer to Mr. Nate Silcox the Director of the PA Senate VAEP Committee for an update on exclusion of veteran's compensation as income in calculating for RETX. Mr. Silcox said Senate Bill 126 contains the language for the exclusion, and the bill is moving forward which also contains the exclusion with all state programs.

Mr. Woody addressed the committee about some counties action on their own have removed some of the state requirements to qualify for the RETX program-such as, war time service. He noted legislators are receiving inquires.

### **DMVA Bureau of Veterans Homes**

Mr. Travis Davis

Executive Director Mr. Davis introduced Commandant Mr. Sam Dunkle and Deputy Commandant Ms. Christina Dambeck to the SVC members. He informed them that Commander Dunkle will do a presentation on the progress of the new construction taking place at Hollidaysburg Veterans Home. He noted the tremendous leadership both are doing at Hollidaysburg.

Mr. Davis then requested Director Ms. Barbara Raymond DMVA-BVH to provide the members with a COVID update.

• Ms. Raymond said that BVH had several days of no reported COVD. She unfortunately said a visitor to Hollidaysburg had reported after the visit that they tested positive for COVID, outbreak testing was done, and three individuals tested positive. They are all fine. She said the bivalent vaccine has reduced the severity of the COVID symptoms traumatically.

Hollidaysburg Veterans Home Commandant Sam Dunkle provided an update on the new construction plan. Commandant Dunkle briefed the members utilizing slides [slides and audio are attached to the April 14, 2023, read ahead for a more comprehensive review of his presentation which can be found on the DMVA-SVC webpagehttps://www.dmva.pa.gov/Veterans/Commissionsandcouncils/Pages/StateVeteransCommissionsandcounci

- Hollidaysburg Veterans Home (HVH) was originally constructed in 1850 and was a state hospital treating mentally challenged individuals. HVH became a veteran's home in 1977 with only 5 residents. HVH now has 474 beds devoted to veterans with 560 employees. 350 of those employees are either RNs, LPNs, or nurse's aides.
- HVH will begin the construction on the new building in May 2023. HVH move to a 200-bed skilled nursing facility. The building will have the 200 beds in 8 neighborhoods (formally referred to as units) on two floors. The first floor will contain a 160-person auditorium that will be used for functions, and dietary. Currently dietary is in a separate building and prepared food must be trucked to other buildings.
- To help facilitate the new constructions HVH has sold 100 acres of its 300 acres.
- HVH had been listed as the 14<sup>th</sup> best long-term care facility our of 700 long-term care facilities in PA.
- The location of the new HVH construction will go where a previous structure was torn down on the campus.
- Commandant Dunkle will be requesting once the new HVH building is completed in two years that the building be named after SFC Daniel R. Lightner. SFC Lightner 2<sup>nd</sup> Brigade Combat Team, 28<sup>th</sup> Infantry Division Pennsylvania National Guard. SFC Lightner was killed by an IED in Iraq in 2005. SFC Lightner is

a native of Hollidaysburg and is a hometown hero, he was 28 years old. He was also a PA State Police Officer. His career epitomized selfless service to our Commonwealth and our Country.

### Questions/Discussions

Mr. Rich Hudzinski-VVA asked why BVH was going to a 200-bed skilled nursing at HVH. Commandant Dunkle said demographics and recent census were the driving forces. The number of veterans throughout PA has gone from 1 million to around 700,000 in the last two decades.

Mr. Leonard Johnson-DAV complimented BVH on the outstanding job it is doing, and how well the Delaware Valley Veterans Center is operating. He said as a member of DAV they hold meetings and functions at the DVVC, and the reception is tremendous.

Chairman Taylor asked Executive Director Travis Davis how many 5-star homes BVH currently has. Mr. Davis informed members that BVH has three 5-star homes, one 4-star and one 3-star.

**DMVA PIRO** 

Mr. Joel Mutschler

Mr. Joel Mutschler briefed the members on DMVA-PIRO activities and functions.

- Mr. Mutschler updated the members on the roll-out of the new improved VETConnect interactive platform. It was a soft launch and PIRO is in the process of training staff and partners on the functional uses. He noted Outreach and Reintegration supervisor Mr. Cory Bender's instrumental and professional assistance in making the new VETConnect platform a success.
- Mr. Mutschler highlighted the relationship with GAC-VS by informing the members about how the veterans at SCI Muncy will be hosting a 'seed drive' during the month of February to plant new flowers, herbs, and vegetables in their VSU Victor Garden. In 2022 the garden produced over 2,300 pounds of produce which was donated to the Central Food Bank in Williamsport, and was used in the institution's salad bar, and the restaurant trades vocational class. And the collaboration between the DMVA, DOC and Department of Agriculture to stand-up greenhouses.
- Mr. Mutschler informed the members that all town halls will be held in-person this year, and the PACT Act will be stressed.
- Mr. Mutschler noted he was very proud of the Outreach staff; they supported 112 events and 2,565 veteran interactions this fiscal year.
- Mr. Mutschler concluded with a compliment of the relationship between SVC members and DMVA and noted SVC member Mr. James 'Woody' Hogan-TAL in particular.

VISN-4

Mr. Tim Liezert

Mr. Liezert reviewed the VISN-4 talking points that were presented in the February 3, 2023, read ahead. There were no add-ons to the talking points.

Questions/Discussion

Mr. Leonard Johnson asked the following question: We spoke earlier, and I mentioned the presumptive diseases from Vietnam, Gulf War, 9/11. And on 9/11, it has melanoma as a presumptive. Vietnam veterans are also suffering from that disease. It's been deadly to us. If you can investigate that for us, why that's not on there? Thank you.

Mr. Liezert, VISN-4: Thank you. I'll take that back and try to find out more.

VISN-4 provided the following answer: PACT Act allows VA to improve the decision-making process for determining what medical conditions will be considered for presumptive status. This will allow us to make more timely decisions regarding disabilities.

If a Veteran has a cancer or illness that's not on our list of presumptive conditions, but he/she believes it was caused by Agent Orange exposure, the Veteran can still file a claim for VA disability benefits. Veterans are encouraged to file a claim for any condition that they believe is linked to serving in the military, whether from an injury or illness that was incurred in service or a disability that didn't appear until after service. If the illness was not diagnosed in service, a medical link between the disability and conditions of service is also needed.

### What evidence will I need to submit with my claim?

### You'll need to submit these records:

- A medical record that shows you have an Agent Orange-related health condition, and
- Military records to show how you were exposed to Agent Orange during your service

# If your condition isn't on the list of presumptive conditions, you'll also need to provide at least one of these types of evidence:

- Evidence that shows the problem started during—or got worse because of—your military service, or
- Scientific or medical evidence stating that the condition you have is caused by Agent Orange. Scientific proof may include an article from a medical journal or a published research study.

Mr. Brooker brief on the committee's progress with the Bylaws.
regarding the proposed SVC Bylaws and Operating Procedures and Policies or OPP. Together, the Bylaws and OPP provide commissioners the necessary tools and requisite guidance to effectively perform their duties. The Bylaws are a more general and overarching document. The OPP complements the Statute and Bylaws, providing nuts-and-bolts detail. It is envisioned as dynamic document that can evolve to meet future needs of the commission. Regarding the Bylaws, the Committee received input and incorporated suggestions from DMVA's General Counsel. To date we have not received input from the Commission. It is the Committee's recommendation that our discussion today focus on any final questions or comments on the Bylaws. The OPP is a new document that establishes a set of operating procedures and policies to codify and guide our work as commissioners. The OPP provides thorough, but not exhaustive, guidance concerning roles and responsibilities, procedures for commission and committee meetings, reporting, and general administrative matters regarding the commission. The GC's intent was to produce a document predicated on each commissioner taking an active and participatory role in our work. It is only through this commitment to action and rigorous debate that the commission can truly meet the intent of the statute, and work in concert the Department to best serve PA veterans and their families.
Questions/Discussion
Mr. David Brady-MCL requested that committee review Bylaws section 4.6 regarding votes and proxy votes and executive secretary's role Committee Chair Mr. Brooker said he would take that under advisement.
Mr. Charles Jackson-MAL requested that all members get a copy of the final draft before the next meeting. Committee Chair Mr. Brooker said members will get a final draft before the next meeting.
Acting Chief Counsel-OCC Mr. Jeffrey Wallitsch informed the members that OCC has reviewed the Bylaws and requested a change. He said the legal definition of commissioners has specific meaning which could complicate

the document, and suggested the committee change from State Veteran Commissioners to State Veteran Commission Members. It said it would eliminate confusion.

Committee Chair Mr. Brooker requested that A/Chief Counsel Mr. Wallitsch provide his legal opinion in writing to the committee for advisement. Mr. Wallitsch stated he would provide the citations, and it would be sent by Wednesday February 8, 2023.

An overall discussion then occurred along the members and different approaches to the commissioners/commission members were mentioned. Chairman Taylor asked for a show of hands of members who would like to keep the wording as State Veteran Commissioners. Majority agreed with keeping it. Chairman Taylor then requested A/Chief Counsel Mr. Wallitsch to provide "chapter and verse" as to why the committee needs to change that. Mr. Wallitsch said he would.

Committee Chair Mr. Brooker closed the discussion by informing the members that the Bylaws are imperative to the successful operation of the SVC. He stated in the Bylaws it requires the SVC Chairman to act as a collaborator and not a commander making decision without the approval of the body. He then suggested that a separate mailbox be added to the SVC webpage which would allow veterans to speak directly to the SVC. Committee Chair Mr. Brooker said in the OPP committee did define commissioners and appointees by Governor.

Chairman Taylor told the members to be prepared to vote on the Bylaws at the April 14, 2023, meeting.

NW PA Counties Healthcare partners, community organizations, and Veterans residing in the 15 counties in Northwestern Pennsylvania: Erie, Warren, McKean, Crawford, Forest, Elk, Clearfield, Jefferson, Armstrong, Clarion, Butler, Venango, Mercer, Lawrence, and Beaver, are eligible to participate. The program aims to reduce Veteran suicide attempts, injuries, and deaths by 10% (on average) over five years. By improving access to treatment and support services, we will increase awareness of Veteran suicide risk through suicide prevention community activities and training opportunities.

### Improvements to the Access to Care website

Average wait times for all VHA medical centers and clinics are now calculated to include additional steps in the appointment process that had not been captured in the past.

- For **<u>new patient</u>** appointments, average wait time is calculated from the earliest time a request for care is consistently recorded in the scheduling system to the date the appointment is completed or the date it is scheduled to occur if not yet completed.
- For **established patient** appointments, average wait times are measured from the date agreed upon between a Veteran and provider for future care and ends on the date care is received, or the date that care is scheduled to occur if it has not yet occurred.

The upgraded calculation makes the website more reflective of the complete process of requesting and receiving care. Averages are representative of general performance and may not represent individual experience. Average wait times are never used to determine eligibility for community care.

Margaret Wilson, Associate Director for Patient Care Services at Lebanon is currently serving as the Medical Center Director during the recruitment process. Ms. Wilson has been the Associate Director for Patient Care Services at Lebanon since June 2010.

Jennifer Harkins began serving as the acting executive director for Coatesville VA Medical Center effective Sunday, January 29. She has been the associate director of finance and operations at Coatesville VA since May 2017.

Patricia O'Kane, Deputy Director, Philadelphia VAMC has been selected as the executive director of the New Jersey Healthcare System.

Dr. Jaconda Lightburn, Associate Director from Lebanon VAMC, will serve as Deputy Director in Philadelphia while we recruit to fill the position.

Michelle Goetz has been selected as the Assistant Director at the Coatesville VAMC and Eastern Market Manager. Michelle joined the Coatesville VA in 2017 and most recently served as the Chief of HAS.

Kathryn Barley, CBOC Manger at the Lebanon VA was detailed as the Acting Associate Director at Lebanon effective February 20.

Nick Haller, VISN 4 Rehabilitation and Extended Care Clinical Lead is currently detailed to the position of Associate Director, Patient Care Services, Erie VA Medical Center.

Dr. Stephanie Coyne, Physician Assistant and Western Market Lead Clinician at the VA Pittsburgh Healthcare System will serve as the Acting VA Pittsburgh Assistant Director and Western Market Lead effective February 22. Alan Petrazzi, Assistant Director resigned from Federal service.

### **New VA Mission Statement**

VA announced on March 16, 2023, an updated version of its 1959 mission statement. The new mission statement is: "To fulfill President Lincoln's promise to care for those who have served in our nation's military and for their families, caregivers, and survivors."

The new mission statement is inclusive of all those who have served in our nation's military — including women Veterans — as well as Veteran families, caregivers, and survivors.

VA currently serves more than 600,000 women Veterans, the fastest growing cohort of Veterans. VA also serves more than 50,000 Veteran caregivers, more than 600,000 Veteran survivors, and millions of Veterans who did not serve in combat.

In crafting the new mission statement, VA surveyed roughly 30,000 Veterans over two years. Among Veterans surveyed, the new version of VA's mission statement was chosen over the current version by every age group; by men and by women; by LGBTQ+ Veterans; and by white, Black/African American, Hispanic/Latino, Asian and American Indian/Alaska Native Veterans.

VA is here to serve all Veterans, their families, caregivers and survivors — and now, our mission statement reflects exactly that.

## **Patient Experience Update**

Nationally, VA's trust score over the last 90 days was 90.4%. In VISN 4, our trust score over the last 90 days was 93.7% which is the highest VISN in the nation. The percentage of comments made over the last 90 days that were compliments in VISN 4 was 74.9%, also higher than any other VISN. The top compliment themes were quality of care, interactions with staff, cleanliness of facility, satisfaction with specialty care, and quality of care from students and resident staff.

## VA 2024 Budget Request

The Biden-Harris administration released the <u>president's budget for fiscal year 2024</u> on March 9, 2023. This budget proposes critical resources to help VA serve all Veterans, their families, caregivers, and survivors as well as they have served their country.

The total FY 2024 request for VA is \$325.1 billion, a \$16.6 billion, a 5.4% increase above the FY 2023 budget enacted level. This is the *largest budget proposal in U.S. history for Veterans,* their families, caregivers, and survivors.

With these historic investments, VA can continue to deliver more care and more benefits to more Veterans than ever before in our nation's history.

## PACT Act Update

On March 3, VA publicly <u>released</u> the <u>PACT Act Performance Dashboard</u>, which highlights key performance metrics and data we are using to assess our success in implementing the PACT Act. VA is engaging members of Congress and Veterans Service Organizations to share this information widely and meet VA's commitment to transparency with all stakeholders—internal and external to VA. VA plans to share additional information as it becomes available, expanding and improving the Dashboard as PACT Act implementation continues. Data updates will be provided every two weeks on the <u>VA News Blog</u>.

## **Preventing Suicide among Veterans**

There is nothing more important to VA than preventing Veteran suicide — it's our top clinical priority.

VA announced on March 2, 2023, <u>the availability of the latest funding of \$52.5 million in</u> grants through VA's Staff Sergeant Parker Gordon Fox Suicide Prevention Grant <u>Program</u>.

The grants will provide funding for community-based organizations that provide or coordinate suicide prevention services for Veterans and their families – including conducting Veteran mental health screenings, providing case management and peer support services, delivering emergency clinical services, reaching out to Veterans at risk of suicide and more.

VA also recently announced the 10 winners of Mission Daybreak, a <u>\$20 million grand</u> challenge aimed at developing innovations to reduce Veteran suicides on Feb. 16, 2023.

During this challenge, VA received more than 1,300 innovation submissions from Veterans, Veteran Service Organizations, community-based organizations, health technology companies, startups, and universities – with solutions ranging from lethal

means safety concepts, to targeted virtual care programs, to other promising suicide prevention solutions that offer healing and recovery to Veterans.

### **Ending Homelessness among Veterans**

VA is committed to ending homelessness among Veterans because it is our nation's duty to ensure all Veterans have a place to call home.

The Department of Veterans Affairs <u>announced on March 15, 2023, its 2023 goals for</u> <u>preventing and ending Veteran homelessness</u>. Specifically, in 2023, VA will:

Place at least 38,000 Veterans experiencing homelessness into permanent housing.

Ensure that at least 95% of the Veterans housed in 2023 do not return to homelessness during the year. And of those who return to homelessness, VA will ensure that at least 90% are rehoused or on a path to rehousing by the end of 2023.

Engage with at least 28,000 unsheltered (PDF) Veterans to help them obtain housing and other wraparound services. This goal represents a more than 10% increase in the number of unsheltered Veterans reached during 2022.

As a part of ongoing efforts to prevent and end Veteran homelessness, <u>VA also</u> <u>announced availability of \$30 million in grant funding</u> for organizations to help formerly homeless Veterans maintain their independence and housing stability.

Significant progress has been made to prevent and end Veteran homelessness.

- Since 2010, the number of Veterans experiencing homelessness in the United States has declined by more than 55%.
- Since 2010, more than 1,000,000 Veterans and their family members have been permanently housed, rapidly rehoused, or prevented from falling into homelessness through VA's homeless assistance programs.
- Since 2015, 83 communities and 3 states (Virginia, Connecticut, and Delaware) have achieved an effective end to Veteran homelessness.

## **COVID-19: Updated Masking Guidance**

VA announced on March 3, 2023, it has <u>relaxed the masking requirement at VA medical</u> <u>facilities.</u> This update ensures the safety of Veterans while accommodating individual masking preferences and aligning with CDC guidelines.

This new policy will ensure the safety of Veterans and VA health care providers, while accommodating individual masking preferences,

Moving forward, VA will base its masking guidelines on the VHA COVID-19 Health Protection Levels (low, medium, and high) and healthcare facilities' conditions. When health protection levels are high, masking will remain required.

When health protection levels are low or medium, medical center leadership will conduct a facility risk assessment to determine if it is appropriate for masking to be optional in certain areas at their facility.

### **Connected Care Update**

Emergency Management Text Messages

The new VEText Emergency Management features allows VA staff to send text messages to communicate important and time-sensitive information with patients during emergencies. Messages can be one-way or two-way which will allow Veterans to respond. VEText messages and responses are combined with other data in a near realtime report for our Emergency Management staff to identify Veterans who have been contacted and those who need follow-up assistance. All Veterans are enrolled in this system unless they previously opted out of the VEText.

Blood Pressures by VA Video Connect (VVC)

VA patients are able to take their blood pressure from home with assistance of their care team through VA Video Connect (VVC). Veterans no longer need to travel to a VA facility to check their blood pressure. They can avoid travel and inclement weather! Plus, there is never a co-pay for a VVC visit. Veterans should talk to their care teams or providers about VVC Blood Pressure checks from home!

## **Veteran Homelessness in Pennsylvania**



Pennsylvania is home to over 700,000 veterans – the 4<sup>th</sup> largest veteran population in the nation.

According to the latest available Point-in-Time (PIT) Count from January of 2022, a total of 778 veterans were identified as homeless in the commonwealth: 746 were identified in emergency shelter and transitional housing locations, and 32 were identified as unsheltered (living on the street, in cars, under bridges, etc.). The COVID-19 Pandemic greatly impacted the ability to properly count unsheltered homeless individuals, so the actual number of homeless veterans may be a bit higher. The U.S. Department of Housing and Urban Development note Analysis of changes over time are generally limited to those between 2022 and 2020 or earlier. The PIT Count should be used as a tool regarding homelessness and should not be relied upon as the sole indicator of veteran homelessness.

The DMVA receives no funding to combat veteran homelessness, however, through the Office of Veterans Affairs (OVA) provides grants through the Veterans Trust Fund (VTF) to organizations who address housing insecurity and underlying issues. The OVA also administer the Veterans Temporary Assistance program (VTA) and the Military Family Relief Assistance Program (MFRAP), which both may assist veterans with emergent housing-related issues in addition to referrals to other governmental and community resources.

The DMVA also has two programs that allow for collaboration with multiple federal entities, sister agencies, and community partners regarding homelessness in Pennsylvania. PA VETConnect is a community-based outreach program to connect veterans and families who need assistance with resources. The Governor's Advisory Council on Veterans Services (GAC-VS) is the commonwealth's first interagency collaborative approach to veteran's services. Through these successful programs, DMVA has increased awareness and engagement with current challenges and successes related to the veteran homelessness sector.

Continuums of Care (CoCs) are homeless assistance planning networks that exist at the city, county, and state levels, and coordinate efforts to identify needs, resources, and gaps in service for local homeless populations. Pennsylvania is divided into 16 CoCs, which seek to address all aspects of homelessness and the needs of those experiencing homelessness. The Eastern and Western PA CoCs are together known as the Balance of State and comprise 53 counties. The remaining 14 counties are each their own Entitlement CoC. Eight CoCs in PA have effectively ended veteran homelessness according to the criteria set forth by the United States Interagency Council on Homelessness (USICH), meaning that veteran homelessness in these communities is rare, brief, and non-recurring.

Veterans Integrated Service Network (VISN) 4, which covers 63 of PA's 67 counties, works directly with all federal Department of Veterans Affairs (VA) Medical Center Homeless Veteran Care Teams to assist VAeligible veterans. Luckily, veterans who may not qualify for assistance through the VA may still be able to obtain help with homeless issues. Supportive Services for Veteran Families (SSVF), and the U.S. Department of Housing and Urban Development-Veterans Affairs Supportive Housing (HUD-VASH) are two flagship VA programs utilized to permanently house veterans. The HUD-VASH program combines Housing Choice Voucher (HCV) rental assistance for homeless veterans with case management and clinical services provided by the VA. The VA also announced that 38,000 veterans will be permanently housed through the VA Permanent Housing Placement National Challenge during calendar year 2022. Each VA location will receive data on the number of veterans they are tasked with housing.

In federal FY 2022, twelve non-profits received funding in the amount of \$16,189,386 from the federal VA in the form of SSVF grants. These grants assisted 2,578 veteran households, or over 3,800 individuals. Of these households, 1,402 received Rapid Rehousing enrollments, meaning household members were literally homeless, and 1,176 received Homeless Prevention enrollments, meaning these households were imminently at risk for

becoming homeless, if not for the intervention from the SSVF provider. Some SSVF grantees also operate the Homeless Veteran Reintegration Program (HVRP), administered by the Department of Labor. This program aims to reintegrate homeless veterans back into meaningful employment and as of July 1, 2021, seven HVRP PA grants exist.

Under the GAC-VS, two workgroups have formed related to homelessness. The Hard-to-Place workgroup focuses on establishing networks of support to reduce the occurrence of veteran homelessness following reentry from incarceration and assisting those who are considered hard-to-place due to a criminal record. The Affordable Veteran Housing workgroup is fairly new, but focuses discussion on the lack of available units, and the need to engage landlords so they choose to rent to veterans. Landlords can obtain higher rent amounts with non-HUD-VASH tenants, so landlord engagement is crucial for developing a network of support.

Many challenges exist regarding veteran homelessness, which often results from a combination of drug or alcohol use and co-occurring behavioral health issues that can include Post Traumatic Stress, Traumatic Brain Injury, and poly-Trauma. These conditions make it difficult to find and maintain gainful employment to pay for housing. By percentage, women veterans are at a higher risk of homelessness compared to their male counterparts and face additional challenges when they must care for children. Other challenges exist when individuals facing homelessness have larger families to care for, when they have pets, or when they are members of the National Guard or Reserve Components who were never federally activated, meaning that they will not qualify for SSVF assistance.

Work must continue to uncover more resources for National Guard or Reservists who were not federally activated under Title 10, and therefor do not qualify for SSVF or other veteran homeless programs. Housing instability affecting the older veteran population, women veterans or veterans caring for children, and veterans who have a companion animal, need to be considered when developing plans for emergency shelter beds, transitional housing, and regular affordable units.

Homeless veterans who are couch-surfing are considered "housed" under the current homelessness definitions. However, these situations can change overnight, and individuals may find they suddenly do not have a guaranteed shelter. Also, individuals leaving institutions (such as hospitals or jails) where they have resided for 90 days or more must exit and actually spend one night homeless before they qualify for the more robust homeless services. Broadening or relaxing the definition of homelessness and the criteria that assists these individuals will allow for more wrap-around supports and cause less trauma to the situation.

All stakeholders should collaborate to share data, identify gaps, and create strategies to address unmet supportive service needs for veterans. Increasing access to case management to support triage services for homeless veterans will allow for quicker response once these situations are identified. We ask for support to help expand the awareness of existing programs for homeless veterans, and also assistance in researching and providing additional funding for veteran's homeless programs. No service member or veteran should be left behind.

## Veteran Transportation in Pennsylvania



Pennsylvania is home to over 700,000 veterans – the 4<sup>th</sup> largest veteran population in the nation. Access to appropriate medical and mental health care, the ability to access gainful employment, and the ability for veterans to remain active and involved in their communities play a large role in the overall health and welfare of our Nation's heroes. Transportation access is key to keeping veterans safe, healthy, and involved.

Veterans may struggle to find reliable and affordable transportation for a variety of reasons, including but not limited to age, disability or illness that make personal driving or use of fixed-route or shared-ride transportation programs difficult or impossible; lack of financial means to purchase, maintain or repair a personal vehicle; lack of family or informal support to assist with rides; residing in a rural area with great driving distances between services and a lack of nearby providers, which often necessitates travel into other counties; limitations of current shared-ride systems that result in veterans waiting long periods of time before or after appointments; low-income veterans being eligible for the Medical Assistance Transportation Program (MATP) but not being able to use this transportation program to get to VA appointments; Compensation and Pension exams being located out of county and sometimes several hours away from a veteran's residence; and transit authorities being bound by county borders or coverage territories.

According to a 2020 research article on barriers faced by post-9/11 veterans<sup>1</sup>:

- 16% of programs provided transportation with only 2.7% of veterans reported using or benefitting from programs that provided transportation.
- Veterans with probable PTSD symptoms were two-times more likely to utilize programs that offered transportation compared to veterans without PTSD symptoms.
- Veterans with physical health conditions were not significantly more likely to utilize programs that provide transportation.
- Transportation appears to be a key access assistance component particularly for veterans with serious injuries or disabilities that prevent them from getting around by themselves or for those who do not have the financial means to purchase and maintain their own transportation.

The PA Department of Military and Veterans Affairs (DMVA) receives no funding to combat veteran transportation challenges; however, through the Office of Veterans Affairs (OVA), it provides grants through the Veterans Trust Fund (VTF) to organizations that seek to address transportation challenges and underlying issues. DMVA also administers the Veterans Temporary Assistance program (VTA) and the Military Family Relief Assistance Program (MFRAP), which both may assist veterans with funds to address emergent transportation-related issues in addition to referrals to other governmental and community resources. Additionally, PA VETConnect is identifying transportation programs at the local and regional levels and is building relationships with organizations and programs at the community level that address transportation challenges for veterans. Furthermore, PA VETConnect staff are establishing or participating in veteran-centric coalitions across the Commonwealth. The State Veterans Commission has also recently established a committee focused on addressing the transportation issues facing our community. These spaces bring together stakeholders who can collaborate to better understand the transportation challenges veterans face and brainstorm potential solutions with the resources that currently exist.

For example, DMVA VSOs located in western PA are working with the VA's regional director to address veteran transportation issues in that area, identifying barriers and brainstorming solutions. Personnel have canvased the 27 counties in the western district to see what transportation options are available at the county and local levels. In addition to the VA, DMVA is seeking input from organizations including the Veterans Leadership Project and

Advocate Health Advisors, hosting roundtable discussions with a goal of creating an actionable plan moving forward to minimize, and eventually eliminate, this transportation issue. With the success of this initiative, a more widespread program is possible to assist veterans across the Commonwealth. No veteran should miss a compensation and pension exam due to a lack of transportation.

Currently, there are several programs that exist from the VA and from Pennsylvania that may help to reduce transportation barriers for veterans who qualify for such programs. These are not one-size-fits-all solutions, however, and each has their limitations and drawbacks.

The VA Health Administration (VHA) offers three transportation programs that may benefit Pennsylvania's veterans if they meet eligibility criteria.

- <u>VA Travel Pay Reimbursement</u> pays back eligible veterans and caregivers for mileage and other travel expenses to and from approved health care appointments. Each medical center has a beneficiary travel point of contact.<sup>2</sup>
- <u>Veterans Transportation Service (VTS)</u> provides free, convenient, safe and reliable transportation to qualifying veterans who require assistance traveling to and from VA healthcare facilities and authorized non-VA healthcare appointments when they do not have access to transportation options of their own due to financial, medical or other reasons. The VTS partners with service providers in local communities such as Veteran Service Organizations, local and national non-profits, and federal, state, and local transportation services, to serve veterans' transportation needs.<sup>3</sup> One example of this partnership is the Disabled American Veterans (DAV) Medical Transportation Program which operates a fleet of vehicles that provide free rides to VA medical facilities for injured and ill veterans. The provision of this service depends entirely on a pool of volunteers available in any given area; therefore, not all counties have equal access to the DAV Medical Transportation program. In fact, it is non-operational in some areas.<sup>4</sup>
- Finally, VA now offers a rideshare program for veterans enrolled in VA homeless or veteran justice outreach programs. Veterans can utilize rideshare programming such as Uber and Lyft where it is available to get to medical and mental health appointments, job interviews, substance use treatment, and court appearances. Due to the rural nature of many of Pennsylvania's counties, however, rideshare services are not readily available everywhere.

Pennsylvania offers transportation programs that may assist eligible veterans. Find My Ride (FMR) provides education on these services and explains programs specific to seniors age 65+, persons with disabilities, and low-income individuals. Since many veterans fall into one or more of these categories, these services may be of assistance in some circumstances. Veterans can apply online at <u>FMR Apply</u><sup>5</sup> or they can contact their <u>local</u> transportation provider<sup>6</sup>. Additionally, those interested in learning what services are available by county can use the <u>PennDOT Public Transportation Services and Program Map</u><sup>7</sup>. More information about the following programs can be found on the <u>FMR education site<sup>8</sup></u>.

- Senior Shared Ride Program enables those 65+ to use shared ride services and pay only a small portion of the regular shared ride fare or perhaps nothing at all. The shared ride service picks up passengers at home and takes them directly to the destination (typically curb-to-curb service). The downside to this service is that it is often unable to travel outside of specified coverage zones and those riding often have long wait-times before and after their appointments.
- The Free Transit Program for Seniors provides a pass to seniors 65+ to ride for free on all public transportation bus services in PA. This is fixed-route service following repetitive, fixed schedules along consistent routes, picking passengers up from and delivering them to specific locations. If the location of a veteran's destination is not on or near a fixed route, this service will be of no value.
- The Persons with Disabilities (PwD) Program pays for those aged 18 to 64 to be picked up at their residence and travel to locations within their county, or in some cases, to locations outside of their county. Riders receive discounts on shared-ride services, which in most cases results in free or significantly reduced fare. Proof of disability must be provided. Prior-day advanced registration is required.
- The MATP may consist of mileage reimbursement, public transportation bus passes, or pick up by a vehicle at home. The county of residence provides the type of transportation that is least expensive. More information on MATP and other programs for low-income individuals may be obtained from a local county assistance office. Please note that this program cannot help to transport a veteran to a VA appointment since VA does not bill medical assistance. This program would only be beneficial to veterans who were receiving healthcare from a provider that will bill medical assistance.


Some community action agencies and non-profit organizations may offer grants or funds to help individuals with the cost of vehicle repairs or to purchase a used vehicle. These programs are not widely available however and are often restricted to one county or a specific coverage area. They also tend to have strict eligibility criteria. Some transit providers have started to offer rides for veterans going to VA medical appointments through donated funds meant for this specific cause. For example, RabbitTransit can provide York County veterans with rides to VA medical appointments through a pot of money donated and earmarked for this purpose.

A better understanding of the steps and elements necessary to support such a program could help other counties replicate this model. Funds to support these types of programs are essential however to being able to make them more widely available and expand the number of veterans who can benefit from them.

- The Advisory Council for the Hollidaysburg Veterans Home unanimously voted on a motion to name the CLC after Sergeant First Class Daniel R. Lightner.
- SFC Lightner served as a Pennsylvania State Policeman graduating from the Academy as a member of its 115th class in April 2004.
- SFC Lightner was a member of the 2nd Brigade Combat Team, 28th Infantry Division, Pennsylvania Army National Guard. SFC Lightner was killed in Iraq by an improvised explosive device (IED) on October 27, 2005, supporting Operation "Iraqi Freedom." He was 28 years old.
- SFC Lightner is a native son of Hollidaysburg and "Hometown hero" whose career epitomized selfless service to our Commonwealth and our Country.
