Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. § 323, in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

Jaime S. Moss, notary ID number 1267204, of Philadelphia, Philadelphia County, is prohibited from reapplying for appointment and commission as a notary public for a period of four years, based on her failure to require personal appearance of an individual executing their signature on a record, to secure her stamping device, and to maintain a journal of notarial acts. Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. § 323, in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

Westmoreland County

Denise M. Villi, notary commission no. 1171926, of Greensburg, Westmoreland County, agreed to the suspension of her notary commission for three months, which shall be stayed in favor of probation; payment of a probation assessment of and \$150.00; payment of an administrative penalty of \$500.00; and completion of six hours of remedial education because she failed to record in her journal the type of notarial act she performed, the full address of the individuals for whom she performed notarial acts, and the dates of issuance and expiration of the identification credentials used to verify the identity of the individuals for whom she performed notarial acts; charged fees for the performance of notarial acts in excess of the fees set by the Department; and recorded the performance of multiple notarial acts within a single entry in her Journal. (07/11/2024).

Eileen Williams, notary commission no. 1232521, of Hunker, Westmoreland County, agreed to the suspension of her notary commission for three months, stayed in favor of probation; pay an administrative penalty of \$500.00; pay a probation assessment of \$150.00; and complete six hours of remedial education because she failed to maintain a journal of all notarial acts performed. (07/11/24).

York County

Melissa Blevins, notary commission no. 1293821, of York, York County, voluntarily surrendered her notary commission because Respondent failed to maintain a journal of notarial acts performed, failed to consistently and accurately record the time at which she performed a notarial act, the type of notarial acts she performed, a description of the record for each notarial act performed, the dates of issuance and expiration of identification credentials used to verify the identity of individuals for whom she performed a notarial act, and the fee she charged for the notarial acts she performed and made or attempted to make a certified copy of a birth certificate. Fred B. Shoemaker, notary ID number 1258487, of York, York County, is prohibited from reapplying for appointment and commission as a notary public for a period of four years, based on his failure to record all notarial acts in his journal; failure to consistently include type of notarial act, time of notarization, full name and address of the individuals for whom he performed notarial acts, the date of issuance and expiration of identification credentials and the fee he charged. Mr. Shoemaker also charged in excess of the maximum fees which a notary may charge for at least six different clients. Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. § 323, in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

Berks County

Melody Ortiz-Gonzalez, license no. RN684270 of Reading, Berks County, liecnse was suspended for three years with such suspension stayed in favor of no less than three years of probation retroactive to May 14, 2024, because Gonzalez, is unable to practice professional nursing with reasonable sill and safety by reason of mental or physical illness or condition or dependence upon alcohol, hallucinogenic or narcotic drugs which tend to impair judgment or coordination. Maria T. Kelly, LPN, License No. PN251041L, of Warrington, Bucks County, had her license indefinitely suspended retroactive to May 13, 2024, and was assessed costs of investigation because she violated a Board order. (7/15/24)

RN529885L of Slippery Rock, Butler County, was indefinitely suspended with such suspension stayed in favor of indefinite probation, because Ralston had a license suspended or revoked or has received other disciplinary action by the proper licensing authority in another state, territory, possession or country. (5/2/24)

Mariamma Philip Abraham, license no. RN223399L, of Philadelphia, Philadelphia County, had her license to practice professional nursing indefinitely suspended for 3 years, with the suspension immediately stayed in favor of probation, was ordered to complete 30 hours of remedial education, and levied a civil penalty in the amount of \$2,000, because Abraham violated section 14(a)(9) of the Professional Nursing Law, 63 P.S. § 224(a)(9), by being guilty of unprofessional conduct, including departing from quality standards of the profession, by failing to practice to the standard of nursing care in her treatment of Patient J.W. on or about July 30, 2021. Donna Mangini, license no. RN659573, of Philadelphia, Philadelphia County, was placed on probation for one year, because Mangini has been convicted, or has pleaded guilty, or entered a plea of nolo contendere, or has been found guilty by a judge or jury, of a felony or a crime of moral turpitude in the courts of this Commonwealth, the United States, or any other state, territory, or country, or has received probation without verdict, disposition in lieu of trial or an Accelerated Rehabilitative Disposition in the disposition of felony charges.
