As a result, Respondent is subject to disciplinary action under RULONA, 57 Pa.C.S. § 323, in that she lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

#### **Lancaster County**

William B. Stull, notary commission no. 1162557., of Lancaster, Lancaster County, was ordered to pay an administrative penalty of \$1,200; complete six hours of remedial education; and his notary commission placed on probation for 12 months because he stored his official notary stamping device in an unsecured place.
