## **PA Board of Accountancy**

#### **Allegheny County**

Clearview CPA Advisors LLC, license no. AF068735, and Feruza Matyakubova, license no. CA058967, of Sewickley, Allegheny County, were ordered to jointly and severally pay a civil penalty of \$3,500; and costs of investigation of \$562.87, because Clearview CPA Advisors LLC engaged in the unlicensed practice of public accounting in the Commonwealth and Matyakubova aided and abetted the unlicensed practice of the profession. #### **Lackawanna County**

Eugene Daniel Lucas, license no. CA017299L, of Scranton, Lackawanna County, was suspended for two years and ordered to pay a civil penalty of \$1,500 because Lucas pled guilty to Theft by Deception-False Impression. (7/23/25)

MD469310, of Honolulu, Hawaii was levied a civil penalty of five hundred dollars (\$500.00) and a public reprimand was placed on his disciplinary record with the Board, because Potthoff had a license or authorization to practice the profession suspended, revoked, refused or otherwise disciplined by the proper licensing authority of another state, territory, possession or country, or a branch of the Federal Government. ## **Secretary of the Commonwealth - Notaries Public**

#### **Berks County**

George Kotsopoulos, notary ID number 1088517 of Douglassville, Berks County, had his notary commission revoked and is prohibited from reapplying for appointment and commission as a notary public for a period of one year, based on findings that he did not provide any details, documents or explanation relating to the suspension of his law license for one year by order of the Supreme Court of Pennsylvania when submitting an application for reappointment. This is a violation of Section 315(a)(1) of the Revised Uniform Law on Notarial Acts (RULONA), 57 Pa.C.S. § 323(a)(2). As a result, Respondent is subject to disciplinary action under RULONA, 57 Pa.C.S. § 323, in that he lacks the honesty, integrity, competence, or reliability to hold the office of notary public. ## **Delaware County**

Shenequa Smith, notary commission no. 1297405, of Glenolden, Delaware County, was placed on probation for one year; ordered to pay a probation assessment of \$600; administrative penalty of \$600; and complete six hours of remedial education because Smith failed to record all required information for all notarial acts she performed in her journal. (07/14/25)

## **Lackawanna County**

Cory McCort, notary commission no. 1330871, of Scranton, Lackawanna County, was placed on probation for six months; ordered to pay a probation assessment of \$300; administrative penalty of \$600; and complete six hours of remedial education because McCort failed to maintain a journal of all notarial acts that he performed; and to promptly notify the Department that his journal was lost. #### **Northampton County**

Genesis Espinal-Rivera, notary ID number 1360247 of Bethlehem, Northampton County, is prohibited from reapplying for appointment and commission as a notary public for a period of four years, based on findings that she failed to use a notarial statement on a record to which she affixed her notarial seal and signature. As a result of this violation of Section 315(a)(1) of the Revised Uniform Law on Notarial Acts (RULONA), 57 Pa.C.S. § 323(a)(2), Respondent is subject to disciplinary action under 57 Pa.C.S. § 323, in that she lacks the honesty, integrity, competence, or reliability to hold the office of notary public. #### **Westmoreland County**

Shawn Burns, notary commission no. 1271847, of Greensburg, Westmoreland County, was suspended for 12 months with the entire period being stayed in favor of probation; and ordered to pay a probation assessment of \$600; an administrative penalty of \$750; and complete six hours of remedial education because Smith notarized a document without having the individual signing the document personally appear before him; and failed to record, all required information in his journal of notarial acts. Monica Blackwell, license nos. PN296965, of Pittsburgh, Allegheny County, was indefinitely and actively suspended until such time as the Board grants the reinstatement of her license to practice as a professional nurse and/or practical nurse, because Blackwell is addicted to alcohol or is addicted to hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination, so long as such dependence shall continue, or if he or she has become mentally incompetent. Robert Piazza, LPN, license No. PN259916L, of Levittown, Bucks County, was revoked, based on his conviction, including a felony, crime of moral turpitude and in violation of the Criminal History Record Information Act. (06/06/25)

Eileen M. Diaz, RN, license No. RN618947, of Allentown, Lehigh County, was suspended for no less than three years, stayed in favor of probation based on being unable to practice professional nursing with reasonable skill and safety to patients. (06/18/25)

Alexander Robert Lamay, license no. RN708736, last known of Philadelphia, Philadelphia County, was indefinitely suspended based on his criminal convictions related to the profession. (06/06/25)

#### **Somerset County**

Brittany Victoria Poplin, LPN, license No. PN306765, of Somerset, Somerset County, was revoked, based on her conviction of a felony and crime of moral turpitude directly related to the profession and her violation of the Criminal History Record Information Act. (06/06/25)

RN597621, last known of Columbus, Warren County, was indefinitely suspended until such time as she demonstrates that she can resume a competent practice of nursing with reasonable skill and safety. PN307905, of Washington, Washington County, received an indefinite and active suspension for no less than four years, retroactive to September 11, 2024; after serving one year of suspension, the suspension shall be stayed in favor of probation because Wozolek was convicted or pleaded guilty or entered a plea of *nolo contendere* or was found guilty by a judge or jury of a felony or a crime of moral turpitude in the courts of this Commonwealth, the United States, or any other state, territory or country, or received probation without verdict, disposition in lieu of trial or an Accelerated Rehabilitative Disposition in the disposition of felony charges, or has been dishonorably discharged or has been discharged under circumstances amounting to dishonorable discharge from the military forces of the United States or of any other country, is addicted to alcohol or hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination, and violated a lawful disciplinary Order of the Board. #### **Out of State**

David Kerzner, PA license no. RN735996, last known of Sandy Level, Virginia, was indefinitely suspended until such time as he demonstrates that he can resume a competent practice of nursing with reasonable skill license and until his license is restored to unrestricted status in Virginia based on disciplinary action being taken against his license by the proper licensing authority of another state. Robert Charles Long, III, PA license no. RN675681, of Painesville, Ohio, had his license indefinitely suspended because he is unable to practice nursing with reasonable skill and safety to patients. (06/06/25)
