The documents listed below are not the same as registering your business and may require additional steps.

EIN (Tax ID)

- Employer Identification Number, also called a Federal Tax ID, is a 9-digit number associated with your business and is issued by the IRS.
- **All businesses are required to register** with the federal government and obtain an EIN*. **Fines can be up to \$10,000.**
- An EIN is also required to hire employees, open a business bank account, file taxes, apply for business loans / lines of credit, and other business purposes.

Labor Law Posters

- State and Federal law mandates employment posters be displayed which inform employees of their rights under the NRA (National Labor Relations Act).
- **It is required by Federal & State Law** for these poster to be posted in a visible location of the workplace for businesses with at least one employee. **Fines can be upward of \$25,000** and lead to potential lawsuits.

Certificate of Status

- Certifies that your company is in existence & **authorized to transact business** in the state of Pennsylvania.
- This certificate may be required for loans, to renew business licenses, to open your business bank account, to register a Pennsylvania formed company as foreign entity in another state, and/or other business purposes.

E-Filing Instructions:

Your business may be at risk.
