16 FSMB Attorneys Workshop in Philadelphia, PA, started
17 on a high note with opening remarks from Ashley
18 Goshert, Esquire, Board Counsel, and herself for the
19 State Board of Osteopathic Medicine. She noted the
20 highlight of the workshop was the State of the States
21 session where boards shared updates and challenges.
22 She added much of the discussion related to the
23 Interstate Medical Licensure Compact (IMLC),
24 difficulties with the implementation of IMLC and
25 comparisons with other states.

1 Ms. Archer commented her favorite session was
2 regarding compounding, particularly the legal
3 regulatory complexities with compounded medications
4 and how Boards can address compounding effectively.
5 Ms. Archer concluded by thanking the Board for
6 sending her to the workshop.]

1 Report of Committee on Legislation/Policy Development
2 and Review

3 [Mark B. Woodland, M.S., M.D., FACOG, reported the
4 American Medical Association (AMA) is doing a deep
5 dive into telehealth utilization. He stated the top
6 five physician specialties utilizing more than 20
7 percent of the visits in telehealth are neurology,
8 endocrinology, gastroenterology, family general
9 medicine, and urology. He added the top five
10 physician specialties utilizing less than 20 percent
11 of visits include ophthalmology, dermatology,
12 emergency medicine, orthopedic surgery and
13 anesthesiology. He pointed out for emergency
14 medicine, the telehealth visits are follow-up visits.

15 Chair Yealy commented for emergency medicine,
16 physicians actually do telehealth, but it falls under
17 a different rubric, not under emergency care itself.
18 He added telehealth is a wonderful way to get care to
19 people when and how they need it.

20 Dr. Woodland reported the "Big Beautiful Bill"
21 will reshape healthcare in 2026. He stated there are
22 many things that will change as a result of the new
23 legislation. He noted the big fear for patients is
24 confusion that could delay care, worsen health
25 outcomes, and present financial hardship for

1 families. For physicians, he noted, the confusion
2 could relate to patients being uninsured or
3 underinsured, less stability for safety net
4 financing, and growing pressure on the already
5 strained practices.

6 Dr. Woodland added fiscal incentives that
7 expanded in Medicaid will end, having a ripple
8 effect. The cost for ACA marketplace enrollees will
9 increase until action is taken. In addition, medical
10 students will have fewer options to pay for student
11 loans, and some of the options will have caps. He
12 added this may determine who can go into medicine and
13 who cannot. Finally, related to the bill, he added
14 physicians can expect to see significant policy
15 changes starting in January 2026, which may affect
16 their practices, especially around fiscal concerns.

17 Dr. Woodland shared the Association of Medical
18 Colleges (AAMC) continues promoting funding for
19 health and scientific research. He added AAMC has
20 information on their website, www.aamc.org, regarding
21 access to programs to enhance workforce resilience
22 and support the training of future physicians and
23 researchers.

24 Dr. Woodland reported the new issue of the
25 *Journal on Medical Regulation* (JMR), published by

1 FSMB, highlights corporatization in health
2 professions; trends in case complexity and its
3 implications; and looking at telehealth. He added,
4 as the chair of the oversight committee for JMR, he
5 supports the journal.

6 Dr. Woodland mentioned discussions about the
7 assistant physician legislation; however, there is no
8 current legislation in Pennsylvania.

9 Dr. Woodland stated the annual FSMB meeting is in
10 Spring 2026. He thanked the Board for their
11 supporting his nomination to run for chair-elect. He
12 reported he has been going through the interview
13 process with the Nominating Committee over the past
14 month.

15 Mr. Dillon stated, at the prior meeting, the
16 Board decided to send two people to the FSMB meeting.
17 He offered to attend again, but it might be good for
18 the newer members to attend, if interested.

19 Chair Yealy stated making sure the Pennsylvania
20 board is engaged and fully represented at FSMB is
21 good for the Commonwealth. He stated the Board's
22 overall agenda is to find the people who are the most
23 interested and the most dedicated to support their
24 involvement.

25 Dr. Ripchinski voiced his support for Mr.

1 Dillon's attendance. He also was interested in
2 attending in the future, but unable to attend in the
3 spring due to a personal conflict.

4 Dr. Kutz echoed Dr. Ripchinski. He was
5 unavailable in the spring, but was interested in
6 future meetings.

7 Chair Yealy encouraged any Board Members
8 interested in attending to notify himself, Mr. Cassel
9 or Acting Commissioner Claggett. He added a
10 combination of people with experience and people who
11 want to gain experience would make the most sense.

12 Ms. Okereh shared January 23rd is National
13 Maternal Health Awareness Day. She stated the day
14 highlights maternal health issues and advocates for
15 better care for mothers and their families. She
16 added preventable maternal complications continues to
17 impact families across Pennsylvania, particularly
18 after discharge. She explained a need for ensuring
19 that every mother and baby in the Commonwealth have
20 access to high quality evidence-based care, strong
21 postpartum support and standardized safety
22 practices.]

2 Report of Department of Health

3 [Robert Bonacci, M.D., on behalf of Debra Bogan,
4 M.D., FAAP, Secretary Department of Health, reported
5 Pennsylvania is firmly in the midst of cold and flu
6 season. He shared graphics demonstrating where rates
7 are of influenza A, B and RSV compared to last year.
8 He noted there are rapidly rising rates of influenza.
9 He noted there is also an uptick in SV cases. He
10 reminded all practitioners of the importance of
11 making sure their patients are protected from
12 respiratory viruses by being protected through
13 vaccination and immunizations per guidance from
14 professional medical societies.

15 Dr. Bonacci stated the Advisory Committee on
16 Immunization Practices (ACIP) at the CDC met on
17 December 4 and 15, 2026. As a result of the
18 meetings, ACIP voted to change the recommendation
19 around the universal newborn dose for the hepatitis B
20 vaccination. He added the Commonwealth continues to
21 strongly recommend the guidelines set forth of the
22 American Academy of Pediatrics and other professional
23 medical societies, which uniformly continue to
24 recommend the universal birth dose for hepatitis B.
25 He noted since the original recommendation in 1991,

1 there has been a significant decrease in the
2 incidence of perinatal and acute hepatitis B cases in
3 infant populations.

4 Chair Yealy thanked DOH for continuing to provide
5 clarity on both the respiratory virus season and on
6 how to protect from a variety of threats. He noted
7 the Commonwealth has always taken advice from
8 multiple sources including primary science and expert
9 groups.]
