A real estate education provider shall be owned by a person(s) who possess good moral character or, if the owner is a corporation, have officers and directors who meet this requirement.

Each owner, officer, or partner must file a copy of this application with the Commission.

### **Application Checklist**

Attach the following documentation:

- A non-refundable \$75.00 check or money order made payable to the "Commonwealth of Pennsylvania."

All fees are non-refundable. A \$20.00 processing fee will be charged for any check returned unpaid by your bank, regardless of the reason.

**NOTE:** *This fee is not applicable if this application is being submitted with an initial real estate education provider application.*

- Detailed employment resume listing all experience owning, administering or teaching in a college or university or as a real estate education provider.
- Two signed and dated letters of reference attesting to the owner's integrity and, if applicable, previous administration experience. The letters must be original copies. Scanned, photocopied, or faxed letters are not acceptable.
- Criminal Background Check completed by the State Police where the applicant resides and dated within 90 days of the date this application is received in the Commission office.
  - If you reside in Pennsylvania, background checks may be obtained at: <https://epatch.state.pa.us>.
  - If you reside outside the state of Pennsylvania, you must obtain a background check from the State Police in that state.
  - The background check must contain the Applicant's **date of birth and social security number**.
  - The background check must either state "**No Record**" or "**Record Exists**." Background checks that reflect "**Pending**" "**Under Review**," or "**Under Request**" cannot be submitted. Questions regarding the status of a background check must be directed to the State Police.
  - If "**Record Exists**"—submit **originals** of the following for EACH felony or misdemeanor conviction:
    - The conviction summary information provided by the State Police
    - Certified copies of court documents;
    - Letter from Probation Officer, dated within 90 days, indicating current probationary status/completion date;
    - Police reports;
    - Employment History (resume);

- Detailed description (in applicant's words) of the circumstances surrounding the conviction, the basis for the conviction and the disposition of the conviction;
- A signed and dated reference letter from the employing broker, on the company letterhead, indicating that the broker is aware of all conviction(s) and is willing to hire the applicant;
- Two signed and dated character references from individuals who are not related to or residing with the applicant.
