

## Electronic Notarization and Remote Notarization Technology Providers

The following is a complete listing of organizations approved by the Pennsylvania Department of State to offer electronic notarization (e-notary) technology and remote notarization (RON) technology to Pennsylvania notaries public. Notaries must notify the Department that the notary is performing notarial acts with respect to electronic records/ performing notarial acts for a remotely located individual using communication technology prior to performing such acts and identify the technology the notary intends to use. Vendors are listed in the order that their solutions were approved by the Department. There is an alphabetical list on the last page. Note: Many of these companies also offer an electronic journal which may not be fully compliant with Pennsylvania law and regulation.
