This month, we celebrated major policy wins in the 2025-2026 budget with Acting Secretary Rowe highlighting these investments at a recent [\*\*event at Lewisburg Area School District\*\*](#) and saw firsthand the work the Shapiro Administration is doing to set students up for long-term success.

### A Message from the Acting Secretary on the 50th Anniversary of IDEA



This year marks the 50th anniversary of the Individuals with Disabilities Education Act, an historic law that reshaped the future for millions of children and families across the nation. Pennsylvania played an early role in that story. A landmark court case decided here in our Commonwealth helped establish the principle that every child has value and deserves a public education tailored to their needs. That principle continues to guide our work today.

Over five decades, IDEA has opened classroom doors, strengthened family partnerships, and raised expectations for what students with disabilities can achieve. In Pennsylvania, we see the impact every day. Children receive early intervention that sets a strong foundation for learning. Students are supported in general education classrooms where they learn alongside their peers. Educators and related service providers bring skill and care to each decision, and families remain trusted partners in every step of a child's educational journey.

IDEA's anniversary is a moment to honor the progress made through determination, collaboration, and advocacy. It is also a moment to look ahead. Our charge is to continue breaking down barriers and to keep raising the bar for what every student can achieve. The next 50 years begin now, and I believe it will be defined by how well we listen to students and families, and by how boldly we advance opportunity for all.



## Information Regarding the 2025-2026 Budget

Following last year's record-setting K-12 funding, the 2025-26 budget delivers more than \$900 million in additional funding for public education. Under Governor Shapiro's leadership, Pennsylvania has increased funding for our schools by nearly \$3 billion over the past three years. The investments in this year's budget include:

- **\$565 million** in new adequacy funding to expand support to all school districts across the Commonwealth and a **\$105 million increase** for Basic Education Funding. The adequacy funding formula was expanded to drive out more money to schools.
- **\$40 million increase** for Special Education Funding, continuing the Governor's commitment to equitable education for all students.
- **\$125 million** for school infrastructure improvements to create safe, healthy learning environments — including \$25 million for the Solar for Schools program to lower energy costs and promote sustainability.
- **\$100 million** in annual mental health and school safety funding for K-12 schools, ensuring every student has access to the resources and support they need to thrive, continuing the Shapiro Administration's strong commitment to expanding access to mental health care and support across the Commonwealth.
- Expanded access to school meals, providing universal free breakfast for more than 1.7 million students and free lunch for 22,000 eligible students, with nearly 93 million breakfasts served during the 2024-25 school year — a 13.8 percent increase over two years — including over 70 million meals for students at risk of hunger or from low-income families.
