## Executive Summary

PDE created the *optional* **Teacher-Student Linkages** data set in the School Year 24-25 to allow LEAs to report teacher-student connections to facilitate pre-population of PVAAS custom student reports (a teacher's currently enrolled students with their longitudinal, state and local assessment student-level data, as well as PVAAS student-level projections). The submission of this new data set will ease the administrative burden in creating custom student reports. Furthermore, these reports will grant teachers access to their current students' data, including historical assessment data and PVAAS projections to future assessments. Data will follow students across schools, LEAs/Districts, and school years. LEAs should report data as completely and accurately as possible to PIMS.

## PIMS Teacher-Student Linkages

### Who Must Report

The target audiences for the *Teacher-Specific Linkages* collection are LEAs/school districts, intermediate units, charter schools, and both comprehensive and occupational career and technical centers (CTC). However, all LEA types are welcome to use the extensive range of PVAAS reporting, so this data set is available for submission by all public LEAs.

### What Must Be Reported

The core of this data set comes from one PIMS template: *Staff Student Subtest Template for Teacher-Student Linkages* and references several other PIMS templates for contextual and administrative data. The template is named 'Staff Student Subtest Template for Teacher-Student Linkages' to distinguish it from the 'Staff Student Subtest Template for Act 13 Educator Effectiveness.'

### Teacher-Student Linkages Template

The specification for the *Teacher-Student Linkages* template is in the Student Domain of the ***PIMS Manual Vol. 1 (Staff Student Subtest Template for Teacher-Student Linkages)***. The template should contain one record for each instructional relationship associated with the specific subtest identifier for the respective reporting period. Include instructional relationships for educators who would benefit from access to a comprehensive analysis of a student's historical assessment data and projections for future assessments. This may include classroom teachers, interventionists, and other educational groups providing targeted support to students needing additional assistance beyond the general curriculum. The department sends the relevant fields from this template to our partner for pre-population of custom student reports.

### Staff Template

The *Staff Template* contains a list of all professional-level positions and the people filling those positions in an LEA. The specification for this template is in the Staff Domain of the *PIMS Manual Vol. 1*. The template captures one person per record. The PPID field in the *Teacher-Student Linkages* template is validated against the Staff Template in the PIMS warehouse during the Extract, Transfer, and Load (ETL) phase of the PIMS upload process.

### Student Template

The *Student Template* contains a list of students and their relevant demographic information. The specification for this template is in the Student Domain of the *PIMS Manual Vol. 1*. The template captures one person per record. The PAsecureID field in the *Teacher-Student Linkages* template is validated against the Student Template in the PIMS warehouse during the Extract, Transfer, and Load (ETL) phase of the PIMS upload process.

## Collection Window

The *optional* Teacher-Student Linkages data set will be collected twice a year: October and January. The Elementary/Secondary Data Collection Calendar will have details about the collection windows. See the [Appendices](#) section for a link to the calendar.
