

This Confidential Information & Restrictive Covenant Agreement (the "Agreement") is made as of this day of June 2017, by and between Insight PA Cyber Charter School ("Employer") and Syreda Gralling-Local [name of employee] ("Employee" or "I").

As a condition of commencing my new, at-will employment with the Employer, I agree to the following, intending to be legally bound:

Confidential Information.

- I recognize that in my employment with Employer, I will be placed, from time to (a) time, in a position of trust and confidence in which I will have access to and obtain Confidential Information (as defined below) relating to Employer's business of providing a new, innovative model of public cyber charter school education. Such "Confidential Information" includes, but is not limited to confidential and/or proprietary information of the Employer and Employer's service providers (e.g., K-12) including business, manufacturing, marketing, legal and accounting methods, policies, plans, procedures, strategies and techniques; information concerning curriculum, program and course development materials, methodologies and delivery processes, payment plans, student account payment information, course descriptions, marketing information and programs, financial aid information and programs, enrollment statistics, business plans, and student data, earnings, production volumes and methods for doing business; research and development projects, plans and results: trade secrets (e.g., formulas, methods, processes and specifications) and technical information; the names and addresses of Employer's vendors, suppliers, contractors, students (and their families), potential students (and their families) and former students (and their families) and student lists); pricing, credit and financial information, and other business information that I learn of, obtain, or that is disclosed to me during the course of my employment, either directly or indirectly, in writing, orally, electronically, or by inspection of documents or other tangible property. Nothing herein shall prohibit me from purchasing or owning less than five percent (5%) of the publicly traded securities of any corporation, provided that such ownership represents a passive investment and so long as I am not a controlling person of, or a member of a group that controls, such corporation.

3. As a condition of commencing my new, at-will employment with the Employer, I agree to the following, intending to be legally bound:

1. Confidential Information.

- I recognize that in my employment with Employer, I will be placed, from time to time, in a position of trust and confidence in which I will have access to and obtain Confidential Information (as defined below) relating to Employer's business of providing a new, innovative model of public cyber charter school education. Nothing herein shall prohibit me from purchasing or owning less than five percent (5%) of the publicly traded securities of any corporation, provided that such ownership represents a passive investment and so long as I am not a controlling person of, or a member of a group that controls, such corporation.

3.
