Introduction


The Restraint Information System Collection (RISC) is a data collection system for all restraints across the Commonwealth of Pennsylvania occurring with school-aged students in educational programs that have an Individualized Education Program (IEP). RISC was developed by the Pennsylvania Department of Education (PDE), in conjunction with recommendations from the state Special Education Advisory Panel (SEAP). Annually, this report is presented to the Secretary of Education.

The Bureau of Special Education (BSE) closely monitors the use of positive behavior support and restraints by Local Educational Agencies (LEAs) across the Commonwealth. LEAs are required to comply with 22 Pa. Code § 14.133 (related to school entities) and 22 Pa. Code § 711.46 (related to charter schools and cyber charter schools). This includes reporting RISC data quarterly every school year. 22 Pa. Code §§ 14.133(c)(5) and 711.46(c)(5). This also includes training of personnel in specific procedures, methods, and techniques of restraint. 22 Pa. Code §§ 14.133(f) and 711.46(f). The training of personnel should provide varied intervention and strategies needed to address problem behaviors. PDE asserts the use of restraints is considered a measure of last resort, only to be used after other less restrictive measures, including de-escalation techniques. PDE utilizes the Pennsylvania Training and Technical Assistance Network (PaTTAN) and the 29 Intermediate Units to provide ongoing training to LEAs in Positive Behavior Intervention and Support programs (PBIS) and other research-based practices and techniques to develop and maintain skills that enhance an educator's ability to prevent restraints.

In conjunction with training and technical assistance, BSE also closely monitors LEAs' compliance of restraint with positive behavior support during the Cyclical Monitoring for Continuous Improvement (CMCI) process and conducts ongoing restraint reviews as data is reported in the RISC system throughout a school year. When necessary, BSE conducts further investigation with LEAs when the following instances occur: mechanical restraints (handcuff), electric shock intervention (taser), excessive restraints lasting longer than 60 minutes, multiple injuries occurring with student and/or staff, patterns of excessive holds of a specific student, patterns of excessive holds that have not decreased over time, excessive law enforcement interventions, high waiver count without reconvening the student's IEP team, serious injury warranting a BSE investigation, law enforcement intervention without reconvening the student's IEP team, law enforcement charge under Safe Schools related to a restraint and a student with an IEP (22 Pa. Code § 10.23), and staff not trained in de-escalation and restraint programs. Lastly, due to the COVID-19 pandemic, 2020-2021 school year RISC data has been impacted and should be interpreted with caution.


Local Educational Agencies (LEA) Reporting Restraints

In the 2020-21 school year, of the total 676 LEAs, 596 LEAs reported that restraints occurred, and 80 LEAs reported zero restraints. All LEAs complied with reporting in the Restraint Information Collection System (RISC) program.




Total Number of Incidents of Restraints (by Academic Level)

Total Number of Students Restrained (by Grade Level)


The total number of restraint entries was 9,008. Of the 9,008 entries, 2,382 students were restrained.



Total Number of Students Restrained (by Disability Category)


Of the 2,382 students restrained, the number of restraints by disability category is detailed below.

Location Where Restraints Occurred - Disaggregated


Location of the 9,008 restraints in school-age programs for the 2020-2021 school year:



Types of Restraints Implemented – Disaggregated






Injuries to Staff/Injuries to Students

Of the 9,008 restraints during the 2020-2021 school year, there were 545 injuries (6.05%). There were 382 injuries to staff. There were 118 students that sustained an injury. There were also 45 restraints which occurred where both a staff member and student were injured.



Individualized Education Program (IEP) Meetings After Restraint


IEP Meetings Held, Waived, or Left in Process

Of the 9,008 restraints, the number of waivers and IEP meetings are outlined below:


- 5,483 (60.87%) of restraints the parents waived the available IEP meeting
- 3,183 (35.34%) of restraints an IEP meeting was held
- 328 (3.64%) of restraints parents signed a waiver, and an IEP meeting was held
- 14 (0.16%) of restraints were left "In Process"

Note: The above number of waivers plus the number of IEP meetings held is more than 100% as some parents signed a waiver and then additionally had an IEP meeting.

Remaining restraints were left In-Process. In-Process – More information was needed at the time of this report in the required fields of the individual restraint report and the LEA had not yet fulfilled the process. The In-Process restraint report can still be read by the BSE adviser.



Actions taken by LEAs when the IEP meeting occurred are detailed below.
