

# Student Funding

These programs provide financial aid for students both in and out of PA. Eligible students who fulfill all their obligations (including work and residency requirements) usually do not have to repay this money.

PA students who are first awarded a scholarship or grant by a participating PATH Partner and receive a PA State Grant can qualify for extra funds based on need. These scholarships have the potential to be matched by PHEAA on a dollar-for-dollar basis, up to the annual maximum.

PA students from middle-income families who meet GPA and family income requirements (up to \$175,000) may qualify. Participating schools nominate college sophomores, juniors, and seniors based on eligibility criteria.

Pennsylvania's flagship aid program. The amount of money PA residents can expect to receive is based on their financial situation, the school they attend, and the availability of funding. Students going to school outside PA may qualify for a smaller award based on the state and type of school they attend.				
Postsecondary institutions must be approved by PHEAA for students to receive awards.

Details				
PA students must be enrolled at least half-time in a PA State Grant Program-approved higher education institution. Undergraduates must be eligible for a PA State Grant to qualify for the SWSP. Graduate students must demonstrate financial need after gift aid—including federal, state scholarships, and grants—has been applied. Students work at an eligible job, which they can find online.

### Details

PA students with financial need can receive this grant if they are enrolled in programs that teach skills for high demand fields. High-demand fields include energy, health, advanced materials and diversified manufacturing, and agriculture and food production programs. Students who qualify for a PA-TIP award cannot get a PA State Grant for the same program.

### PA Blind or Deaf Higher Education Beneficiary Grant (BDBG) Program

### Details

PA residents with visual or hearing impairments can submit written documentation to apply for funding. This program funds both graduates and undergraduates on a first-come, first-served basis.

### Chafee Education & Training Grant (Chafee ETG) Program

### Details

Provides federal grants to PA undergraduates who experienced foster care at age 16 or older—including students who were adopted or entered permanent legal guardianship after turning 16. Students must also be younger than age 26 by July 1 of the upcoming academic year.

### PA Fostering Independence Tuition Waiver (FosterEd) Program

### Details

Waives outstanding tuition and mandatory fees in PA schools for students who also qualify for Chafee ETG. It covers all remaining tuition and mandatory fees after gift aid—including federal, state scholarships and grants—is applied.

### Bond-Hill Scholarship (Bond-Hill) Program

#### Details

Provides a scholarship for eligible alumni of PA's two HBCUs (Lincoln and Cheyney Universities). Students must pursue professional study in competitive fields like law, medicine, dentistry, and other selected graduate programs at the Commonwealth's state-related universities and PA State System of Higher Education (PASSHE) institutions.

### PA Internship Program (PIP)

#### Details

Provides funds to PA students attending PA-based colleges or universities and participating in internship or seminar programs with TWC.

The maximum award for internships is \$7,250 for students attending a public institution; it is \$8,500 if attending a state-related or PASSHE institution and using TWC housing; it is \$4,000 if attending a private school. Students attending an academic seminar can receive a scholarship for up to \$4,000.

## Students With **Work or Volunteer Commitments**

#### Details

Provides tuition and loan assistance to help the state recruit and retain volunteer first responders at volunteer fire companies and emergency medical services companies. Volunteers must also meet active participation requirements for at least 1 year prior to applying for this program.

### Grow PA Scholarship Grant (Grow PA Grant) Program

#### Details

Provides grants to PA residents who attend a PA college to pursue a degree in a high-demand occupation and agree to work and live in Pennsylvania after graduation.

**NOTE:** Award converts to a loan if recipient does not meet the work and residency requirement.

### Grow PA Tuition Waiver (Grow PA Waiver) Program

#### Details

Provides in-state tuition to out-of-state residents who attend a PASSHE university to pursue a degree in a high-demand occupation. Students must agree to live and work in PA after graduation.

**NOTE:** Award converts to a loan if recipient does not meet the work and residency requirement.

### PA Mental Health Education Learning Program in Schools (PA HELPS)

#### Details

Provides a stipend to support school-based mental health professionals enrolled in one of four PA Department of Education approved Educational Specialist Preparation Programs. Students must agree to work in PA after graduation. Students who successfully complete their work commitment may receive an additional \$5,000 award.

The maximum award for school psychologists is \$25,000; it is \$2,500 for school nurses; it is \$10,000 for school counselors and school social workers.

### PA Student Teacher Support Program (STSP)

#### Details

Provides financial support to help students complete student teaching requirements at schools with high turnover. The goal of this program is to reduce teacher shortages in PA. Students must agree to work in PA after graduation.

**NOTE:** Award converts to a loan if recipient does not meet the work requirement.

### PA Student Loan Relief for Nurses (SLRN) Program

#### Details

Nurses can no longer apply for this program; it was limited to 3 years from 2020-2022. SLRN provided a financial incentive, in the form of student loan relief, for PA nurses who worked fighting the COVID-19 pandemic to continue within the nursing profession.

## Military Students & Families

#### Details

Provides a waiver of tuition and fees for unmarried surviving spouses up to 10 years after the PA National Guard service member was killed or died as a result of injuries while in federal or state active duty. To contact the National Guard, call 1-800-GO-GUARD.

#### Details

Provides tuition assistance for students who enter a 6-year service commitment with the PA National Guard. This program is administered by PHEAA and the PA Department of Military and Veterans Affairs. To contact the National Guard, call 1-800-GO-GUARD.

#### Details

Provides full tuition coverage, plus room, board, and stipends, for up to 10 students per year. This accelerated ROTC program allows participants to pursue their education while serving PA and the nation. Students earn a degree and attain the rank of Second Lieutenant in the PA National Guard.

This scholarship is based on merit and grades.

### PA National Guard Military Family Education Program (MFEP)

#### Details

Provides tuition assistance for dependents (children and spouses) of a service member who enters a 6-year service commitment with the PA National Guard. This program is administered by PHEAA and the PA Department of Military and Veterans Affairs. To contact the National Guard, call 1-800-GO-GUARD.

## PA Postsecondary Educational Gratuity Program (PEGP)

### Details

Waives any remaining institutional charges at state-owned and supported institutions of higher education after gift aid—including federal state scholarships, and grants—has been applied. The waiver covers all remaining costs of tuition, fees, on-campus housing, and food.

Spouses and birth or adoptive children of PA police officers, firefighters, rescue and ambulance squad members, corrections employees, and National Guard members who died in the line of duty since January 1, 1976, can apply.

## School Funding

### Details

These funds support services for academically and financially disadvantaged undergraduates. Act 101 Programs exist to help students who may struggle to graduate due to their economic or educational backgrounds.

### Details

Provides funds for institutions that apply for and receive federal dollars through the FWS program for community service jobs.

Institutions must spend at least 7% of FWS funds received from ED to employ students in community service positions. PHEAA's FWS-CS Program provides eligible PA postsecondary institutions with funds to help meet their FWS community service requirement.

#### Details

Provides funds for institutions that apply for and receive federal dollars through the FWS program for on-campus jobs.

Institutions must match FWS funds received from the U.S. Department of Education (ED). PHEAA's FWS-ON Program provides eligible PA postsecondary institutions with funds to help meet their FWS institutional match requirement. Institutions receiving Title III Waivers are currently eligible to receive FWS-ON funds even though they are exempt from the matching requirement.

### PA Institutional Assistance Grants (IAG) Program

#### Details

Provides funds to help independent, postsecondary institutions maintain enrollment levels and stabilize their educational costs. Eligible institutions receive block grants based on the number of PA State Grant-receiving students in attendance.

The institution must spend the grant on eligible institutional expenses, such as staff salaries, operating expenses, utilities, or maintenance. IAG funds may not be spent on sectarian or denominational expenses.
