RULES AND REGULATIONS

Rules, Regulations, and Health	1. All entries in these classes will also be subject to the General Rules, Regulations, and Health Requirements: https://www.farmshow.pa.gov/pafarmshow/exhibit/rules-regulations
Eligibility	2. Only registered animals may be shown in the Open Boer Goat Show. All Boer goats must be registered in the herd-book of a recognized association before the date of the show. Recognized associations include ABGA, and the Canadian Boer Goat Association.
Boer Goat	3. All animals must be registered purebred, fullblood, or percentage blood Boer goats. Percentage doe classes must be 50% to 88%, Purebred/Fullblood doe classes must be 15/16 blood (94%) and higher. Bucks must be 31/32 blood (97%) and higher.
Certification	<p>4. All goats must be registered in the ABGA herd book by the date specified by the show. Original registration certificates are required, except that a copy of a registration application stamped with the date received by ABGA can be accepted for kids less than 3 months of age. Animals over the age of 3 months must be verified as registered in the ABGA database at the time of show. An animal that may be verified as registered in the web-based database of ABGA will be accepted in lieu of registration certificate. Verification must be provided by the exhibitor in either digital or print to the show secretary. JABGA ownership must be verified using the transfer history on the animal pedigree if the certificate is not provided.</p> <p>All goats must be appropriately identified and comply with USDA Scrapie Eradication Program Guidelines. Call 1-888-USDA TAG (873-2824) or visit the following website for more information: http://www.aphis.usda.gov/animal_health/animal_diseases/scrapie/</p> <p>ABGA prohibits the transfer of any goat exhibited in a JABGA sanctioned show back to the seller and/or seller's agent for a period of one year from date of purchase for all goats that are not bred and owned by the JABGA exhibitor.</p> <p>When the animal is verified as registered in the ABGA database or a stamped registration application is presented at check-in, registered name, ABGA registration number and tattoos/microchip number of each animal must be recorded.</p> <p>All goats must have legible tattoos consistent with the registration certificate or the animal will be disqualified. If an animal is disqualified due to illegible or inconsistent tattoos, all lower placing animals will be moved up in placement. First and second place animals in each class will have their tattoos read.</p> <p>Permanently implanted microchip identification will be accepted by ABGA as official identification in addition to, or in lieu of, tattoos. The owner is responsible for providing the appropriate scanning device to read any microchip used for identification purposes.</p> <p>Goats registered in a frozen or suspended account are ineligible to exhibit.</p>
Age	5. Ages will be determined by the birth date on the registration certificate and calculated to December 31, 2025.
Horns	6. Animals with natural horns, disbudded, or de-horned may be shown without regard to discrimination.
Judge History	7. An exhibitor shall not present an animal to be shown under a judge from whom it was purchased within 90 days of the show.

RULES AND REGULATIONS

Merit	8. In classes where there is no competition, awards shall be made by the judge according to the merit of the animal. In class(es) where the quality of the animal(s) is not of Champion consideration type, the judge shall begin the class(es) with a second-place ribbon and the animal(s) shall not compete for Champion or Reserve Champion.
Breeding Requirements	9. To be shown, all Boer does must have kidded or exhibited pregnancy by 24 months of age.
Entry Limits and Fees	10. An exhibitor shall be limited to two entries in any one class. Entry fee is \$10.00 per head.
Arrival	11. Meat goats must arrive on Wednesday, January 14th, between 2:00 p.m. and 6:00 p.m. All animals must have papers presented by 6:00 p.m. Tattoos will be read on each goat at check-in.
Check-In	12. All goats must be checked in with the Superintendent by 6:00 p.m. on Wednesday, January 14, 2026.
Release	13. Release time is 5:00 p.m. on Saturday, January 17, 2026. Any exhibit removed prior to the listed times without Show Management approval will result in forfeiture of all premiums.
Substitutions	14. Substitutions are allowed in the same class only and must have same ownership as the original entry. Substitutions will be made at check-in.
Champion Classes	15. Competition will be limited to first- and second-place animals.
Grooming	16. Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, DO NOT use it.
Drenching	17. Drenching of animals is not permitted unless approved by the show veterinarian.
Show Order	18. Open Boer Goat show will follow the Junior Boer Goat Show. The Junior Meat Breeding show will begin on Saturday, January 17th, at 8:00 a.m. with Showmanship, followed by the breeding classes. Classes will start with Percentage Does and will be followed by Fullblood Does.
New! Fitting Stand	19. Fitting stands goats will be charged at a rate of \$20 per stand. Each exhibitor/farm/family is allowed to have one stand for three animals. No late fee will apply for the goats stands for 2026. A sticker will be furnished by Show Management to serve as proof of payment. The stand must have the sticker affixed to somewhere visible. All stands must be kept out of aisles and in designated areas or they will be removed from the grounds.
New! Barn Watch	20. If it's not right, report it! Because doing the right thing matters, every time, every ring. Report suspicious activity in the barns anonymously via form: https://forms.office.com/g/dEkb5671XR .
New! Code of Show Ring Ethics	21. The Mandatory Code of Show Ring Ethics form must be read, signed, dated, and then uploaded with entry by the entry deadline.

Rules, Regulations, and Health	1. All entries in these classes will also be subject to the General Rules, Regulations, and Health Requirements: https://www.farmshow.pa.gov/pafarmshow/exhibit/rules-regulations . All entries will be subject to the rules and regulations found on pages 2-3.
Eligibility	2. These classes are open to 4-H Club and FFA members. Exhibitors must have been born from 2006 through 2016 inclusive. Exhibitors must be 4-H members carrying a meat goat project under the supervision of the Pennsylvania State University Agricultural Extension Service or a dues-paying FFA member carrying a meat goat project under the supervision of a Pennsylvania Vocational Agricultural Instructor. No exhibitor shall be eligible who does not take entire charge and care of his or her animals except in the case of illness or some other reason approved by the Farm Show Commission.
Entry Deadline	3. Entries must be computer timestamped by November 6, 2025. Entries must be made online at www.farmshow.pa.gov by the entry deadline giving all necessary information.
Entry Fee	4. No entry fee.
Ownership	5. All animals must be owned by and be in the possession of the exhibitor by November 6, 2025, in the name of the junior exhibitor only.
Breeding and Market	6. An animal may show in one division only. Meat Breeding does cannot show in the Market Goat Division and vice versa.
Registration Papers	7. Boer goats must be registered as fullbloods or purebred Boer goats to show in Boer classes. Percentage Boer goats must have papers listing the animal as a percentage Boer to show in percentage classes.
Arrival	8. Junior Meat Breeding Goats must arrive by 5:00 p.m. on Wednesday, January 14, 2026. Pens will be open to receive animals at 2:00 p.m. on Wednesday, January 14, 2026. All goats must be checked in with the Superintendent by 6:00 p.m. on Wednesday, January 14, 2026.
Grooming	9. Use only grooming products that are approved for use on meat and milk-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues. IF IT IS NOT CERTAIN THAT A PRODUCT IS RESIDUE SAFE AND APPROVED FOR USE ON MEAT AND MILK PRODUCING ANIMALS, DON'T USE IT.
Release	10. Meat Breeding Goats will be released at 5:00 p.m. on Saturday, January 17, 2026, and must depart by midnight. Any exhibit removed prior to the listed times without Show Management approval will result in forfeiture of all premiums.
Drenching	11. Drenching is prohibited.

GOOD HOUSEKEEPING AWARDS

The Pennsylvania Farm Show Commission offers special daily premiums to breeding goat exhibitors who maintain the most attractive and sanitary exhibit at the 2026 Pennsylvania Farm Show.

Exhibits of five goats or more will be scored on the following basis:

Preparation of Exhibit - 40 Points

- Decorations neat and attractive, well-planned, not too gaudy or overdone
- Appropriate Farm or Exhibitor signs displaying complete information
- Appropriate color scheme, background, show boxes, and originality

Appearance and attitude of exhibitors - 20 Points

- Knowledgeable, courteous, friendly, and able to answer questions about the exhibit and goats
- Clothes and person neat and clean, dressed appropriately

Care of the exhibit - 40 Points

- Animals clean and well-groomed
- Aisles are clean and neat with adequate space for spectators to walk through
- Bedding clean and dry
- Feed and equipment stored neatly (out of sight if possible), equipment clean

Total - 100 Points

Inspections will be made unannounced. Exhibitors will be scored daily and their rating for the day published. Prizes will be awarded Thursday through Saturday with grand prizes for the total period.

FIRE REGULATIONS

1. All exit corridors and emergency exits must be kept clear; no partial blocking will be permitted.
2. All fire alarm pull stations must be kept clear.
3. Fire extinguishers may not be covered by any drapes or hidden by any type of displays.
4. No motorized camping units or vehicles may contain more than one (1) gallon of fuel while on display.
5. All pressurized fuel tanks may be drained.
6. All fuel fills must be locked and fuel caps must be taped closed with duct tape.
7. Any living trees and shrubs are acceptable as long as the shrubbery is individually bagged and baled.
8. Artificial trees and shrubbery must be treated with a flame proofing material. The fire official may request certification of flame proofing.
9. Any type of mulch materials must be treated with a flame proofing material or watered daily. If treated with a flame proofing material, certification may be requested by the fire official.
10. Smoking is prohibited in the Pennsylvania Farm Show Complex & Expo Center.
11. No open flames, fires or burning of any kind will be permitted within the Complex. No exterior burning is allowed unless the Department of Environmental Protection and the Bureau of Fire grant permission.
12. Vendors setting up tents, canopies and membrane covering must provide fire department with fire rating of material. Vendors must also provide any required portable fire extinguishers as needed.
13. Outside propane tanks shall be protected by posts or other approved physical barriers (Jersey barriers).
14. Extinguishers need to be visible, accessible and located in a conspicuous location where they will be readily accessible and immediately available for uses. These locations shall be along normal paths of travel.
15. Doors shall never be blocked or tied off.
16. The Fire Prevention Code of Harrisburg will be strictly enforced.

EMERGENCY PREPAREDNESS TIPS

EARLY DETECTION

- Early detection is the most effective way to prevent emergencies or lessen their impacts.
- Vendors and exhibitors will likely be the first to witness, experience, or report incidents.
- You can be the difference in preventing something harmful from happening.
- To report any type of threat or emergency incident, notify the PA State Police Command Post.

BOMB THREATS

- Threats can be made in person, by phone, or in written message.
- Collect as much detailed information as possible about the threat (when, why, how, exact wording of threat, type of voice, personal appearance, clothing description, name, gender, phone number, physical address).
- It is especially important to know the perpetrator's timeline for activation of the device (when will it occur?).
- Immediately report the threat to the State Police Command Post.
- Authorities will investigate the threat and make the proper decisions accordingly in coordination with facility management.

LOST CHILDREN

- Be sure to get the full name of the lost child and keep them safe with you. Notify the Farm Show security desk or closest security/law enforcement team. PSP or Farm Show staff will help to reunite lost children with loved ones.

SHELTER IN PLACE

- Although rare, there could be incidents that occur outside the facility that could put people at risk (chemical fire, very severe weather). In these instances, a shelter-in-place plan will be implemented for the welfare of all occupants.

SUSPICIOUS OBJECT

- Do not touch or disturb the object.
- Maintain a safe distance from the object and attempt to isolate the area.
- Notify the State Police Command Post with a description and location of the object.

SUSPICIOUS PERSON

- Observe the circumstances and behavior of the suspicious activity.
- Notify the State Police Command Post and provide as much detail as possible.
- Details about the person should include direction of travel, appearance, height and weight, build, clothing, speech, and anything about the behavior that indicates suspicion.

FLOODING

- Facility management will attempt to mitigate the effects of flooding and natural disasters before they happen and will work with all show vendors during this type of event.
- The Maclay and West parking lots are susceptible to flash flooding.
- Avoid contact with flood water.
- If major interstates or surrounding roads are being closed, facility management will make announcements accordingly.

MEDICAL EMERGENCY

- Notify the State Police Command Post and they will dispatch emergency medical services to the location.
- Describe the nature and severity of the medical incident and location of the victim.
- Do not attempt to move the person unless you are a trained medical responder.
- Stay with the victim and seek help from others if necessary.
- If rendering aid due to your training, be careful not to expose yourself to hazards such as fire, electricity, hazardous materials, or blood borne pathogens

FIRE & EVACUATION

- If you see a fire, activate the nearest alarm or notify the Farm Show Security Desk.
- The City of Harrisburg Bureau of Fire will respond to the alarm.
- When the building evacuation alarm is activated, leave by the closest and safest exit and alert others to do the same.
- Quickly take all personal belongings.
- Please listen to the instructions of the PA system announcements, Farm Show Complex employees, or responders.
- Do not use elevators!
- The facility is equipped with sprinklers and ABC fire extinguishers.
- Once outside, move a safe distance from the building.
- Do not return to an evacuated building until the 'all-clear' sign is provided by the Fire Chief, a Police Officer, or any other official first responder.
- Do not operate cell phones during an evacuation until the 'all-clear' is given

VIOLENT BEHAVIOR

- Your safety comes first. Use your best judgement to preserve your life.
- Report any physical abuse to the State Police Command Post.
- If there's an active shooter in the facility but not in your area, evacuate the facility and find safety.
- If the active shooter is near your area and preventing your escape, go to a room that can be lock or barricaded or hide and remain silent.
- If the shooter knows you are there but you feel you can flee, quickly evacuate the area.
- If you feel like fleeing is not possible, you can either confront, or attempt to overpower the person.
- If there is a shooter, messages regarding the known location of that person may be broadcast over the PA System.
