# RULES AND REGULATIONS

## Eligibility

1. These classes are open to 4-H Club and FFA members. Exhibitors must have been born in **2006 to 2016** inclusively. Farm Show animals must be carried as a project under the supervision of the Pennsylvania State University Agricultural Extension Service or of a Pennsylvania Agricultural Education Instructor. 4-H Market Animal entries are a continuation of the previous 4-H year. During the previous year, 4-H members must have been enrolled in a large meat animal (beef, swine, sheep, and meat goat) project by June 1 and must be a member in good standing as defined by the state 4-H or FFA office.

The Pennsylvania Farm Show is requiring all youth market livestock exhibitors showing at the Pennsylvania Farm Show to have completed the applicable YQCA (Youth Quality Assurance-<https://yqcaprogram.org/>) program training. **Proof of completion must be submitted to the Farm Show Livestock Office no later than your entry deadline date. Submit to [farmshow@pa.gov](mailto:farmshow@pa.gov) or submit with online entry.**

FFA market animal exhibitors must be currently carrying an SAE project for the species for which they wish to make an entry. Exhibitors, county extension personnel, or ag instructors are encouraged to disclose any exhibitor disabilities to the committee chairs prior to the show so that accommodations can be made. Junior livestock must be shown by the owner except in the case of illness or physical disability, in which case another member who meets the requirements may show that animal(s); however, this member will not qualify for the showmanship contest. Attendance at school or athletic events is not considered an excuse for absence. Exhibitors not showing their own animals must notify the Show Superintendent before entering the ring.

Unethical or abusive activities are not allowed and will result in disqualification of the exhibitor from the show at sole decision of Farm Show Management. (Read “Guidelines for Care of Animals” and the “Pennsylvania Farm Show Code of Show Ring Ethics”). The purpose of a youth project is to learn by doing via hands-on educational experiences. Youth who rely on professional fitters to perform activities in preparing their animals for show fail to gain these experiences. Farm Show Management expects all youth to live up to the 4-H and FFA philosophies. **Project animals must be housed near enough to the exhibitor to be cared for regularly by the exhibitor. Show Management reserves the right to do random or complaint-driven on-farm inspections to ensure compliance.**

Each registered purebred animal (breeding and market) must be registered in the name of the junior exhibitor only. **No reference to farm name or joint ownership (including sibling ownership) is permitted.** Market animals must not change ownership, be shown by another exhibitor, or be offered for sale in an auction from the time it is identified (ear tagged) for the Farm Show until sold at the 2026 Farm Show Sale. Exhibitors not conforming to this rule will be ineligible to participate in accordance with Rule 10 in General Rules and Regulations.

## Entry Process

2. To be qualified to exhibit in the Jr. Market Animal Show, the following steps must be completed.

- **Identification and proof of ownership** – Animals must meet the ownership and identification requirements for that species (see rules for market cattle, market goats, market lambs, and market swine). Each animal may be tagged and registered to only one exhibitor.
- **Entry** – Exhibitors will need to enter their animal into <http://pafarmliv.fairentry.com> under Junior Market using a valid RFID tag obtained by the Farm Show office or from the farm that the animal originated.
- **Entry/Tagging Deadlines** – Cattle- June 26, 2025; Goats, Lambs, and Swine - October 15, 2025. Online registration by these dates will serve as entry into the 2026 Farm Show. Extension Educators or FFA advisors must verify the tag in each animal’s ear and fill out the tag report form with the Farm Show office by the tagging deadlines.

	<ul style="list-style-type: none"> <li>• <b>On-farm spot inspections of market animals are possible between the tagging deadline and the show. Untagged or improperly tagged animals, or animals housed at a location other than that listed on the entry form will be disqualified. Extension Educators or FFA advisors are encouraged to personally observe animal tagging and ensure animals are properly tagged before the entry deadline.</b></li> </ul>
Health Requirements	3. Health Requirements are listed in the <a href="#">General Rules and Regulations</a> . All entries will be subject to the <a href="#">General Rules and Regulations</a> .
Identification	4. Exhibitors are required to take a hair sample of each junior market animal they are entering for the 2026 Farm Show. Must request hair collector card from Farm Show office by email <a href="mailto:farmshow@pa.gov">farmshow@pa.gov</a> or calling the office 717-787-2905. The hair sample has to be pulled according to the show office guidelines (included with collector envelope), mailed in the hair collector envelope and postmarked by the entry deadline. Mail samples to the Farm Show Admin Office, 2300 N Cameron St, Harrisburg, PA 17110. Envelopes need the specific three signatures and at least 40 hairs with follicles- guidelines on how to pull located here: <a href="https://wednaid.com/videos/">https://wednaid.com/videos/</a> . A second hair follicle sample will be pulled at random during weigh in and first and second place animals in each species to verify that it is the same animal entered.
Entry Limit	5. Each exhibitor may exhibit <b>one animal</b> in each Market Animal Division. In preparation for the PA Farm Show competition, an exhibitor may place on feed and maintain in their possession by June 26, 2025 (market cattle) or October 15, 2025 (goats, sheep, swine) up to <b>two</b> market animals per species from which <b>one animal per species will be selected for exhibition</b> . To be eligible for the Farm Show, market animals must be uniquely identified by a PA Farm Show 840 RFID Tag. Tags can be obtained from the Farm Show office. <b>ONLY ONE ANIMAL PER SPECIES MAY BE BROUGHT AND PRESENTED AT THE FARM SHOW</b> and must be declared before the scale. <b>If two market animals of the same species are brought to the Farm Show, one will be dismissed.</b> The animal cannot be changed after it is weighed. <b>Each animal may be tagged and registered to only one exhibitor.</b>
Proof of Ownership	6. The Junior Market Animal Tag Report Entry Form must be submitted for each county by the Extension Educator or FFA chapter by the FFA Advisor using the official report form, and it must be received by the Farm Show Manager by the tagging deadline.
<i>New!</i> Appeals Process	7. If a junior exhibitor wishes to appeal a decision regarding eligibility, qualification, or rule of interpretation made by the Show Committee or the Farm Show Events Management Division, they may appeal by the following procedure: First - a \$100 deposit is due with appeal to the Department Chairperson. Second - appeal to the Farm Show Events Director. Third - appeal to the Ethics Committee. This committee will make a final ruling on all questions and appeals regarding Farm Show Rules and will be available only after appeals one and two above have been completed and denied. Any appeal will be resolved in a timely manner. This appeals process does not apply to rulings of official judges. All decisions by judges are final.
<i>New!</i> Barn Watch	8. If it's not right, report it! Because doing the right thing matters, every time, every ring. Report suspicious activity in the barns anonymously via form: <a href="https://forms.office.com/g/dEkb5671XR">https://forms.office.com/g/dEkb5671XR</a> .
<i>New!</i> Barn Closure	9. Barns will be closed, locked down, and monitored between the hours of 11 p.m. and 4 a.m. each evening except for Friday, January 9, 2026 when the barns will stay open until 1 a.m.

# RULES AND REGULATIONS

RFID Tags	10. A legitimate 840 RFID Tag must match the current information on record at the Farm Show. If the 840 RFID Tag information does not match, entry does not have an 840 RFID Tag, or 840 RFID Tag does not scan, entry will be disqualified. RFID tags from one or more animal in each class may be re-scanned immediately after each class is placed and compared to records on file.
Unsuitable Animals	11. The Farm Show Commission recommends that county units or groups eliminate any animals for competition and sale that may not be in suitable condition, or which cannot be satisfactorily handled under show conditions. The Farm Show Commission will appoint a sifting committee to eliminate any unsuitable animals, including stags, from the show and their decision will be final. Any animal that appears to be unsafe for handlers or to the general public attending the Farm Show can be required to be removed from the Farm Show facilities by Farm Show Management.
Blocking Chutes	12. A \$40 fee must be paid by November 6, 2025, for each beef cattle blocking chute to be used during the Pennsylvania Farm Show. A sticker will be furnished by Show Management to serve as proof of payment. Blocking chutes must have this sticker affixed to the right rear upright at eye level and remain in designated areas or they will be removed from the grounds.
Exhibitor Responsibility	13. It is the responsibility of the exhibitor to see that their animal is present at the specified time and place for weighing, showing, and selling.
Caretakers	14. Each club or county unit must provide sufficient caretakers for each species and make provisions for their expenses.
<i>New!</i> Grand Champion Market Drive Eligibility	15. For each species, the top five crossbreds and top five purebreds from every division will be in the Grand Drive. For goats, the top 3 goats in 4 divisions will be in the drive. All animals will not arrive at the same time. Times when species are judged at the drive will be announced.
Sale	16. All market animals presented for check-in must be sold either through the Junior Market Animal Sale or by Farm Show Management.
Grooming	17. Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, don't use it!
Unethical Fitting	18. Any animal showing any evidence of unethical fitting practices such as tampering with the natural fleshing and muscle development will forfeit any awards and premiums and will not be permitted to show at Farm Show for one year. Artificial fins on cattle are not permitted. <b>No grooming will be permitted by adding material to the animal beyond hair that is growing from the animal including but not limited to materials such as hair, twine, or nylon. No exhibitors shall be allowed to use any coloring agents on any animal exhibited.</b> The Farm Show may adopt and implement various tests designed to monitor this prohibition, including but not limited to a "white glove" or "white towel" test. Any exhibitor found to be using coloring agents will forfeit any ribbons and premiums and will not be permitted to show at Farm Show for one year. No aerosol cans or other pressurized containers will be allowed in designated makeup areas. Designated makeup areas will be the Lower Spine and arena areas. <b>Drenching of animals is not permitted unless approved by the show veterinarian.</b>

# RULES AND REGULATIONS

Market Animals	19. Animals consigned for slaughter during or immediately following the show shall not receive any treatment with drugs or biologics within the withdrawal time prior to slaughter. Withdrawal times for drugs and biologics are all stated on the directions for use. Label directions must be followed at all times. A Drug Certification and Disclosure Statement must be submitted at weigh-in. <b>**Important**! If upon slaughter, treatment with drugs, biologics, or any chemical from fitting products is the cause of the condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor. All sale proceeds, premiums, banners and awards, will be forfeited by the exhibitor and the exhibitor may not be permitted to show at Farm Show for one year pending decision of the Show Manager. Unapproved substances are prohibited. Animals will be tested for unapproved substances.</b>
<i>New!</i> Sale Animals	20. All sale animals must be washed after showing. The use of any grooming products ( <b>including glitter</b> ) applied to livestock after the show and prior to the sale is prohibited.
Substance Testing	21. All Champions, Reserves, and random samples will be tested for beta agonists. Approximately 100 milligrams of hair will be shaved off animal for substance testing after the Sale of Champions.
<i>New!</i> Blood Testing	e. At the completion of the show (if not before), first and second place animals from each cattle, lamb, and goat class must be presented for blood sampling. The exhibitor and a parent/guardian must complete this task to receive premiums and to maintain sale eligibility.
<i>New!</i> Code of Show Ring Ethics	22. The <a href="#">Mandatory Code of Show Ring Ethics form</a> must be read, signed, dated, and then uploaded with the online entry by the entry deadline.
Pennsylvania Bred Class	23. In efforts to know where your animal is coming from and promoting Pennsylvania bred animals, awards will be given to the top two animals bred in Pennsylvania. Grand and Reserve will be selected during the Grand Drive. To participate in this class: <ul style="list-style-type: none"> <li>• Make sure your animal has an 840 RFID tag or Scrapie tag from the original Pennsylvania breeder. The 840 RFID tag must be registered with your 4-H Educator or FFA advisor as well as the official Farm Show entry. For sheep and goats, the Scrapie tag needs to accompany the 840 RFID tag in the entry.</li> <li>• Make sure to add this class when you enter.</li> </ul>



# REGISTRATION

The State Farm Products Show Commission reserves the right to test any animal for the illegal use of drugs or antibiotics. The act of entering an animal in this show is giving consent by the owner, exhibitor, trainer, and/or absolutely responsible person for Show Management to obtain any specimen of urine, saliva, blood, or other substances from the animal to be used in testing. Testing will be conducted at the 2026 Pennsylvania Farm Show. Jr. Market and Junior Production animal exhibitors and their parents will be required to sign a statement that they will abide by the Pennsylvania Farm Show Code of Show Ring Ethics and will permit testing of their animals. All animals will be tested for the presence of beta agonists.

# JUNIOR MARKET ANIMAL SALE

## DATE/TIME

### Junior Market Animal Sale

The Grand and Reserve Champion will sell in the Junior Market Animal Sale of Champions on Tuesday, January 13, 2026, at 9:30 a.m.  
Small Arena

The Pennsylvania Farm Show Scholarship Foundation will conduct an auction sale of market animals shown by youth exhibitors in the 2026 Pennsylvania Farm Show: Junior Market Cattle, Junior Market Lamb, Junior Market Goat, and Junior Market Swine shows as well as the top 10 Junior Rabbit Meat Pens and top 5 Junior Market Turkeys. All exhibitors of Junior Market Animals that meet the weight requirement, exhibit in their designated class, meet show placing requirements, and are selected by the Foundation Show and Sale Committee Chairmen must consign their animals.

Sale schedule will be as follows: Sale of Champions – Grand Champions, Reserve Grand Champions, and Supreme Showman (qualified market animals) – **9:30 a.m. Lambs, Goats, Rabbits, Turkeys, Swine, Cattle**

- **Cattle** - Cattle weighing less than 1,000 pounds will not be eligible to sell. Exhibitors are required to tie animals in stalls after animals are sold, using a rope halter that is acceptable to the chairman of the beef cattle division of the show. Failure to provide such acceptable rope halter will subject the exhibitor to a deduction of \$5 from the proceeds of sale of the animals.
- **Lambs** - 120 lambs will sell in the Junior Livestock Auction. The highest-placing lambs in each class will be selected to sell based on the percentage of the total shown. At least three purebreds from each breed will be selected. The balance of lambs will be sold by Farm Show Management.
- **Goats** - 80 Market Goats will sell in the Junior Livestock Auction. The five highest-placing goats in each class will be selected to sell. The balance of the goats will be sold by Farm Show Management.
- **Swine** - 160 pigs will sell in the Junior Livestock Auction. The highest-placing pigs in each class will be selected to sell based on the percentage of the total shown. At least three purebreds from each breed will be selected. All market hogs selling in the Junior Market Animal Sale must be sold for slaughter through the buy-back program. The balance of pigs will be sold by Farm Show Management.
- **Turkeys** - Top five turkeys will sell in the Junior Livestock Auction.

### SALE DEDUCTIONS:

- (a) **Scholarship Fund** - 1% of the amount due each exhibitor will be deducted from the sale of Jr. Market animals for the Farm Show Scholarship Fund. However, deductions for the Scholarship Fund will be made at the rate of 30% for the Grand & Reserve Grand Champion Market animals of each species (cattle, sheep, goats, swine, rabbit meat pens, and turkeys) and the Supreme Market Showman.
- (b) **4-H/FFA** - An additional 1%, up to the limits listed above, also will be deducted and this money will be divided proportionally for the 4-H Youth Development and the FFA Foundation to be used specifically for livestock projects.
- (c) **Sale Expenses** - An additional 3%, up to the limits listed above, will also be deducted for sale expenses from the amount due each exhibitor for animals sold through the auction sale.

Equine Arena

General	1. a. Junior Market Cattle are subject to all <a href="#">General Rules and Regulations</a> and all Department Rules and Regulations (pages 3-6).
Arrival	b. Junior Market Cattle must arrive between 8:00 a.m. on Thursday, January 8, 2026, and 7:00 p.m. on Friday, January 9, 2026. Junior Market Cattle must not be stabled in the barn prior to that time and must be on display in the assigned stalling areas during daylight hours from Saturday through Tuesday.
Purebred Class Eligibility	c. All market cattle must have a legible tattoo that matches the breed association provided registration certificate in order to qualify for the purebred division. Any purebred steer whose breed is not listed below must be entered into DIVISION 0008 Other Purebreds. All transfers must be on or before June 26, 2025. All heifers must enter and show in DIVISION 0009 Market Heifers.
Unsuitable Animals	d. All Junior Market Cattle will be evaluated by a sifting committee. Junior Market Cattle that are undesirable as market cattle will not be accepted for show or sale. All Junior Market Cattle must be naturally polled or de-horned to a safe condition as determined by the sifting committee. Heifers may not have any visible signs of pregnancy. Decisions of the sifting committee will be final.
Bedding	e. Shredded wood fiber 4" - 6" deep will be provided by the Farm Show. No other type of bedding is permitted in the beef cattle area.
Check-In and Processing	2. a. All Junior Market Cattle will be checked in and weighed from 7:00 a.m. until 9:00 a.m. on Saturday, January 10, 2026. Exhibitors and their market cattle must report to the scales in the North Hall where identification, health papers, registration papers (if applicable), and RFID Tag Numbers will be checked. CATTLE WEIGHING LESS THAN 1,000 POUNDS WILL NOT BE ELIGIBLE TO SHOW. Steers must have a legible tattoo that matches the Registration Certificate in order to qualify for the purebred division. Registration papers, etc. must be presented to the beef committee at the time of check-in. If the papers are not presented at that time, the steers must show in the crossbred class.

# JUNIOR MARKET CATTLE

Show Procedures	3. a. Market cattle will be divided as equitably as possible into weight classes not to exceed a total of 16 classes (crossbred and purebred).
Weight Divisions	b. There will be up to eight crossbred classes divided by weights to as nearly as possible have equal numbers of steers in each class. Purebred classes will be broken into two weight classes if more than seven steers are shown in a breed.
Show Order	c. The show will begin with purebred classes in the order listed below, followed by market heifer, followed by crossbred classes.
Purebred Class Requirements	d. At least four purebred steers of one breed must be shown for that breed to be shown separately. Purebred classes can be comprised of both purebreds and percentage cattle recognized by their association as eligible for exhibition. If only three or fewer animals of one breed are eligible, they will be shown in the Other Purebreds class.

Small Arena

General	1. a. Junior Market Swine are subject to all <a href="#">General Rules and Regulations</a> and all Department Rules and Regulations (pages 3-6). Pigs may be barrows or gilts. Barrows must be physically castrated. All castration wounds must be healed and dry. Evidence of fresh ear notch will be reason for disqualification. All swine must go to slaughter.
Check-In and Processing	2. a. <b>Arrival Time</b> - Pigs must arrive at the weigh-in station between Friday, January 9, 2026, at 9:00 p.m. to Saturday, January 10, 2026, at 12:00 a.m. in the West Hall.
Weighing	b. Pigs will be weighed upon arrival at the weigh-in station located in the West Hall of the Farm Show Complex. Exhibitors should accompany their pigs to the scale. Read, understand, and double-check all paperwork received during weigh-in. All pigs must weigh not less than 230 pounds nor over 290 pounds in order to show or sell. No re-weighing will be permitted. Pigs not making weight will be marketed as arranged by management.
Bedding	c. All swine must be bedded with one of the following bedding materials: straw or shavings. Straw will be provided for initial bedding. Carpet will NOT be permitted.
Hair Length	d. Because this is a market show and swine processors demand it, market swine must have a minimum of 3/4 inch of hair. Hair length will be inspected at weigh-in and immediately prior to the show. Pigs with less than 3/4 inch of hair will be disqualified and marketed as arranged by management. Trimming of ears, tail, face, and underlines is permissible.
Purebred Paperwork	e. Purebred paper documentation must be presented at weigh-in with the purebred declaration occurring prior to the animal's entry to the scale. Exhibitors must have their paperwork and declaration ready when they get to the scale. Purebred registration will not be accepted after weigh-in has concluded (1:00 a.m. Saturday). By 4:00 p.m. Saturday, January 10, a posting containing only pig breed registration and weight will be made in the swine barn (no class breakdowns with this initial posting). Requests for changes based on this initial posting must be made in person at the sales office by 5:00 p.m. Saturday, January 10. Requests for changes will not be considered if proper paperwork is not presented. After this time, no registration changes will be made. Posting of final classes will occur later in the evening on Saturday, January 10.
Purebred Classes	f. In order to compete in purebred classes, market swine must be registered as recognized by their respective breed association. At least six purebred market swine of one breed must be shown for that breed to be shown separately. If only five or fewer animals of one breed are eligible, they will be shown in the Other Purebreds class.
Penning	g. Pens will be assigned by the Swine Committee. Any pigs penned in the Farm Show Complex prior to weigh-in or not penned in their assigned pen will be marked for shipment and will not be permitted to show or sell. Exhibitors are not permitted to lock their pens.

h. There will be 20 crossbred classes divided by weights to as nearly as possible have equal numbers of pigs in each class. ### SPECIAL AWARD

The National Swine Registry will offer \$500 to the Grand Champion Market Hog Overall and \$250 to the Reserve Grand Champion Market Hog Overall of the Junior Market hog show (live) at the 2025 Pennsylvania Farm Show if this animal is a registered Duroc, Hampshire, Landrace, or Yorkshire. The exhibitor must submit a photo and copy of the registration paper of the Grand Champion or Reserve Grand Champion Market Hog to: National Swine Registry, C/O Matt Claeys, 2639 Yeager Rd., West Lafayette, IN 47906, within 60 days of the conclusion of the show. This award is paid directly from the National Swine Registry.

If the Grand Champion or Reserve Grand Champion animal is disqualified for any reason, the exhibitor is not eligible for this special premium. Lambs must be identified <b>by the same 840 tag or Scrapie tag as displayed on health papers at time of weigh-in AND by the Junior Market Animal Entry Form.</b>
Sifting	2. Entries are not limited. However, if sufficient pens are not available to house Junior Market Lambs at weigh-in time, a committee will sift the Junior Market Lambs down to the number that can be housed. Those not making the sift will not show and will be sold on bid and shipped immediately by management. All must sell.
Check-In and Processing - Penning	3. a. <b>Lambs may arrive 4:00 p.m. to 9:00 p.m. Thursday, January 8, 2026, and 7am to 10am Friday, January 9, 2026. Market lamb pens will be pre-assigned by the show committee based on county entries.</b> No animals or materials may be brought into the penning area before 4 pm on Thursday. Anyone moving stall tags will be disqualified from further exhibition at the PA Farm Show. Any lamb not penned in their assigned pen will be marked for shipment and will not be able to show or sell. After penning, market lambs must remain in the assigned barn or in the immediate area outside the lamb barn. Lambs observed outside these areas will be disqualified. <b>Lambs must be slick-shorn or have 1/2-inch or less of fleece and be dry at weigh-in.</b>
Weigh-In	b. <b>Weigh-in will start at 10am, Friday, January 9, 2026, and will be dismissed by row to go to the weigh-in station. All lambs need to remain in their pens until their row is dismissed.</b> All lambs presented for check-in and weighing must be sold either through the Junior Market Animal Sale or by Farm Show Management. Only one animal may be presented and must be declared before the scale. The animal cannot be changed after it is weighed. All market lambs must weigh at least <b>90 pounds</b> . No re-weighing will be permitted. Buyback prices for heavyweight market lambs may be reduced depending on current market conditions. All underweight or disqualified lambs will not be eligible to show and will be sold by Farm Show Management. Exhibitors are responsible for care of underweight lambs until they are removed from the premises.
Breed Declare	c. The exhibitor and/or person presenting the lamb for weigh-in will declare the breed of the market lamb at time of weigh-in and a panel of classifiers will determine if the animal meets those breed requirements. If it were determined to not meet that requirement, it would be shown as a crossbred. Classification standards will follow standards of published sheep breed scorecards. At the Pennsylvania Farm Show, market lamb breeds are established <b>ONLY</b> by visual characteristics, not by the presence or absence of registration papers. Registered lambs may not be eligible for purebred classes while unregistered lambs may be classified as purebreds.
Physical Condition	d. All lambs will be mouthed and must have a full set of lamb teeth. All lambs must be docked. All castration wounds must be healed and dry.

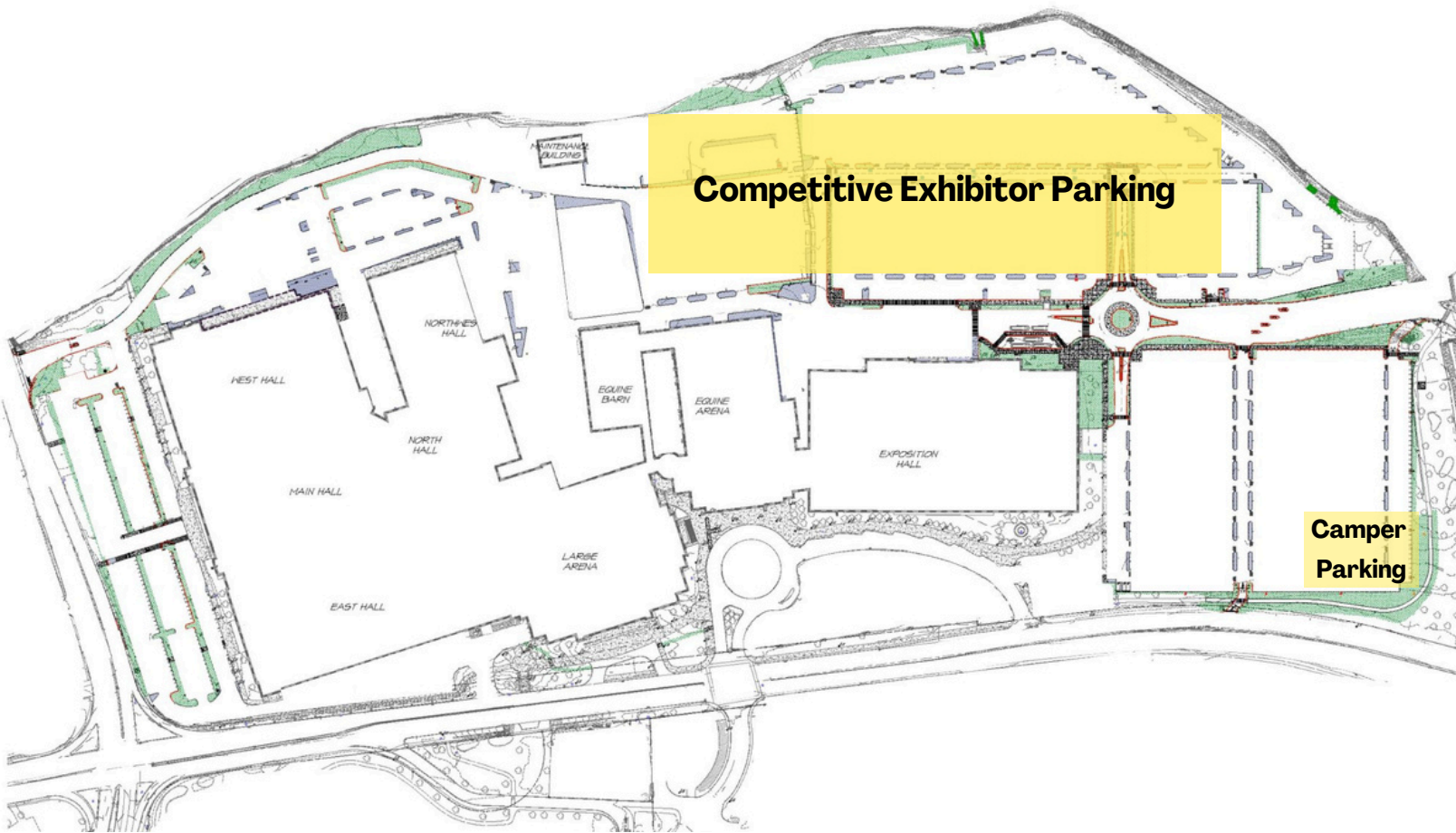

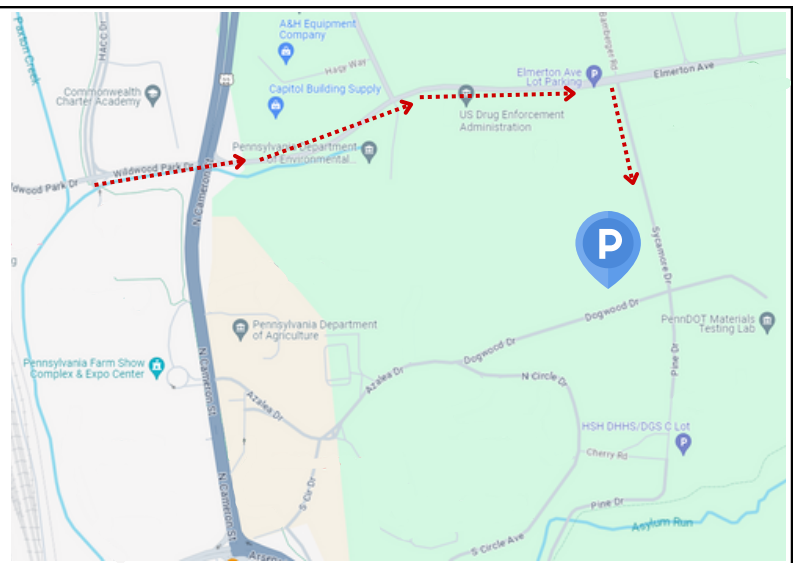

## VEHICLE PASSES

## CAMPING

Camping is discouraged, but available on a first-come, first-serve basis. Reservations are not accepted ahead of time. See Security upon arrival.

Fees include 4 parking spaces and access to electric  
Additional parking spaces \$25 per day

# FIRE REGULATIONS

1. All exit corridors and emergency exits must be kept clear; no partial blocking will be permitted.
2. All fire alarm pull stations must be kept clear.
3. Fire extinguishers may not be covered by any drapes or hidden by any type of displays.
4. No motorized camping units or vehicles may contain more than one (1) gallon of fuel while on display.
5. All pressurized fuel tanks may be drained.
6. All fuel fills must be locked and fuel caps must be taped closed with duct tape.
7. Any living trees and shrubs are acceptable as long as the shrubbery is individually bagged and baled.
8. Artificial trees and shrubbery must be treated with a flame proofing material. The fire official may request certification of flame proofing.
9. Any type of mulch materials must be treated with a flame proofing material or watered daily. If treated with a flame proofing material, certification may be requested by the fire official.
10. Smoking is prohibited in the Pennsylvania Farm Show Complex & Expo Center.
11. No open flames, fires or burning of any kind will be permitted within the Complex. No exterior burning is allowed unless the Department of Environmental Protection and the Bureau of Fire grant permission.
12. Vendors setting up tents, canopies and membrane covering must provide fire department with fire rating of material. Vendors must also provide any required portable fire extinguishers as needed.
13. Outside propane tanks shall be protected by posts or other approved physical barriers (Jersey barriers).
14. Extinguishers need to be visible, accessible and located in a conspicuous location where they will be readily accessible and immediately available for uses. These locations shall be along normal paths of travel.
15. Doors shall never be blocked or tied off.
16. The Fire Prevention Code of Harrisburg will be strictly enforced.

## EMERGENCY PREPAREDNESS TIPS

### EARLY DETECTION

- Early detection is the most effective way to prevent emergencies or lessen their impacts.
- Vendors and exhibitors will likely be the first to witness, experience, or report incidents.
- You can be the difference in preventing something harmful from happening.
- To report any type of threat or emergency incident, notify the PA State Police Command Post.

### BOMB THREATS

- Threats can be made in person, by phone, or in written message.
- Collect as much detailed information as possible about the threat (when, why, how, exact wording of threat, type of voice, personal appearance, clothing description, name, gender, phone number, physical address).
- It is especially important to know the perpetrator's timeline for activation of the device (when will it occur?).
- Immediately report the threat to the State Police Command Post.
- Authorities will investigate the threat and make the proper decisions accordingly in coordination with facility management.

### LOST CHILDREN

- Be sure to get the full name of the lost child and keep them safe with you. Notify the Farm Show security desk or closest security/law enforcement team. PSP or Farm Show staff will help to reunite lost children with loved ones.

### SHELTER IN PLACE

- Although rare, there could be incidents that occur outside the facility that could put people at risk (chemical fire, very severe weather). In these instances, a shelter-in-place plan will be implemented for the welfare of all occupants.

### SUSPICIOUS OBJECT

- Do not touch or disturb the object.
- Maintain a safe distance from the object and attempt to isolate the area.
- Notify the State Police Command Post with a description and location of the object.

### SUSPICIOUS PERSON

- Observe the circumstances and behavior of the suspicious activity.
- Notify the State Police Command Post and provide as much detail as possible.
- Details about the person should include direction of travel, appearance, height and weight, build, clothing, speech, and anything about the behavior that indicates suspicion.

## FLOODING

- Facility management will attempt to mitigate the effects of flooding and natural disasters before they happen and will work with all show vendors during this type of event.
- The Maclay and West parking lots are susceptible to flash flooding.
- Avoid contact with flood water.
- If major interstates or surrounding roads are being closed, facility management will make announcements accordingly.

## MEDICAL EMERGENCY

- Notify the State Police Command Post and they will dispatch emergency medical services to the location.
- Describe the nature and severity of the medical incident and location of the victim.
- Do not attempt to move the person unless you are a trained medical responder.
- Stay with the victim and seek help from others if necessary.
- If rendering aid due to your training, be careful not to expose yourself to hazards such as fire, electricity, hazardous materials, or blood borne pathogens

## FIRE & EVACUATION

- If you see a fire, activate the nearest alarm or notify the Farm Show Security Desk.
- The City of Harrisburg Bureau of Fire will respond to the alarm.
- When the building evacuation alarm is activated, leave by the closest and safest exit and alert others to do the same.
- Quickly take all personal belongings.
- Please listen to the instructions of the PA system announcements, Farm Show Complex employees, or responders.
- Do not use elevators!
- The facility is equipped with sprinklers and ABC fire extinguishers.
- Once outside, move a safe distance from the building.
- Do not return to an evacuated building until the 'all-clear' sign is provided by the Fire Chief, a Police Officer, or any other official first responder.
- Do not operate cell phones during an evacuation until the 'all-clear' is given

## VIOLENT BEHAVIOR

- Your safety comes first. Use your best judgement to preserve your life.
- Report any physical abuse to the State Police Command Post.
- If there's an active shooter in the facility but not in your area, evacuate the facility and find safety.
- If the active shooter is near your area and preventing your escape, go to a room that can be lock or barricaded or hide and remain silent.
- If the shooter knows you are there but you feel you can flee, quickly evacuate the area.
- If you feel like fleeing is not possible, you can either confront, or attempt to overpower the person.
- If there is a shooter, messages regarding the known location of that person may be broadcast over the PA System.
