The application shall be submitted at least thirty (30) days prior to the requested date of the inspection. The annual inspection shall be conducted prior to the first commercial use of the boat.</p> <p>Forward an additional copy of this form to the Pennsylvania Fish and Boat Commission, Bureau of Boating, P.O.
