REPORTS

Dr. Finello took roll call. Deputy Secretary Patel introduced the topic for the meeting, which was criminal justice and behavioral health care within the system. Deputy Secretary Patel explained that the meeting would focus on understanding behavioral health services for individuals in the criminal justice system, including juvenile and adult populations. She hoped the presentations would provide an understanding into what's currently happening with efforts across Pennsylvania and would show how behavioral health care is provided within correctional and juvenile facilities, address forensic behavioral health needs, and talk about challenges in integrating care for individuals transitioning back into the community.
