### **FDA Safety Communication Anti-Choking Devices**

On November 13<sup>th</sup>, The U.S. Food and Drug Administration (FDA) updated the Safety Communication which encourages the public to follow established choking rescue protocols during choking emergencies. The update includes information on actions the FDA has taken to address the marketing of unauthorized anti-choking devices, including issuing Warning Letters and an Important Alert.

### Practice Spotlight - Health Room Staffing Roles

Our Division of School Health is often asked about the regulations and roles that guide health room staff. To make information easier to locate, we have put together quick-reference tables outlining law, regulations and key points.

#### Certified School Nurse (CSN) Overview

Section	Citation	Key Points
<b>State Board of Nursing</b>	<a href="#">49 Pa. Code Chapter 21, Subchapter A, §21.11</a>	Defines general functions of Registered Nurses, includes; (d) The Board recognizes standards of practice and professional codes of behavior, as developed by appropriate nursing associations, as the criteria for assuring safe and effective practice.
<b>School Health Regulations</b>	<a href="#">28 Pa. Code Chapter 23, §23.34</a>	Duties assigned by school district/joint school board which are exclusively connected with medical and dental school health activities; technical content prescribed by Dept. of Health.
<b>Duties of School Nurses</b>	<a href="#">28 Pa. Code Chapter 23, §§23.71–23.79</a>	Assist in health program/exams; maintain records; advise pupils/teachers/parents; interpret health needs; provide info; plan for environmental needs; assist in budget prep; coordinate with community programs; provide first aid.
<b>Certification Guidelines</b>	<a href="#">CSPG 80 – School Nurse</a> (rev. 3/1/2025)	Only RNs certified by Dept. of Ed as “Education Specialist” may use title CSN. If an RN has an emergency permit from the Dept. of Education they may function and perform the day-to-day duties of a CSN (carry a caseload, etc.) however, may not use the initials CSN.
<b>Public School Code</b>	<a href="#">1949 Act 14, Chapter 14, §1411</a> (amended 1963)	Defines “school nurse” as licensed RN certificated by Superintendent of Public Instruction; employed by district, joint school board, or contracted health unit.

Role	Citation	Functions	Supervision
<b>Registered Nurse (RN)</b>	<a href="#">49 Pa. Code Chapter 21, Subchapter A, §21.11</a>	<ul style="list-style-type: none"> <li>Meet daily student needs; follow care plans; assist with mandated screens/exams; consult with CSN; function within RN scope.</li> </ul>	Works under CSN direction but under own license.
<b>Licensed Practical Nurse (LPN)</b>	<a href="#">49 Pa. Code Chapter 21, Subchapter B, §21.145</a>	<ul style="list-style-type: none"> <li>Meet the daily health needs of students, follow plans of care, assist with completion of mandated screens/exams, consult with CSN, and function within their scope of practice.</li> <li>Could be a substitute for another LPN.</li> <li>Could be a substitute for an RN <u>when the medical needs of the students can be met under an LPN license</u>.</li> <li>An LPN can <u>NOT</u> be a substitute for a CSN.</li> </ul>	Works under CSN direction but under own license.

Role	Citation	Functions	Supervision
<b>Agency Nurse (RN/LPN)</b>	Division of School Health guidance	<ul style="list-style-type: none"> <li>Prior to agency personnel caring for students in schools, the Division of School Health recommends all appropriate school personnel, certified school nurses (CSNs), agency personnel, parents, and physician, develop a plan of care (504/IEP) that would include how care/treatment will be provided to students with agency nurses at all times while the student is under school jurisdiction.</li> <li>Should report care/changes/refusals to CSN daily. Nurses are responsible for functioning within their scope and standards of practice.</li> </ul>	Agency nurses have their own orders; CSN should also maintain orders in case agency staff unavailable.
<b>Unlicensed Assistive Personnel/Paraprofessional</b>	<a href="#">CSPG 101 – Utilization of Paraprofessional Staff</a> (rev. 3/21/25)	<ul style="list-style-type: none"> <li>Cannot be directed to engage in health-related activities reserved exclusively for certified school nurses.</li> <li><b>Personal care assistants (special education)</b>-provide one-to-one support and assistance to a student, including support and assistance in use of medical equipment (e.g. augmentative communication devices; activities of daily living; and monitoring health and behavior).</li> </ul>	Works under direction of certificated staff member
