CALL TO ORDER Chairman Holden

Pledge of Allegiance to the Flag

Board Secretary John K. Stark indicated that a quorum of the Board was present and Chairman Holden called the meeting to order.

PUBLIC COMMENT ON AGENDA ITEMS

The Board has reserved 10 minutes for Public Comment on printed agenda items.

Caller James Declanio of Washington, PA described himself as a "Bourbon Hunter" who probably frustrates store employees because, although he is looking for bourbon and trying to be polite, he has found that there are always a few select individuals who always know what products are going to stores and when. He stated that he has spoken with a few of these individuals, who have told him that they have friends working at Fine Wine & Good Spirits who tell them warehouse inventory and delivery schedules. Mr. Declanio noted his understanding that the PLCB wants to make distribution fair, but opines that the current store distribution only benefits "career bourbon hunters" who have personal friends working for Fine Wine & Good Spirits. He asked if the PLCB has any plans either to make this delivery information public or to restrict this information from employees so that underground groups with insider information are not securing most of the allocated bottles?

Chairman Holden replied that he is unaware of any insider information being distributed, noting that it is the goal of the PLCB to make sure our products are distributed fairly and that no one has an advantage. Chairman Holden then requested Executive Director Michael Demko and Chief Counsel Rodrigo Diaz to elaborate on how the PLCB tries to make the process as fair as possible.

Chief Counsel Diaz noted that if someone has such information, they ought not to be providing it in the manner described by Mr. Declanio, and he asked to speak with Mr. Declanio after the meeting to get more information and find out what is going on. Chief Counsel Diaz emphasized that the PLCB has taken steps to be fair, such as having "Third Wednesdays" to put the product out there so everyone gets a chance. This is also why we put a limit on how much a person can purchase. We also limit some items to PA residents. If there is a problem, Chief Counsel Diaz wants to know about it.

Executive Director Michael Demko also requested that Mr. Declanio contact the Legal department as that is not how the PLCB operates and if information is being "leaked out," we want to be aware and take care of it. He noted also that the PLCB has put more bourbon on our e-commerce website to enable serving all of Pennsylvania and not just certain stores. Mr. Demko stressed that any information provided will be put investigated and urged Mr. Declanio to contact Chief Counsel Diaz. Chief Counsel Diaz provided his email address for direct contact.

Mr. Declanio expressed his appreciation for steps the PLCB has taken to improve distribution, noting that it has definitely gotten a lot better. He wanted to recognize the efforts of the PLCB in this regard and indicated that he will contact Chief Counsel Diaz as requested.

 Kelbud, Inc. t/a Kelly's Inn 1906 N. Sherman Street York, PA 17402 Restaurant Liquor License No. R-10535 LID 14431 Appeal from the Adjudication and Order of Administrative Law Judge.

At Board Member Negra's request, Chief Counsel Diaz provided the following background on this matter: a citation was issued against the Licensee because, in June of 2020, Licensee had allowed various individuals to consume food and alcohol on the licensed premises during the time that the COVID emergency declaration had been issued. More specifically, this was during the time when the Governor's Order and our Advisory Notice had indicated that no on-premise consumption of food and alcohol was permitted. The establishment was not open at the time, however, some distributor employees were there doing work and also some employees of the licensee. They were observed drinking on the premises by a police officer.

Based on these admitted facts, the ALJ sustained the citation. The licensee took an appeal to the PLCB, raising various issues but essentially arguing that Licensee did not serve these individuals, rather, they served themselves. Licensee also argued that they were not open for business and that what was precluded by the Order and the Advisory Notice was the sale, not the consumption, of alcohol.

Chief Counsel Diaz noted that these same arguments had been raised before the ALJ; however, the ALJ correctly pointed out that if one reads Advisory Notice # 26 in its entirety and looks at the Governor's Order, clearly there was to be no on-premise sale or consumption at that time. Chief Counsel advised that the ALJ was correct as to the law and the facts are not in dispute, so his recommendation would be to sustain the citation.

- (1) Office of Administration HR Shared Services Billing of \$515,575 for the FY 2021-22 Q2 billing for OA's HR-Enterprise Services (labor relations, employee benefits, training, etc). The LCB's charge represents 2.4% of the total \$21.9M OA- HR Shared Services billing. The billing includes a true-up of \$56,875 for the FY 2021-22 Q1 estimated billing of \$401,825.
- (2) Department of Auditor General FY 2021-22 first quarter net billing of \$670,957.50 from the Department of the Auditor General. The billing includes a credit adjustment of \$10,925.40 for an over-charge on the estimated FY 2020-21 Q4 billing. The charge for FY 2021-22 Q1 services is \$681,882.90 and is \$9,642 (+1.4%) more than last year's billing and is based on actual audit hours for July, August and September, which were down 5.0% from last year's Q1 billing.

OTHER ISSUES

Board Member Negra raised his concern with the Governor's recently announced incentive of five additional days of leave or a lump sum payout to state employees as an incentive for providing proof of vaccination against COVID-19.

Board Member Negra is concerned about the estimated cost of \$6,000,000 to the PLCB. It is his understanding that it doesn't matter when a person was vaccinated that makes them eligible. Supposedly, only 38% of Commonwealth employees have registered their vaccination status online, but that doesn't mean only 38% of Commonwealth employees have been vaccinated. Over 80% of adults in PA have received at least 1 shot according to the Governor's office and that was in August. Thus, this bonus/incentive is more of a bonus than an incentive. We've been trying to figure out a bonus system for our store employees based on performance for years and we were always told the Commonwealth doesn't allow bonuses. Now, that seems to be okay.

Member Negra said the idea that this \$6,000,000 will be covered by our budget is absurd unless there is a directive to not cover the shift of someone taking 5 days off in the stores and thus diminish customer service. But what if the lump sum option is taken? How does our current budget cover that? Is the directive for our staff to reduce expenses in the same amount as paid out? This bonus plan will be costly to the PLCB and to the Commonwealth. Incentives haven't worked around the country to change people's minds, so why would this be any different? He stated, is the percentage goal 100% vaccination status? What happens when we reach the goal and will the mask mandate currently in place on Commonwealth employees, including those in our stores, go away? As an independent agency we can and should refuse to direct our resources in this manner and instead utilize those resources in a more productive way for the long-term welfare of our employees and customers.

Board Member Negra then made a motion to not institute the bonus/incentive plan suggested by the Governor and instead to follow the lead of the Auditor General's office, the Office of the Treasurer, and other agencies that have decided it is not the best use of Commonwealth funds.

Chairman Holden stated that he believes the Governor should be commended for implementing this incentive program for employees, giving them the opportunity to get vaccinated. However, he first wanted to recognize the parliamentary process that the Board is involved in with these public meetings. He asked Chief Counsel Diaz for a summary of his conversations on the topic with the Office of General Counsel and the Governor's Office.

Chief Counsel Diaz stated that he did reach out to the Office of General Counsel to get a better sense of what the Office of Administration was indicating. They are indicating something more akin to administrative leave and not vacation time or the like. Chief Counsel Diaz explained that while the Liquor Control Board is not an agency under the Governor's jurisdiction, we are an executive agency under the authority of the Office of Administration, which has the right to establish administrative leave if they want to and the PLCB must comply with any rules or procedures issued by that office.

Chief Counsel Diaz explained that there are agencies such as the Office of the Attorney General, Auditor General, and Office of the Treasurer over which the Secretary of Administration has no authority because those agencies have elected heads. It is Chief Counsel's opinion that the Board is subject to this rule and, while the Board is welcome to have a conversation about the merits, the Board does not have the authority to vote against this incentive. Chairman Holden stated that he strongly disagrees with Board Member Negra's position, but noted that even if he and Board Member Isenhour did agree with Board Member Negra, that would be irrelevant as the PLCB is subject to the authority of the Secretary of Administration on this matter.

Chairman Holden wanted to thank and commend the Governor for what he has done, noting that the PLCB's employee vaccination rate is only around 32% as of November 9th, and he opined that it is the Board's responsibility during this public health crisis to do anything that can be done to give employees an incentive to get vaccinated, not only to protect state employees, but customers of the PLCB's retail stores and those who enter the Northwest Office Building as well.

For these reasons, based on guidance from Chief Counsel Diaz, Chairman Holden stated there would not be a vote.

Board Member Isenhour noted that while she respects Board Member Negra's position on the matter, she vehemently disagrees with it. If there were a vote on the pending motion, she would not second it and she further requested it be noted she would have been a "no" vote on the motion if there had been a second. Board Member Isenhour stated that she echoed everything that Chairman Holden had said about public health and safety. Furthermore, she noted that PLCB employees are employees of the Commonwealth who should be treated in the same way that other employees of the Commonwealth are being treated in this matter.

Board Member Negra noted that the Board had gotten some flak for not taking a formal vote on closing the stores in March of 2020, even though if all three Board members had voted not to close the stores, the stores would still have been closed because that was the directive that was coming from the Governor's Office. He stated he was taking the approach with his motion that the Board would be taking a symbolic vote by putting their votes on the record and he asked Chief Counsel Diaz for his opinion regarding taking a symbolic vote on this issue.

Chief Counsel Diaz agreed that sometimes symbolic votes are taken, such as voting to approve conveying certain monies that, by statute, must be transferred somewhere else. However, he advised against doing so in this situation because it suggests that if the Board voted against it, the administrative leave would not be available, which is simply inaccurate. The administrative leave is available.

Additionally, regarding the example of the store closings as noted by Board Member Negra, Chief Counsel Diaz noted that the concern expressed at that time by elected officials was that there were no public comments about it and the public did not know what was going on. Here, by virtue of this conversation, the Board is hereby making the public aware that the PLCB is subject to this incentive program and the Board members have each expressed their opinions on the issue. Under the emergency order, the Governor had the express authority to close the stores and the only vote this Board would have taken would have been whether to sue the Governor, which was not going to happen.

Finally, Chief Counsel Diaz noted that by virtue of this conversation on the record, the public now knows where each Board member stands on the issue and where the agency is going to be on the issue, as the PLCB's authority is not as much as the Treasurer's and not as much as the Attorney General or the Auditor General.

The next meeting of the PLCB will be a formal meeting on Wednesday, December 1, 2021 beginning at 11:00 A.M. Prior to the public meeting, there will be an Executive Session to discuss matters of personnel and to engage in non-deliberative informational discussions, some of which are regarding actions and matters which have been approved at previous public meetings.

ADJOURNMENT

On a motion by Board Member Negra, seconded by Board Member Isenhour, the meeting was adjourned.
