# **Volunteer Tax Credit Incentive Program Report**

**November 1, 2022 – March 31, 2026**

## Executive Summary:

The purpose of this report is to provide a summary of the information regarding the Volunteer Tax Credit Incentive program which has been submitted through the electronic reporting system maintained within the Office of the State Fire Commissioner (OSFC).

This program was established under Act 172 of 2016 and expanded under Act 91 of 2020 providing municipalities, school districts and counties the option to offer a real estate or/and an earned income tax credit to active members of volunteer fire companies and emergency medical service agencies.

Since the implementation of the reporting system in November of 2022, there may be some municipalities that have not submitted information at the time of this report. The information contained in this report reflects the reporting period of November 1, 2022, through March 31, 2026, and is solely based on the information that has been entered into the electronic reporting system, and therefore may *not* be an all-inclusive list.

## Current Reporting Information:

### Municipalities reporting

A total of 83 municipalities comprising of 53 Townships, 21 Boroughs, 5 counties, and 4 School Districts within 28 counties have reported as of March 31, 2026.
