Domestic violence incidents remain a leading threat to the safety of victims, law enforcement officers, and communities. This workshop explores public-safety-focused collaboration between domestic violence centers, courts, and law enforcement to reduce lethality, improve outcomes, and enhance officer safety. Participants will learn how evidence-based risk assessment tools, judicial strategies, and multi-agency coordination can prevent escalation and support survivors, law-enforcement officers, and the community.

Act 79 Implementation: Why is There Such Variance Among Commonwealth Counties?*

Johns Hopkins University reports that almost 50% of women murdered in the US are killed by a current or former intimate partner. Of these homicides, more than half are by firearms. In October 2018, Pennsylvania Governor Wolf signed Act 79 into law - a law that requires judges to order a defendant to relinquish their firearms, other weapons, and ammunition following a final protection from abuse order. A previous quantitative study conducted by Indiana University of Pennsylvania found wide variance in the implementation of Act 79 across Pennsylvania counties. Through a grant funded by PCCD, researchers from Temple University's College of Public Health are currently conducting a new study to evaluate differences in the county-level implementation of Act 79 in Pennsylvania. In addition to discussing the study's design, commentary from participants will be elicited regarding preliminary findings and trends.

Across Pennsylvania, counties are transforming reentry, recovery, and overdose prevention through the power of lived experience. Supported by the Bureau of Justice Assistance's COSSUP Program, this session spotlights county initiatives in Allegheny, Fulton, and York where Certified Recovery Specialists provide critical support as people transition from incarceration back to their communities. Presenters will share how embedding peers in settings like jails and Public Defender's offices builds trust, engagement, and meaningful recovery and reentry connections.

A standardized, evidence-informed intake process leads this transformation by employing structured decision-making tools that empower system professionals to make consistent, effective, and equitable decisions for system-involved youth. This session will explore how this approach connects system partners for effective collaboration. Attendees will learn about its practical application, its impact on youth outcomes, and strategies for sustaining collaboration that drives continuous systemic improvements.

With practical strategies and real examples from a Pennsylvania county that has successfully aligned its goals, streamlined efforts, and connected the dots across initiatives, participants will discover how to reduce redundancy, strengthen collaboration, and improve outcomes.

During this session, Women's Center and Shelter of Greater Pittsburgh's Firearms Safety Team will discuss their new approach to firearms safety awareness related to intimate partner violence. Their work is grounded in the Lethality Assessment Program as well as Protection from Abuse Weapons Relinquishment Orders. This presentation will also include an open discussion format with attendees in the hope of continuing to gather and share information to support intimate partner violence safety needs and their potential impacts on our communities.

Across the U.S., 3.7 million Americans are on community supervision-twice the size of the prison population-and 51% of people on probation lack full-time employment, even as employers face persistent labor shortages. REFORM's Work Matters Initiative addresses this gap through a systems-level approach that aligns county workforce and probation agencies with the skilled trades industry. This session will highlight how the Work Matters pilot was designed and launched in Pennsylvania and Virginia, examine the roles of key ecosystem partners, and share lessons learned to support replication and scale nationwide. Attendees will leave with practical employment-service best practices for engaging and supporting individuals on supervision, as well as insights on building cross-system partnerships that meet employer demand.

Expanding the Frame: Advancing Intersectional Approaches to Community Violence Intervention*

Dr. Sylvia C. Washington is a public health researcher and advocate whose work centers the experiences, leadership, and resilience of Black women and girls. In this keynote, she challenges us to expand our understanding of Gun Violence Prevention (GVP) not just as a matter of policy, but as a public health imperative rooted in equity, prevention, and collective care.

Community Violence Intervention (CVI), a key strategy within GVP, has proven effective when it is trauma-informed, community-driven, and sustainably funded. Programs that invest in credible messengers and support wraparound services have helped reduce shootings and build trust in communities most affected by violence. But for CVI and GVP strategies to fully live up to their promise, they must also be intersectional, recognizing and responding to the unique ways violence affects Black women, girls, and LGBTQ+ individuals.

Dr. Washington offers an urgent and hopeful call to action. By applying a public health lens grounded in intersectionality, she urges researchers, practitioners, and policymakers to expand who is seen, heard, and included in the work of violence prevention and to build systems that reflect the full humanity of every community member.

Missing Persons: Reentry, and the Aftermath of Incarceration*

The Missing Persons keynote address reframes reentry by naming what is consistently left out of public health, justice, and service-provider conversations: the lasting psychological and neurological impact of incarceration itself.

Drawing from lived experience, documentary storytelling, and emerging research, EL Sawyer will outline how social isolation, chronic stress, loss of agency, and institutional trauma fundamentally reshape behavior, identity, and decision-making, long after a person returns home. The talk challenges the assumption that people coming home from prison can simply “pick up where they left off,” and instead asks what reentry looks like when we acknowledge the full human cost of incarceration.

This keynote invites practitioners, service providers, funders, and community members to rethink reentry not as a compliance problem, but as a trauma/neuro-informed public health issue, and to consider how systems might respond differently if they truly understood what has been missing all along.

This team-based approach has been proven to identify risks earlier, reduce trauma, build stronger cases, strengthen health and recovery outcomes and enhance survivors' trust in the system.

This session examines PCCD's investment in the development of a hospital-based violence intervention program (HVIP) within one of the state's busiest trauma centers during a period of historic gun violence. It explores how sustained investment and community-based victim services strengthened responses to gun violence in a city that has since seen drastic reductions in violent injury. The focus is on practice, partnership, and how early, values-driven decisions laid the groundwork for continued innovation and expansion.

Founded in 2023, the MOUD Unity Recovery Peer Re-Entry Program at the Allegheny County Jail is a pioneering program that provides peer-led support services within the criminal justice system for individuals with substance use disorders (SUDs). This presentation will examine creative approaches employed within this program to engage participants, enhance recovery capital, and decrease recidivism, giving special emphasis to the roles of peer support in promoting recovery and a successful reintegration with the community. This workshop will also discuss the financial impact of peer-run services, as well as how this model serves community public health and safety by preventing re-arrest.

Veteran Services within the PA DOC

The Pennsylvania Department of Corrections proudly employs approximately 5,000 veterans. Additionally, the agency houses approximately 2,300 veteran reentrants. Over the past five years, DOC leadership has invested in a Veteran Services Team to connect veteran staff and inmates with the services, benefits, and information they need in order to receive the care warranted to them. Currently, the PA DOC has five specialized veteran service units housing more than 600 inmates and a dedicated veteran services team of seven employees working to ensure all veterans, staff and inmate alike, are not forgotten.
