## **Overview**

The Pennsylvania Department of Agriculture Act 225 of 1982, as amended by Act 119 of 2008; charged the department with enforcing the commonwealth's Dog Law.

The department's Dog Law Enforcement Office is now the Bureau of Dog Law Enforcement to properly reflect its charge under the authorizing legislation, and to more properly align with the department's organizational structure. This name change has no impact on the bureau's mission and goals.

The bureau enforces regulations, including licensing of individual dogs, licensing and inspection of kennels, activities related to dogs that are found running at large or classified as dangerous, and processing claims for livestock damage caused by dogs and coyotes.

As required by Section 906 of the Dog Law, this report to the General Assembly provides:

## **Dog Licenses**

Pennsylvania dog licenses are sold to dog owners by county treasurers. Revenues from the sale of annual and lifetime licenses are directed to the Dog Law Restricted Account. In accordance with the Dog Law, Philadelphia County and the cities of Altoona, Erie, Harrisburg, Pittsburgh, and Scranton administer their own dog license sales, retain all income and information generated and do not report dog licensing sales income to the department (reference Appendix J for Section 1201 of the Dog Law which addresses enforcement by independent political subdivisions). This report does not include sales or revenue generated within those cities.

In 2014, there were 978,384 individual dog licenses sold, including 931,909 annual and 46,475 lifetime licenses, generating \$6,150,400 in revenue (Appendix C).

License sales increased by 1.2% from calendar year 2013 to 2014.

## **Kennel Licenses**

The bureau licensed 2,218 kennels in Pennsylvania in 2014, garnering \$404,075 in license fees directed to the bureau's restricted account (Appendix D).

## **Out-of-State Dealers**

In 2014, 115 out-of-state dealers were licensed, generating \$14,475 in revenue for the restricted account (Appendix E).

## **Dog Law Inspections**

A total of 4,716 kennel inspections were completed in 2014 (Appendix F). All kennels were inspected twice as required by the Pennsylvania Dog Law.

## **Enforcement Activities**

The bureau refused six (6) kennel license applications and revoked three (3) kennel licenses in 2014.

Fifty-eight individuals were cited for operating a kennel without a license and 1,869 citations were issued to owners who failed to license their dog(s) in 2014.

In 2014, the bureau collected \$20,100 through administrative actions (settlements and civil penalties).

In 2014, the bureau collected \$55,424 in Dangerous Dog registration fees.

## **Citation Issuance**

In 2014, 4,303 summary citations and 71 misdemeanor complaints were issued for kennel and other various violations of the Dog Law, including but not limited to failure to license, dogs running at large or abandoned, and dangerous dogs (Appendix H).

## **Dogs Seized and Impounded and Total Reimbursements**

The bureau plays a critical role in managing stray dogs by assisting with humanely capturing and transporting dogs to shelters. Additionally, in 2014, shelters and municipalities received payments from the restricted account for reimbursement of costs related to transportation, feeding, and care of stray dogs. A total of \$302,440 was paid for 7,561 dogs statewide (Appendix I).

The bureau has continued to offer and pay \$40 per dog for holding and disposing to all licensed kennels approved by the Secretary of Agriculture to accept stray dogs. Currently 147 licensed kennels receive holding and disposing payments from the bureau.

## **Payments Made from the Dog Law Restricted Account**

All revenue and expenses related to the bureau are credited and disbursed from the Dog Law Restricted Account, as required by Section 1001 of the Dog Law.

## Licensing Fees

The primary source of revenue for the Dog Law Restricted Account is the sale of individual dog licenses. This is supplemented by kennel licenses and fines that are capped at approximately \$70,000 annually. For 2014, approximately \$6.15 million was generated by the sale of individual dog licenses.

## Accomplishments

The focus of the bureau in 2014 was to continue to restore the solvency of the Dog Law Restricted Account through advances and ongoing initiatives in:

### Operations:

- The bureau continues to maintain and update the standard operating procedure manual which outlines procedures for the day-to-day operations of field staff.
- Hired a second kennel compliance specialist and a full-time veterinarian to improve operations. To date, there are 53 wardens including kennel compliance specialists, seven supervisors, and one veterinarian.
- The bureau continues to utilize internal focus groups to improve operations. Focus groups have been developed to evaluate and create a training curriculum for all field staff, as well as evaluating safety needs as part of the safety initiative.

### Training:

- Wardens received training on citation writing, mock scenarios and trials, interviewing witnesses, preparing and questioning witnesses in court, case law, and handling sovereign citizens.
- The bureau sponsored several trainings across the state specifically designed for educating state and local police on the Dog Law.
- The bureau created a comprehensive police packet to be used as a guide for police when handling a dog law complaint.
- A quick reference sheet was created for 911 call centers to help dispatchers be able to direct callers to the correct agency with ease (police, dog law, humane society).
- The bureau provided dog safety and bite prevention trainings to Postal Workers.

### Marketing and Public Relations:

- Emphasis remains on dog license sales, including a dog owner education campaign that included press releases, news articles, op-ed pieces, public service announcements, vehicle magnets, signs, brochures, a poster contest, billboards, and displays for use at fairs, events, and public appearances.


- Dog wardens played a vital part in communicating the dog licensing message through public education at the Pennsylvania Farm Show, Penn State's Ag Progress Days, National Night Out, and many local events throughout the state.
- To help dog owners understand Pennsylvania's dog laws, particularly those related to licensing, the bureau created [www.licenseyourdogPA.com](http://www.licenseyourdogPA.com), which also hosts an online treasurer tool kit with a sample press release, op-ed, posters, and speaking points.
- Social media outreach promotes the sale of licenses and educates consumers about the importance of licensing dogs.
- March is Dog License Awareness Month. April through December are license enforcement months.

**Partnerships:**

- The bureau continues to work closely and foster relationships with county treasurers, legislators, township supervisors, Pennsylvania Veterinary Medical Association, United States Postal Service, Department of Education, and shelters to bring awareness to the importance of dog licensing.
- Developing relationships with USDA counterparts to support one another's efforts as they relate to kennel operations.

Looking ahead to 2015, the bureau remains focused on restoring financial solvency to the Dog Law Restricted Account. The bureau must continue its regulatory duties to enforce the Dog Law and increase sales of dog licenses to meet this goal.

## **Appendix J – Section 1201 of the Dog Law**

### **Addressing Enforcement by Independent Political Subdivisions**

#### **ARTICLE XII**

##### **MISCELLANEOUS PROVISIONS**

Section 1201. Applicability to cities of the first class, second class, second class A and third class.

(a) Cities of the first class, second class and second class A.--Insofar as this act provides for the individual licensing of dogs and the payment of damages for domestic animals injured by dogs or for licensed dogs illegally killed, it shall not apply to cities of the first class, second class and second class A. Such individual dog licensing and payment of damages in cities of the first class, second class and second class A shall continue to be carried on under the provisions of existing laws.

(b) Cities of the third class.--Insofar as this act provides for the individual licensing of dogs by the department, the payment of damages by the department for domestic animals injured by dogs or for licensed dogs illegally killed and for the performance of duties and functions of dog law enforcement by the department under Articles I and II, except sections 206, 207, 209, 211 and 218 as it pertains to kennel inspections; Article III, except section 301; Articles V through IX; this article; Articles XI and XII, the foregoing responsibilities shall not apply to the department within a city of the third class that does both of the following:

(1) Adopts its own dog licensing ordinance establishing individual dog licensure on a calendar year basis or on another basis consistent with that in use by the department.

(2) Notifies the secretary, in writing, of its intention to assume responsibility for enforcement of its dog licensing ordinance under authority of this section for a period commencing January 1 of a particular year and not ending prior to December 31 of the year in which the city of the third class terminates its responsibility for enforcement. If the department changes dog licensure from a calendar year basis to some other basis by regulation promulgated under authority of section 201, it may modify the requirement set forth in this paragraph to provide for the efficient and equitable transfer of dog law enforcement responsibility and appropriate dog license fees from the city of the third class to the department.
