You can purchase your dog's license from your local County Treasurer.



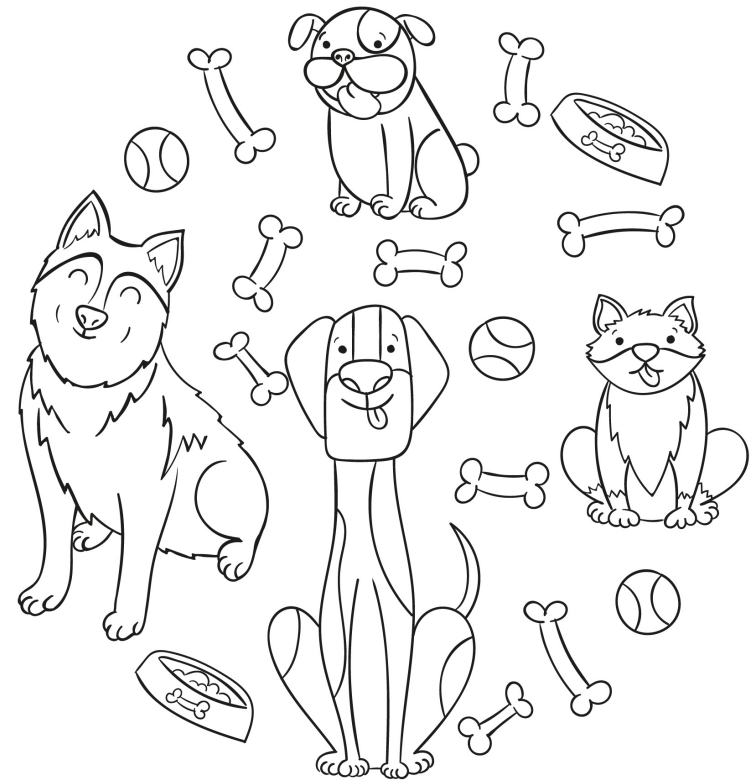
The Pennsylvania state dog is a Great Dane.

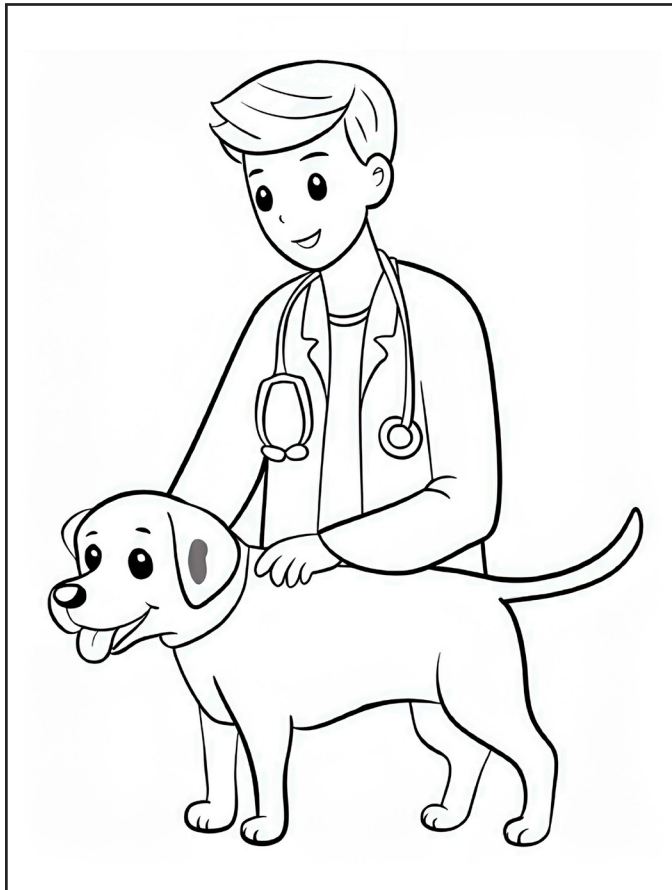

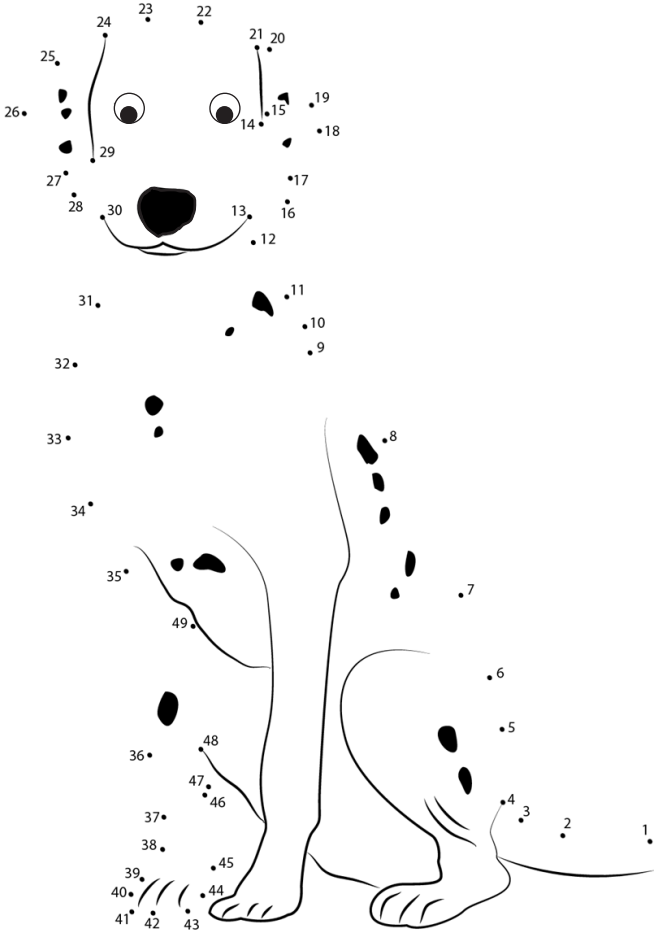
By January 1, all dogs over eight weeks of age are required to have a current dog license and rabies vaccination administered by a licensed veterinarian.

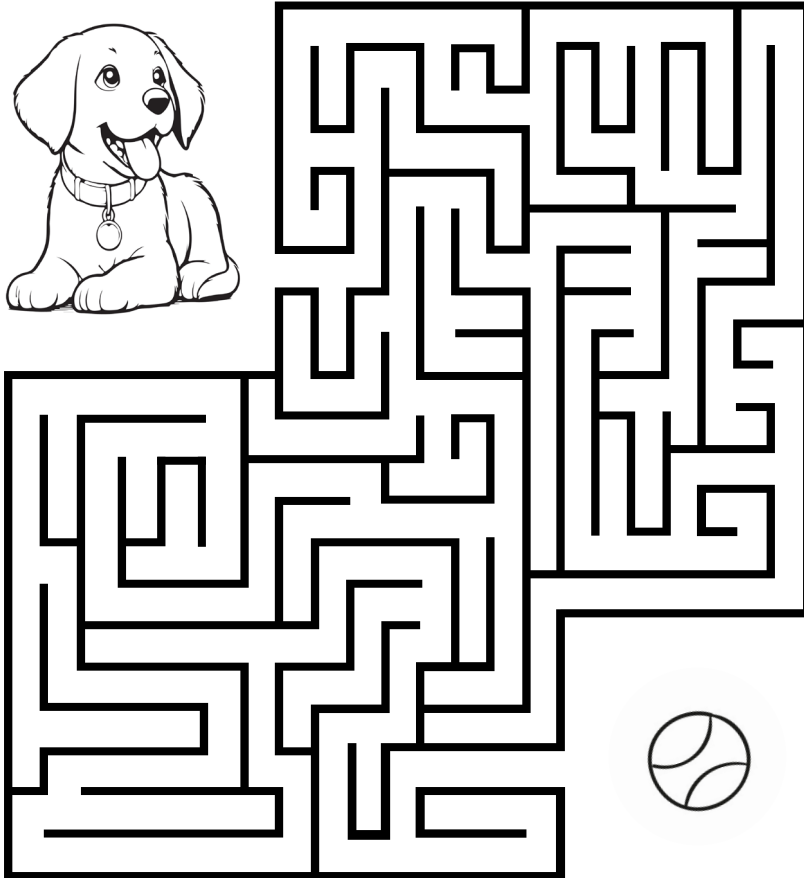
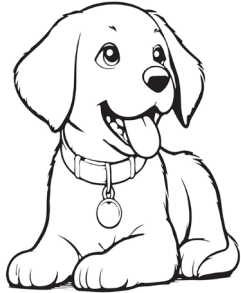
