


DID YOU KNOW?

If your dog gets lost, a license makes it more likely you'll be reunited. It's not only a smart thing to do, it's also the law.






By January 1, all dogs over eight weeks of age are required to have a current dog license and rabies vaccination administered by a licensed veterinarian.


