I further agree to accept the decision of the Racing Officials as final on any matter relating thereto, or to a race or racing. My signature acknowledges that I will comply with drug/alcohol testing when requested by the Commission.

I hereby certify that I have read the foregoing application and that every statement contained therein is true and correct set forth, and I do hereby agree as a condition precedent to the receiving of said license that the same may at any time be revoked, canceled, temporarily suspended or within by said The State Horse Race Commission for cause, and said license may be revoked at any time for misstatements or omissions in the foregoing application, or for any violation of the Rules of Racing of The State Horse Racing Commission or of any other legally constituted racing authority in the United States or elsewhere.
