I also affirm that I will instruct all growers that PDA inspectors must have access to fields used for growing these seed crops, and that all 'bio-security' areas on or adjacent to said fields will be noted by the growers for the inspectors' awareness.

It shall be the grower's responsibility to notify the land owners of rented fields about PDA inspection activity that will take place on their property.
