


OVER ROUTE 4005 (PLEASANT VALLEY ROAD)


PROJECT INTRODUCTION

- The project purpose and need:
 - Replace the dual bridges carrying Route 422 over Route 4005 (Pleasant Valley Road) including associated roadway approach work within the interchange at the South Entrance to Moraine State Park in Muddy Creek Township, Butler County. The existing bridges are deteriorated, and they do not meet the current clearance criteria.


PROJECT DETAILS


Features:

- Provide new jointless single-span dual bridges on Route 422
- Increase vertical clearance on Route 4005 to meet 16'-6" requirement
- Increase horizontal clearance on Route 4005 to meet clear zone requirements
- Upgrade guiderail safety
- Improve roadway drainage
- Maintain a single lane of traffic in each direction via crossovers on Route 422
 - For safer work zone, faster construction, and better quality
- Limit impacts to Moraine State Park no property impacts
 - Restricting bridge demolition and new beam erection to off-peak hours
 - Route 4005 traffic maintained via temporary detours along Route 422
- Avoid Environmental Impacts
- Avoid Utility Impacts




BRIDGE PLAN AND ELEVATION









BRIDGE TYPICAL SECTION STAGES




STAGE 1 TYPICAL SECTION








STAGE 2 TYPICAL SECTION






FINAL CONDITION TYPICAL SECTION




