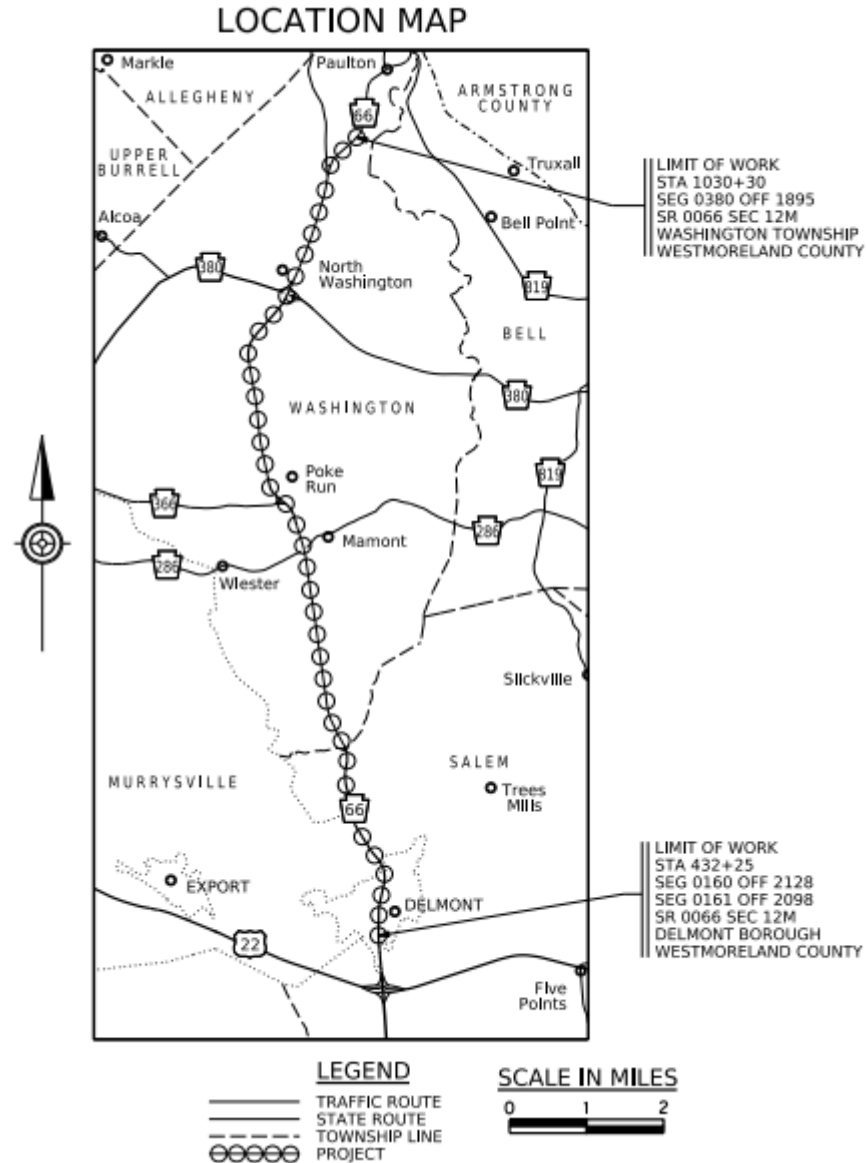

PROJECT LOCATION



The project begins at the PA 66/Manor Rd/Greensburg St. intersection and ends at the PA 66/PA 356 intersection in Delmont Borough, Municipality of Murrysville, Salem Township and Washington Township in Westmoreland County.

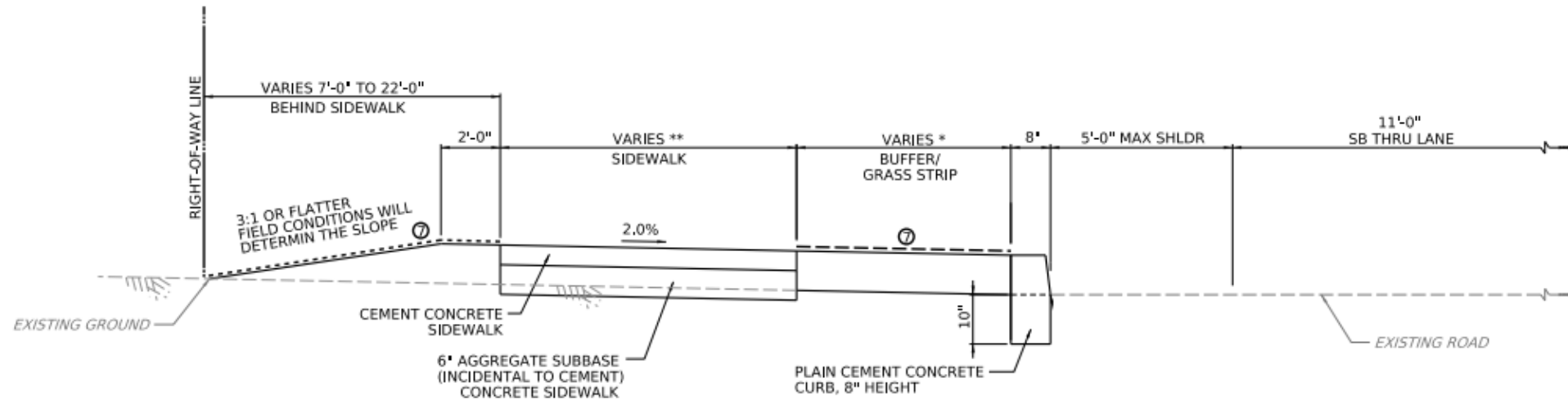
PAVEMENT PRESERVATION PURPOSE & NEED

The purpose of this project is to improve and extend the useful life of the existing pavement as well as improving the rideability. In addition, the project will improve the level of service at key intersections and enhance mobility for vehicles and pedestrians.

The scope of work will consist of milling and resurfacing PA 66 within the project limits. The traffic signals at PA 66/Manor Rd. and PA 66/Pittsburgh St. will be replaced as well as replacing the ADA ramps. In addition, new sidewalk will be installed including sidewalk lighting and landscaping on the western side PA 66 between Stotler Rd. and Pittsburgh St.

Also, PA 66 Northbound lanes between Zubal Rd. and Beaver Run Rd, will be reconstructed. The PA 66/PA 356 intersection will be reconfigured to a T-intersection controlled by a new traffic signal. Miscellaneous work will include updating the drainage guiderail, pavement marking and signage.

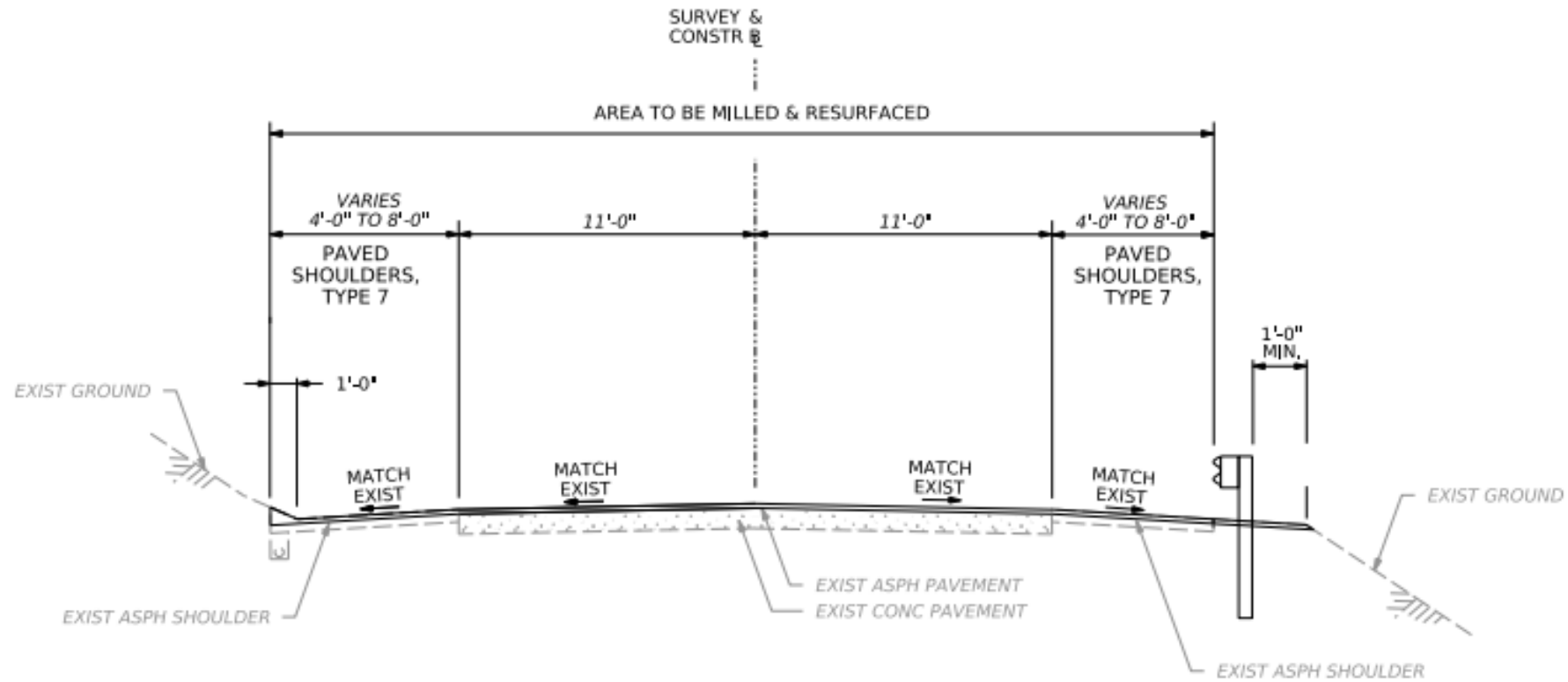


SR 0066 TYPICAL SECTION - SIDEWALK

SR 0066 TYPICAL SECTION – SIDEWALK (RENDERING)

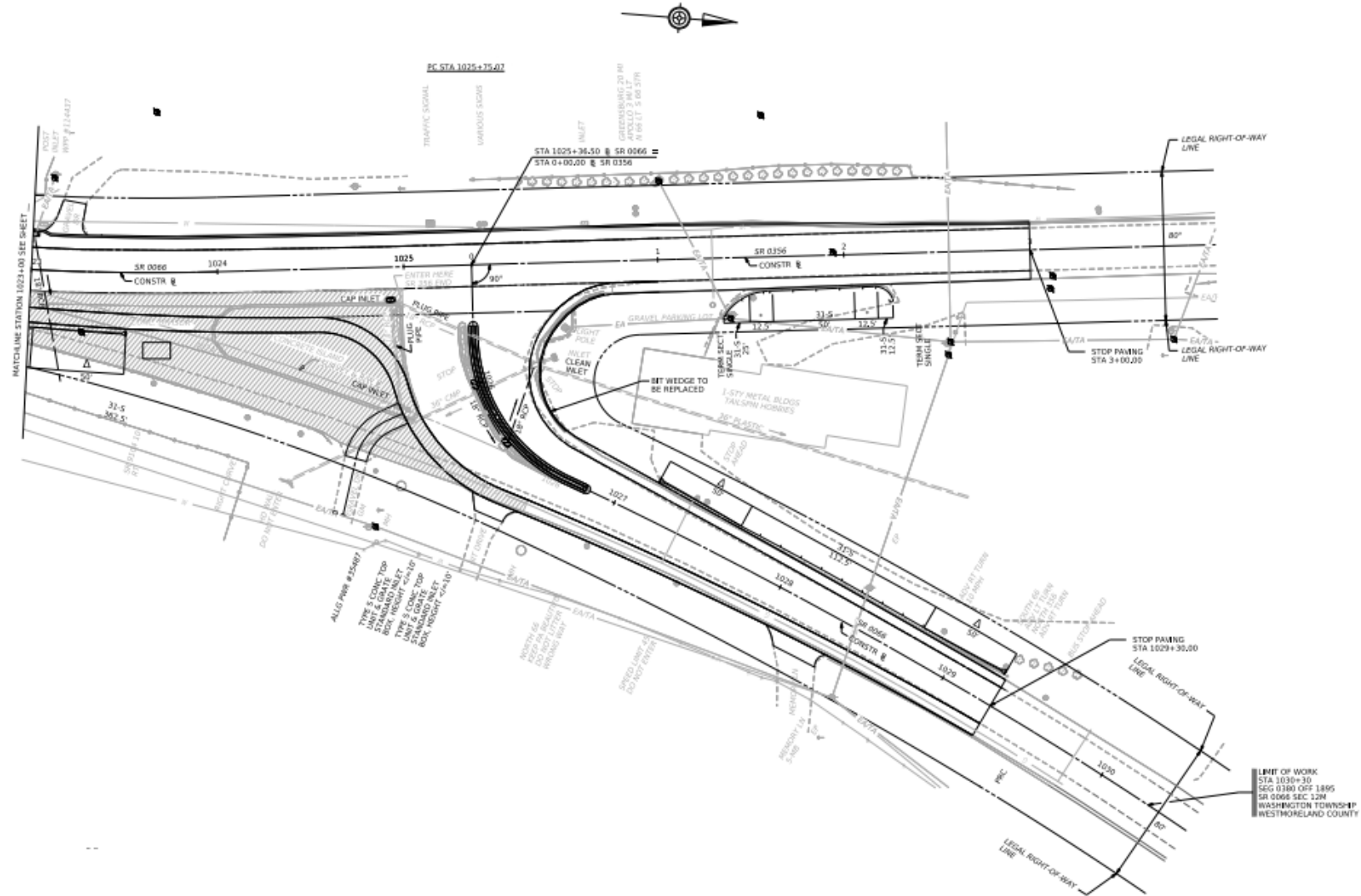


PAVEMENT PRESERVATION TYPICAL

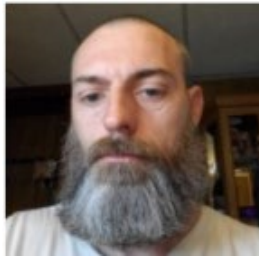

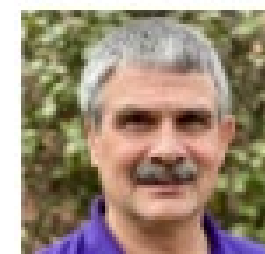
