# INSTRUCTIONS

1. This form requires a fee. Please review the instructions below carefully prior to submitting the application. For a complete listing of motor vehicle fees, refer to [Form MV-70S, "Bureau of Motor Vehicles Schedule of Fees."](#) found on our website at [www.pa.gov/dmv](http://www.pa.gov/dmv) or scan the QR code on the front of this application.
2. Check the appropriate block at the top of the form to indicate whether you are adding, changing or deleting a seasonal vehicle registration indicator on a vehicle record.
3. If adding a seasonal vehicle indicator to the vehicle record, complete Sections A, B and C.
  - Individuals should list their PA Driver's License (PA DL) or Photo ID# in the space provided. Businesses should list their Business ID# (Bus. ID) where indicated (i.e. E.I.N.).
  - Indicate in Section B, the month and year the seasonal registration and vehicle insurance will expire. **NOTE:** You may choose to backdate the expiration month and year of your vehicle registration. (This transaction will not produce a registration card if it is a month that is already expired. No refund on lost months will be given.) No fee is required when backdating the expiration date if you have already renewed your seasonal vehicle registration and have a current registration card.
  - Seasonal registration only controls when registration will expire. Future periods of registration will be valid with the processing of renewal applications.
  - When the vehicle's current registration expiration date is earlier than the chosen expiration date listed in Section B, the prorated registration fee for the additional months is required. For a complete listing of registration fees that can be used to calculate the amount of additional fee required, refer to Form MV-70S, "Bureau of Motor Vehicles Schedule of Fees," found on our website at [www.pa.gov/dmv](http://www.pa.gov/dmv). [Example: For a Passenger Vehicle – You will take the full registration rate for a one year registration fee and divide that fee by 12 months. That will tell you how much your registration costs each month. After you determine what the fee per month is, you will multiply it by the number of months not covered by the current registration. For example, if your Chosen expiration date for seasonal registration is September of this year, and the current registration expires in July of the same year. An increase in fee of two additional months would be required.]
  - Submit a check or money order made payable to the Commonwealth of Pennsylvania for the prorated registration fee. **PLEASE DO NOT SEND CASH.** Mail completed application to: Bureau of Motor Vehicles, 1101 South Front Street, Harrisburg, PA 17104-2516.
- NOTE:** Customers will receive their renewal application approximately 3 months before their registration will expire. Customers should not submit their renewal application until they are ready for the registration to be valid. The full registration fee is required regardless of how many months the registration will be valid for. Customers must have insurance for their vehicle before the registration renewal application is submitted. Please carefully check all dates on the registration credential to ensure the dates are for the desired registration period. Failure to maintain financial responsibility while your vehicle has valid registration may result in suspension of the vehicle's registration.
4. If deleting a seasonal vehicle indicator from the vehicle record, complete Sections A and C.
5. If changing the expiration date for a seasonal registration, complete Section A, B and C. The full vehicle registration fee must be paid when changing the expiration date for the seasonal registration and renewing at the same time.
