## GENERAL INFORMATION

- To renew your vehicle's registration in conjunction with this application, you must complete and attach your vehicle renewal application or [Form MV-140, "Request for Registration,"](#) and a check or money order, made payable to the Commonwealth of Pennsylvania, for the appropriate registration renewal fee in addition to the appropriate registration plate fee.
- Fee required with this application is one check or money order in the amount of the required fee. (An additional fee is required for personalization requests.) **Payment is to be made by check or money order payable to the Commonwealth of Pennsylvania. DO NOT SEND CASH.**
- To replace a lost, stolen or defaced registration plate that is damaged, but not beyond recognition, complete and submit [MV-44, "Application for Duplicate Registration Card or Replacement of Lost, Stolen or Defaced Registration Plate,"](#) along with a photograph or tracing of the registration plate for identification purposes. A registration plate is considered to be defaced when the registration plate is damaged by a specific incident such as a traffic accident, cutting, scraping or damaged caused by intense cleaning or harmful chemicals. There is a fee to replace a lost, stolen or defaced standard issue or specialty registration plate. If your defaced registration plate is a personalized registration plate, it will be replaced with the same configuration as before at no cost. Personalized registration plates that are lost or stolen are not able to be replaced with the same configuration. If your personalized registration plate was lost or stolen, we will replace it with the same style of registration plate, however, customers will be required to select a new configuration. The registration plate will be produced with the new configuration if it is available. Please make sure to indicate that you are replacing a defaced personalized registration plate on the front of the [MV-44](#). If an immediate replacement registration plate is needed while waiting for your replacement personalized registration plate, please complete and submit a second [Form MV-44](#), and the replacement registration plate fee. A standard issue registration plate will be issued until the replacement personalized, lost or stolen registration plate can be provided. **NOTE:** The replacement personalized registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application. **NOTE:** The replacement standard issue registration plate will take 7-10 business days to receive in the mail from the time PennDOT receives and processes the application.
- To apply for a **free registration plate**, due to current plate being illegible, the vehicle owner should visit our website at [www.pa.gov/dmv](http://www.pa.gov/dmv) and take [Form MV-46, "Application to Replace an Illegible Registration Plate,"](#) to any official Pennsylvania inspection station for verification that their registration plate is illegible OR have a law enforcement official verify the need for a replacement registration plate on [Form MV-46](#). The vehicle owner is then responsible for signing and returning the completed [Form MV-46](#) to PennDOT in order to receive a replacement registration plate free of charge. Your registration plate will be replaced with the next registration plate in the series and with the same style of registration plate you are replacing. If your registration plate is currently personalized, PennDOT will replace it with the same style and configuration as the registration plate you are replacing. If replacing your personalized registration plate, please attach a photograph or tracing of the registration plate for identification purposes. **If an immediate replacement registration plate is needed while waiting for your illegible personalized registration plate, please complete and submit Form MV-44, "Application for Duplicate Registration Card or Replacement of Lost, Stolen or Defaced Registration Plate," and the replacement registration plate fee. A standard issue registration plate will be issued until the replacement personalized registration plate can be provided.** **NOTE:** The replacement registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application. **NOTE:** The replacement registration plate will take approximately 7-10 business days to receive in the mail from the time PennDOT receives and processes the application. Please allow 8-10 weeks for delivery of personalized plates.
- To apply for a never received product, the vehicle owner should visit our website at [www.pa.gov/dmv](http://www.pa.gov/dmv) and complete [Form MV-50, "Application for Replacement of a Never Received Product."](#) By law, customers are entitled to a free reissuance of a product they never received if an application for a never received product is submitted within 90 days of the original issuance date. If a customer submits the application outside of the 90 days, the customer must pay a fee for each never received registration card requested and pay a fee for each never received registration plate requested, along with the application.
- Requests for Veterans of an Allied Foreign Country registration plates are restricted to passenger cars or trucks with a registered gross weight of not more than **14,000 lbs.** Motorcycles, motor homes and trailers do not qualify for Veterans of an Allied Foreign Country registration plates.
- NO REFUND** of the fee will be issued when an applicant cancels a request after the registration plate is issued.
- This application, completed in full, along with a check or money order, should be mailed to: Bureau of Motor Vehicles, P.O. Box 67900, Harrisburg, PA 17106-7900.
- All telephone numbers will be held in confidence and used only in the event of a problem with your application.
- Veterans of an Allied Foreign Country registration plates are in number sequence, unless personalized, and may not be issued with a Persons with Disability symbol.
- To avoid possible problems with citations with your old registration plate, return it to: Bureau of Motor Vehicles, Return Tag Unit, P.O. Box 68597, Harrisburg, PA 17106-8597.

## IF PERSONALIZING YOUR REGISTRATION PLATE



- Personalized Veteran registration plates may contain up to **FIVE** letters or numbers in combination. **ONLY** one hyphen or space is permitted, but not both. No additional special characters are available. Please use capital letters and print clearly. When requesting a numeric character of zero, please show as "0" instead of the alpha character "O." Since this is an electronically fillable form, after printing the form, please be sure any zero is marked with a "/." **NOTE:** A pre-printed letter configuration of **"VA"** will follow your personalized configuration on your registration plate and cannot be changed.

- PennDOT reserves the right to limit or reject requests.
- There is an additional fee to personalize your registration plate and the registration on your vehicle must be current in order for PennDOT to process your request. **The additional fee covers the cost of your personalized registration plate order only and will not renew your vehicle's registration.** If your registration has expired or expires in the next three months, please include your completed renewal application, Form MV-105, "Pennsylvania Registration Renewal Application," or [Form MV-140, "Request for Registration,"](#) and a separate check or money order in the amount of your registration renewal fee. Payment is to be made by check or money order payable to the Commonwealth of Pennsylvania. **PLEASE DO NOT SEND CASH.**
- To check personalized registration plate availability, visit PennDOT's Driver and Vehicle Services website, [www.pa.gov/dmv](http://www.pa.gov/dmv), and select Vehicle Services then Registration Plates and select [Personalized Registration Plates](#). Personalized registration plates will not be reserved until PennDOT receives payment and a completed application, and approves your requested registration plate configuration [number(s) and/or letter(s)]. Please note that registration plate requests are processed on a first-come, first-served basis. Although a requested registration plate configuration may show as being available on the website, it is possible that a request for the same registration plate configuration may have already been submitted by another customer and may not be available when making application.
- Personalized registration plates will be manufactured on the basis of this application. **NO REFUND** of the fee will be issued when an applicant cancels a request after the order is placed with the manufacturer.
- Allow 8 to 10 weeks for delivery.
