



SELF-CERTIFICATION OF EXEMPTION FROM TAX STATUS CERTIFICATE WHEN TRANSFERRING OWNERSHIP OF A MOBILE HOME OR MANUFACTURED HOME

INSTRUCTIONS: This self-certification form is to be used for titled mobile homes or manufactured homes when the home is **NOT** anchored to the ground to facilitate connections with electricity, water and sewerage **OR** was not used as a residence immediately preceding the transfer **OR** was not previously titled in PA. This self-certification form is to be completed by the transferor of the mobile home or manufactured home and provided to the transferee to be submitted with the completed application for a Pennsylvania Certificate of Title.

If the home **IS** titled, anchored to the ground to facilitate connections with electricity, water and sewerage and previously titled in PA to a person using the mobile home or manufactured home as a residence in PA immediately preceding sale or transfer, this form is not to be used. The transferor must provide the transferee with a tax status certification issued by the tax bureau where the mobile home or manufactured home is located.

NOTE: Neither a tax status certification nor Form MV-16T is required when the mobile home or manufactured home being titled is using a Manufacturer's Certificate of Origin (MCO) as the proof of ownership document.
