- No more than three dealer assignments are permitted (one Form MV-27) per title assignment. **This form may not be used for out-of-state assignments.**
- Form MV-27 should remain attached to the assigned Pennsylvania Certificate of Title, and must accompany application for transfer of title to the purchaser (or fourth dealer) when submitted to PennDOT.
- Assignment on Form MV-27 to a person or firm registered in the Miscellaneous Motor Vehicle Business class is NOT permitted.
- Do not use this form if the vehicle has been repossessed.
- **Seller's signature** for each assignment on Form MV-27 must be **self-certified**.
