## INDEMNITY AGREEMENT FOR FAULTY/LOST/DESTROYED TITLE

**This form may only be used by an authorized Salvor/Scrap Metal Processor in conjunction with a salvage vehicle which has a faulty, lost or destroyed title when the vehicle is located on the property of its owner. A non-repairable certificate will be issued.**

**SALVOR:** A person engaged in the business of acquiring abandoned vehicles for the purpose of taking apart, recycling, selling, rebuilding or exchanging the vehicles or parts thereof.

**SCRAP METAL PROCESSOR:** A person whose principal business interest is the operation of an establishment having facilities for processing iron, steel or nonferrous scrap metals, and whose principal product is scrap iron, scrap steel or nonferrous scrap for resale for remelting purposes only.
