IMPORTANT NOTES

- **Definitions:**

- **Salvage Dealer:** Any person regularly engaged in the business of acquiring and dismantling used, wrecked, damaged, abandoned or salvage vehicles for the purpose of selling the usable parts and selling the remaining vehicle hulk materials for recycling or processing.
- **Scrap Metal Processor:** A person whose principal business is the operation of an establishment having facilities for processing iron, steel or nonferrous scrap metals, and whose principal product is scrap iron, scrap steel or nonferrous scrap for resale for remelting purposes only.
- Pennsylvania or Out-of-State Certificates of Titles/Salvage or Pennsylvania nonrepairable certificates currently in the name of or assigned to the applicant must accompany this form. Attached certificates **MUST** be in order as listed on front of application.
- If the "Salvage Dealer" block is checked on the front of this form, the assignment portion of the attached certificate of title must include the purchaser information, signatures and printed names of both the purchaser(s) and the seller(s), and the odometer reading. The assignment is **NOT** required to be notarized.
- If the "Scrap Metal Processor" block is checked on the front of this form, the assignment portion of the attached certificate of title must include the purchaser information, signatures and printed names of both the purchaser(s) and the seller(s), and the odometer reading. The assignment is **NOT** required to be notarized.
