Program and other sources and did **not** focus on specific projects on the Transportation Improvement Program (TIP) in PennDOT Districts.



Road Safety Audits; A Proactive Safety Tool

Unfortunately for most communities, road safety is a reaction; a reaction to a tragic event that just happened on one of your roads. While improvements after that tragic event will help at that location, the next tragedy will likely be at another location. How can your community get ahead—and prevent that next tragedy from happening? By using proactive, proven safety processes that identify risks and take action before the crashes occur. These methods include developing a local road safety plan, road safety audits, and a systemic approach—all part of the safe system approach. This webinar discussed Road Safety Audits, and how they can be used in your community to identify potential safety risks, and deploy proven, low-cost safety measures to prevent future tragedies—before people are hurt.

2025 ARLE

PennDOT will be accepting applications for the 2025 Automated Red Light Enforcement (ARLE) Funding Program from **June 1st through June 30th, 2025**. The 2025 program will continue to prioritize safety enhancements considering both PennDOT's <u>Safety Network Screening</u> methods for the project location and <u>Crash Modification Factors</u> associated with proposed improvements.

A <u>pre-application scoping form</u> is **required** prior to submitting an application. Scoping forms should be submitted via email to <u>ARLE@pa.gov</u>. **Feedback on scoping forms that were received by April 28, 2025 will be provided by May 30, 2025.** The completed and reviewed scoping form must be uploaded as an attachment to the formal application submission.

The scoping form is a fillable web page. If you wish to save a partially-completed form to finish later, click the "Save" button at the top of the screen and save the file to your computer. When you want to work on the form again, navigate to the scoping form webpage, click "Open" at the top of the page, and select the file you saved to your computer.

When you are ready to submit the scoping form, click the "Save" button and then attach the file to an email to <u>ARLE@pa.gov</u>. Please also attach a detailed cost estimate and project location map. Applications must be submitted electronically through the Single Application for Assistance at https://grants.pa.gov/Login.aspx.

Discretionary Grants Spotlight - Update

<u>PennDOT's Infrastructure Investment and Jobs Act (IIJA) webpage</u> offers the latest news and information on federal grant opportunities available through the IIJA.

Grant opportunities, application guides and other resources on federal grant funding are added as they become available, so please visit often to see if any of these grant funding programs are an opportunity that would benefit your community.

The following is a federal grant program currently accepting applications:

Safe Streets for All (SS4A)

<u>SS4A</u> provides competitive grant funding for the planning and construction of safer roads and streets to prevent death and serious injury for everyone, including pedestrians, bicyclists, transit users, and drivers. It also funds tools to strengthen approaches to roadway safety, tailored to the unique needs of local, Tribal, and regional communities.


- The deadline for requesting PennDOT support is June 12, 2025.
- The application deadline is Thursday, June 26, 2025, 5:00 p.m. EST.

PennDOT will consider providing support for grant proposals on a case-by-case basis.

Guide for Infrastructure Investment and Jobs Act Grant Applications

PennDOT has added a guide for grant applications to the website dedicated to the IIJA, and specifically the federal discretionary programs. Also, included are Grant Alerts that provide background on these opportunities including eligibility, application deadlines, and federal and Department of Transportation (USDOT) resources and guides to assist in applying for the specific programs.



Grants Resources

USDOT Discretionary Grant Resources

The USDOT has developed a discretionary grant preparation checklist for federal fiscal year 2024 to help applicants prepare and chart a strategic pathway to apply for infrastructure investments. More than \$32 billion is available to the USDOT this fiscal year to provide competitive grant funding to local governments, metropolitan planning organizations, transit agencies, Tribal governments, U.S. Territories and state departments of transportation. The USDOT has published a list of anticipated dates for the upcoming Notices of Funding Opportunity (NOFOs) for key programs within the IIJA and the Inflation Reduction Act (IRA), as well as adjacent programs that support IIJA and IRA objectives. This list is not comprehensive, and the agency will periodically update it with additional programs and revised dates as appropriate. PennDOT Connects helps local governments and regional/municipal planning organizations consider community needs during the planning process. Examples include:

- Utility issues
- Transportation operations considerations
- Emergency services accommodations

- Regional planning studies (e.g., corridor studies, resource management studies, watershed studies, etc.)
- Consistency with current community comprehensive or other plans
- Consistency with current and/or proposed zoning
- Other proposed transportation improvements
- Impacts on the natural, cultural, or social environment
- Right-of-way considerations
- Anticipated public opinion
- Community or cultural events in the candidate project area
- Maintenance Agreement requirements
