Transportation Alternatives Set-Aside (TASA) Program 	Pennsylvania Department of Transportation (PennDOT)	Creation and safety improvements to nonmotorized transportation options, including sidewalks; pedestrian and bicycle paths; trails; streetscape improvements; safe routes to schools. Development and improvement of rail trails and shared-use paths; safe crossings for pedestrians, cyclists, and other non-motorized users; planning, design, and construction of infrastructure related to bicycle sharing and bicycle parking facilities.	\$50,000 to \$1.5 million (\$3 million for extraordinary projects)	0% - Sponsor to pay all planning and pre-construction costs	Varies, typically every two years

Automated Red Light Enforcement (ARLE) Grant 	Pennsylvania Department of Transportation (PennDOT)	Roadway safety, mobility, and capacity upgrades; bicycle and pedestrian improvements; Local Technical Assistance Program (LTAP) projects; traffic signal improvements	No minimum award or award ceiling (average award size is ~\$225,000 in 2023)	0% but cost sharing is recommended	Annually by June 30 th (submit scoping forms by April 30 th)
Green Light-Go Grant (GLG) Program 	Pennsylvania Department of Transportation (PennDOT)	Operational improvements to existing traffic control signals including - LED replacement, traffic signal retiming, removal of unwarranted signals, innovative technologies (adaptive traffic signal control, real time performance metrics, etc.), Traffic Management Center connections, detection/controller upgrades, modernization upgrades, Intelligent Transportation System applications.	No minimum award or award ceiling (average award size ~\$460,000 in 2023)	20% of project cost	Annually (TBD)
