To All Proposers:

The Commonwealth of Pennsylvania defines a solicitation “Addendum” as an addition to or amendment of the original terms, conditions, specifications, or instructions of a procurement solicitation (e.g., Invitation for Bids or Request for Proposals), including but not limited to questions and answers, which are considered a material part of the solicitation.

**Please see the following update:**

Addendum 6 does the following:

1. Section 5.2 “Format” on page 15 should now read: “Submittals must be prepared on 8-1/2” x 11” white paper. Volume 1 of the SOQ shall have all pages sequentially numbered and shall not exceed 80 pages. The following do not count toward the 80 pages and need not be sequentially numbered:
  - (a) **Form A;**
  - (b) **Form B;**
  - (c) **Form C;**
  - (d) Any information required pursuant to Appendix 6 required for Volume 1; and
  - (e) Any teaming agreements and summaries of teaming agreement key terms required to be included in Volume 1 of the SOQ pursuant to **Form B.**”
2. Appendix 1, Item 4 “Key Personnel” part (d) on page 31 should now read: “Project Finance Lead”
3. Appendix 1, Paragraph 3 on page 32 should now read: “Three references for each of the project executive (if different from the project manager), project manager and the deputy project manager(s) and one reference for each other individual identified above must be supplied; provided, however, that where the project manager and deputy project manager(s) have only worked on one or two projects during the past five years, the Proposer shall (i) affirmatively state that such individual has only worked on one or two projects during the past five years; (ii) include references for each of such projects; and (iii) include references for projects worked beyond the past five years so that the number of references equals three in total.”
4. Appendix 2, Paragraph 1 on page 33 should now read: “With reference to no more than 15 projects (each of which must have commenced construction or be under contract for maintenance of an existing facility during the past eight years) in the aggregate, demonstrate the collective experience of the Proposer, each Equity Member, each Major Non-Equity Member and any Proposed Guarantor, as applicable, with respect to:”
