### SPECIAL PROVISIONS FOR THE "SORBER MOUNTAIN II" TIMBER SALE

#### S.G.L. # 057

### 1) ADMINISTRATIVE ITEMS

- a) All contractors, subcontractors and consultants of the Buyer must be pre-approved by the Commission. The Commission reserves the right to reject any subcontractor at its sole discretion.
  If Contractor enters into any subcontract(s) not previously approved by the Commission, the Commission shall have the right to require the Contractor to terminate such contracts.
- b) Payment for Block 1 is due at contract execution.
- c) Final payment is due No Later Than 120 days before the expiration of the Agreement.
- d) This 223-acre timber sale consists of 143 acres of shelterwood (Blocks 1, 3, 4, 8), 34 acres of overstory removal (block 2), and 46 acres of clearcut with residual (block 5, 6, 7).
- e) Prescribed fire was implemented in sale blocks 1, 2, 3, and 4 on May 21, 2020.
  - 1. Stems in these blocks may exhibit surface scorching or char as a result of the prescribed fire.
- f) Saw timber volumes were determined by a 100% tally and pulp wood was determined by a 10 BAF prism plot cruise. All trees are tallied in 2-inch diameter classes.
- g) Operator must comply with the erosion and sedimentation control plan for the area.
  - 1. A completed plan will be provided to the successful bidder
- h) Operator is responsible for contacting PA One Call (8-1-1) at least three (3) business days prior to any earth moving activities, skidding, or hauling to ensure all utility lines are clearly identified. PA One Call will alert the appropriate facility owners of the intent to conduct earth moving activities or cross underground lines. For more information, visit www.pa1call.org.
- i) All sale activity, (felling, skidding, & trucking), is restricted to the defined sale area.
- j) Except for seasonally opened gates, PGC gates are to be kept closed and locked except when the contractor is present on the site. Repeated failure to close gates will be penalized.
- k) If site conditions in the timber sale (for felling, skidding, or trucking) or the use of the haul road become wet and/or muddy in the opinion of the Regional Forester or his designee, all phases of the job will be suspended until working conditions are judged favorable.
- Preliminary road work and site preparations specified in section (5) <u>GAME LAND ROADS TO</u> <u>BUILD / IMPROVE</u> must be completed to the satisfaction of the Regional Forester or his designee before harvesting in any other block may begin.
- m) Buyer is not guaranteed exclusive use of the haul roads for this timber sale. Hauling restrictions may be implemented at the discretion of the Regional Forester or his designee to avoid excessive damage to haul roads under joint use.
- n) No tops or slash shall be left on any drainage ditch leading from a culvert, water bar, intercepting dip or break in berm of road.

- o) All tops will be pulled back 25 feet from State Game Lands boundary lines, utility right-of-way, dam, pond, lake, stream, spring seep, herbaceous opening, deer deterrent fence, trail, building, road, parking lot and scattered so as to not form a windrow.
- p) Whole tree chipping of some trees is permitted as specified in section (3). <u>BOUNDARIES</u>, BLOCKS, AND CUTTING INSTRUCTIONS
  - 1. Whole tree chipping of all trees is permitted in blocks 5 & 6.
  - 2. No whole tree chipping is permitted in blocks 1, 2, 3, 4, 7, and 8.
- q) Extra caution should be taken to avoid felling damage or skidding damage to reserved trees.
  - 1. Felling and skidding damage will be closely monitored and excessive damage will result in the payment of damages by the contractor.
- r) No on-site sales of firewood to the public is allowed.

# 2) MECHANIZED HARVESTING EQUIPMENT LIMITATION

- a) The following are prohibited in **Block 2**:
  - 1. The use of equipment that in the opinion of the Regional Forester results in abnormal damage to the residual stand including tree regeneration.
  - 2. No grapple skidders or felling machines may be used unless authorized by the Regional Forester.
  - 3. A pre-work conference with the buyer and or logging contractor and the Regional Forester or his designee must be held at least 3 days prior to the start of road work or logging unless otherwise authorized by the regional forester.

### 3) BOUNDARIES, BLOCKS, AND CUTTING INSTRUCTIONS

- a) Timber sale boundaries are marked with 2 blue paint slashes and block boundaries are designated with 1 blue paint slash.
  - 1. Sale boundary trees which are marked with **blue** paint <u>must not</u> be felled.
- b) Game Land boundary, roads, herbaceous openings, buffered areas and spring runs are to be kept free of tops.
- c) No cutting or skidding is permitted in the reserve areas.
- d) Blocks 1, 3, 4, & 8
  - 1. All trees 2" DBH and over, except for red paint marked reserve trees are to be cut.
  - 2. Conifers, serviceberries, hawthorns, and dogwoods are also reserved.
  - 3. Whole tree chipping is **not** permitted in these blocks.
  - 4. All top wood 3" diameter and smaller is reserved.
- e) Block 2
  - 1. All trees 2" DBH and over, except for blue paint marked reserve trees are to be cut.
  - 2. Conifers, serviceberries, hawthorns, and dogwoods are also reserved.
  - 3. Whole tree chipping is **not** permitted in these blocks.
  - 4. All top wood 3" diameter and smaller is reserved.
  - 5. The block must be cut during the dormant season from October 15<sup>th</sup> March 15<sup>th</sup>.

- f) Blocks 5 & 6
  - 1. All trees 2" DBH and over, except for red paint marked reserve trees are to be cut.
  - 2. Conifers, serviceberries, hawthorns, and dogwoods are also reserved.
  - 3. Whole tree chipping is permitted in these blocks.
  - 4. The blocks must be cut during the dormant season from October 15<sup>th</sup> March 15<sup>th</sup>.
- q) Block 7
  - 1. All trees 2" DBH and over, except for red paint marked reserve trees are to be cut.
  - 2. Conifers, serviceberries, hawthorns, and dogwoods are also reserved.
  - 3. Whole tree chipping is **not** permitted in these blocks.
  - 4. All top wood 3" diameter and smaller is reserved.
  - 5. The block must be cut during the dormant season from October 15<sup>th</sup> March 15<sup>th</sup>.
- h) Blocks 2, 5, 6, & 7 will be cut during the dormant season, October 15 through March 15.
  - 1. Due to some of the soils exhibiting hydric conditions, harvesting will be permitted only when site conditions are stable or frozen.
  - 2. The Regional Forester or his designee may extend the cutting dates if dormant conditions occur outside of the anticipated dates.
- i) Cull portions of the tree are to be left at the stump.
- j) Any reserved trees that are felled for safety reasons must be left at the stump.

- b) State Roads
  - 1. Visit <a href="http://www.papostedroads.pa.gov/">http://www.papostedroads.pa.gov/</a> for information on road bonds. The haul road entry point has a Highway Occupancy Permit.

#### 5) GAME LAND ROADS TO BUILD / IMPROVE

- a) Erosion and Sedimentation control structures will be in place, operable and maintained throughout the duration of the contract.
- b) The Regional Forester or his designee will be notified a minimum of three days prior to road construction, landing construction, and final grading.
- c) During the hunting season, the road that extends from the intersection with Sorber Mountain Road out to the landing in block 2 is open to public access.
- d) Road To Improve
  - 1. Locations of roads to improve are identified on the sale maps.
    - a. A minimum of 9,225 feet of existing haul road is designated for hauling.
  - 2. There are existing culverts along the hauling route. These culverts are to be maintained in good working condition throughout the hauling operation.

- a. Any culvert pipes that are damaged by the operator will be repaired or replaced by the operator at the operator's expense. The operator will remove and properly dispose of all culverts that are replaced.
- b. Proper headwalls and endwalls will be installed on all culverts that are replaced.

#### e) Culverts Information

1. No new culverts are required to be installed for this contract.

#### f) Required Stone

- 1. The operator must apply **40 tons of AASHTO 1 Stone**, (2" to 4"), **200 Tons of 2A Modified Stone** (1 ½" to 2 ½"), and **200 Tons** of crushed stone, shot rock, quarry run, shale or other suitable fill material as approved by the regional forester. This stone will be required as needed to maintain haul roads in a stable condition suitable for hauling as directed by the Regional Forester or his designee.
- 2. A shale pit is located between blocks 5 & 6 and is identified on the sale map. The operator will be allowed to remove shale from this location and place it on seeded PGC haul roads. Shale may not be removed from the game lands. The regional forester must approve the excavation and placement of shale on the haul road prior to the start of construction. At the conclusion of the sale the shale pit must be retired and leveled so no high walls exist and any shale already dug and staged will be replaced.
- 3. On the **6,270' portion of haul road (labeled 'stoned' road on sale map)**, crushed stone is the only suitable stone. If AASHTO 1 or 3 is used on this portion of road, it will be required to be topped with 2A modified.
- 4. The operator must use a bulldozer to shape and grade the roadway before the stone is applied.

# g) Gate Installation

1. No new gate installation is required for this contract.

#### h) Road Retirement

1. A road grader or a bulldozer with a six-way blade will be required for final grading, as needed, to be determined by the Regional Forester. The operator will crown, ditch, and stone rake all required haul roads and all other roads that have been used to a minimum 12' running surface or to the roadway original width, whichever is wider. Ditches and other drainage structures must be opened and re-established where needed. The road must be crowned to drain all water into the ditches and culverts. All piles of surface side cast shall be graded level by feathering it back into the road berms and/or road surface during final grading. Road berms will be graded to a mowable contour.

#### 6) LANDINGS

- a) Main landing locations are designated on the sale map. Any additional landings are to be approved by the Regional Forester or his designee.
- b) Parking lots and herbaceous openings cannot be used for log landings.
- c) All blocks on this sale have existing landing areas, (approximately 1/2 acre each).
- d) Immediately following the completion of its usage, each landing will be graded, leveled, cleared of debris, stone raked sufficiently for use as mowed fields, and seeded according to specifications outlined in Section 8) <u>SEEDING OF ROADWAYS AND LANDINGS</u>.

e) Stumps, stones and other debris on the edges of the landing areas will be moved off the landing area and spread out into the surrounding woods.

#### 7) SKIDDING

- a) Skid trails will be approved by the Regional Forester or his designee.
- b) No skidding across small drainages will be permitted without the use of temporary bridges, culverts, or other approved crossing structures.
- c) No skidding or use of forwarders is permitted on any haul road or other SGL roadway.
- d) Crossing of the haul road or other SGL roadways will be permitted only at designated locations.
  - 1. All crossing locations will be stabilized by the addition of stone and ditch lines will be protected and remain open.
- e) There is an existing skid trail that runs through block 2 and along the eastern boundary of block 3. This is identified on the sale map.
  - 1. All material from block 3 must utilize this skid trail and not be skid through block 2.
- f) No material from block 8 can be skid through block 7.
- g) If skid trails are to sit idle for one month or more, they are to have water bars added.
- h) Main skid trails are to be leveled, open and have water bars added at the conclusion of the harvesting.

#### 8) SEEDING OF ROADWAYS AND LANDINGS

- a) Regional Forester or his designee is to be notified a minimum of three days prior to the application of seed and mulch.
- b) Following completion of logging operations in any individual block, The Operator must seed at his expense the disturbed areas associated with all haul roads, (except for the running surfaces of the sale roads designated as '**stoned**' road on the sale map), all log landings, and bulldozed or designated skid trails where harvesting has been completed.
  - 1. These areas will be retired during the spring or fall, whichever occurs first, as soon as weather conditions are suitable in the opinion of the Regional Forester.
- c) At the conclusion of the harvest, woody debris, sawdust, and wood chips will be removed from the landing areas sufficiently to permit germination of required seeding.
- d) All haul roads designated as 'seeded' and all landings will be seeded according to the following:

5 lbs. per acre of White Dutch clover - Inoculated Seed

5 lbs. per acre of Crimson clover - Inoculated Seed

50 lbs. per acre of Oats, (spring)

50 lbs. per acre of Wheat, (fall)

### A minimum of 4 acres are to be seeded with this seed mix.

This seed mix for landings and haul roads must be applied with one ton per acre of lime and 400 pounds per acre of 10-10-10 fertilizer.

- e) Immediately following seeding, weed-free straw mulch will be applied to all designated landing areas at the rate of 5,000 lbs. per acre (100 bales per acre). A mechanized mulch spreader is required to apply straw uniformly to treated surfaces. Straw must be spread to a depth of less than 1/2" over the entire seeded location. Log landings and disturbed areas along the haul road will be the only surface area receiving straw mulch.
- f) Seeding will include ditch lines and all disturbed areas.
- g) Spring planting may be performed Until June 15<sup>th</sup>. The fall planting may be performed during the period from August 15th to September 15<sup>th</sup>.
  - 1. If any seeding is performed outside of the seeding dates, a guaranteed catch of seeding must be obtained to the satisfaction of the Regional Forester or his designee.
- h) All bulldozed skid trails are to be seeded with wheat or oats at a rate of 25 lbs. per acre depending on the time of seeding.
- i) Guaranteed catch of cover must be obtained to the satisfaction of the Regional Forester or his designee before the bond will be released.

### 9) SAFETY AND LOGGER TRAINING

- a) The Buyer, his employees and sub-contractors are expected to perform all logging operations in a safe manner as required by applicable laws and regulations. The Commission expects the Buyer to ensure that logging crewmembers dress in protective attire, and perform their duties with equipment, in accordance with standards established by the logging industry and the Occupational Safety and Health Administration (OSHA).
- b) The PGC recommends that logging crews working on State Game Lands be trained in safe logging techniques and sound environmental logging practices though a formal training program such as the one provided by the Pennsylvania Sustainable Forestry Initiative or another similar course.

### 10) OPERATIONS AND NON-WORK DAYS

- a) No woods operation will be permitted on the following days:
  - 1. All Saturdays in the months of October, November, December, and January and any Sundays open to hunting.
  - 2. The opening day and all Saturdays during spring turkey season, including the youth spring gobbler hunt.
  - 3. All the days of general statewide bear season.
  - 4. The entire 2 weeks of the general firearms deer season.
  - 5. The opening day of the flintlock muzzleloader season.
- b) No woods operation will be permitted from <u>MARCH, 15 THRU MAY 1 (SPRING BREAK-UP</u> <u>DATES</u> without the permission of the Regional Forester.
- c) The contractor, employees, and sub-contractors may not hunt to, from, or at the job site when the work location is beyond a gated road that is closed to public traffic. The contractor may travel to and from the work location on no-work days to check on the condition of equipment.
- d) The contractor is responsible for the control and collection of fluids leaking from any equipment used on the site. The contractor must have a spill containment and cleanup kit appropriate for the

equipment being used. At a minimum, the kit will contain plugs and clamps to control hydraulic line breaks, a container to collect leaking fluids, fluid absorbent pads and a shovel. Operating any equipment noticeably leaking fluids is prohibited. The contractor must collect and control fluids leaking from any equipment and dispose of properly.

e) It is unlawful to be present on State Game Lands from November 15 through December 15 inclusive when not engaged in lawful hunting or trapping and fail to wear a minimum of 250 square inches of daylight fluorescent-orange material on the head, chest, and back combined, or in lieu thereof, a hat of the same colored material. The material shall be worn so it is visible in a 360-degree arc.

### 11) PNDI RECOMMENDATIONS

a) A PNDI review was performed on 7/25/2025.

### 12) MISCELLANEOUS

- a) The contractor will provide weight slips for stone and receipts for all seed, fertilizer, and mulch to the Regional Forester or his designee.
- b) All existing trails and at least one main skid trail are to be kept open as hunter access in each block.
- c) If possible, the operators will clean all equipment and vehicles thoroughly to remove invasive plant species from being transported from other sites.
- d) Violation of contract provisions by the operator may subject the operator or its employees or contractors to fine based on Title 58 regulations.

### 13) PA RIGHT TO KNOW PROVISIONS

- a) The Pennsylvania Right-to-Know Law, 65 P.S. §§ 67.101-3104, applies to this contract.
- b) Unless the Contractor provides the Commonwealth, in writing, with the name and contact information of another person, the agency shall notify the Contractor using the Contractor information provided by the Contractor in SRM [or "the legal contact information provided in this contract"] if the agency needs the Contractor's assistance in any matter arising out of the Right to Know Law ("RTKL"). The Contractor shall notify the agency in writing of any change in the name or the contact information within a reasonable time prior to the change.
- c) Upon notification from the Commonwealth that the Commonwealth requires the Contractor's assistance in responding to a RTKL request for records in the Contractor's possession, the Contractor shall provide the Commonwealth, within fourteen (14) calendar days after receipt of such notification, access to, and copies of, any document or information in the Contractor's possession which arises out of the contract that the Commonwealth requests ("Requested Information") and provided such other assistance as the Commonwealth may request in order to comply with the RTKL. If the Contractor fails to provide the Requested Information within fourteen (14) calendar days after receipt of such request, the Contractor shall indemnify and hold the Commonwealth harmless for any damages, penalties, detriment or harm that the Commonwealth may incur as a result of the Contractor's failure, including any statutory damages assessed against the Commonwealth.
- d) The Commonwealth's determination as to whether the Requested Information is a public record is dispositive of the question as between the parties. Contractor agrees not to challenge the

Commonwealth's decision to deem the Requested Information a Public Record. If the Contractor considers the Requested Information to include a request for a Trade Secret or Confidential Proprietary Information, as those terms are defined by the RTKL, the Contractor will immediately notify the Commonwealth, and will provide a written statement signed by a representative of the Contractor explaining why the requested material is exempt from public disclosure under the RTKL within seven (7) calendar days of receiving the request. If, upon review of the Contractor's written statement, the Commonwealth still decides to provide the Requested Information, Contractor will not challenge or in any way hold the Commonwealth liable for such a decision.

- e) The Commonwealth will reimburse the Contractor for any costs associated with complying with this provision only to the extent allowed under the fee schedule established by the Office of Open Records or as otherwise provided by the RTKL if the fee schedule is inapplicable.
- f) Contractor agrees to abide by any decision to release a record to the public made by the Office of Open Records, or by the Pennsylvania Courts. The Contractor agrees to waive all rights or remedies that may be available to it as a result of the Commonwealth's disclosure of Requested Information pursuant to the RTKL. Contractor's duties relating to the RTKL are continuing duties that survive the expiration of this contract and shall continue as long as the Contractor has Requested Information in it possession.
