Pennsylvania Historical & Museum Commission

The Pennsylvania Historical & Museum Commission (PHMC) is the official history agency of the Commonwealth of Pennsylvania. Created in 1945, PHMC is responsible for the collection, preservation, and interpretation of Pennsylvania's heritage, which we accomplish through the Pennsylvania State Archives, The State Museum of Pennsylvania, the Pennsylvania State Historic Preservation Office, the Bureau of Management Services, and 23 historical sites and museums. The responsibilities of PHMC, which are based in the Pennsylvania Constitution, are further defined in the History Code and the Administrative Code.

From the Executive Director

As the state's official history agency, the Pennsylvania Historical & Museum Commission is responsible for preserving the Commonwealth's past. It is also in our purview to connect today's Pennsylvania to that history. Stewardship, access, and relevance are all key to making history matter to Pennsylvanians.

Stewardship is integral to ensuring that the history entrusted to us remains available to the Commonwealth today and tomorrow. For that purpose, we have constructed a new Pennsylvania State Archives building, a state-of-the-art facility that will ensure that the permanently valuable records of Pennsylvania are protected. Other improvements have focused on preserving historic buildings and providing facilities that ensure appropriate care for the Commonwealth's history.

Of course, preserving the documents and artifacts we hold is important, but to be of use to Pennsylvanians, they must be available. To that end, we have focused on making information about these collections available online. Last year, we completed the digitization of a collection of nearly 20,000 postcards depicting historic views from across the Commonwealth and made them available through POWER Library. We continue to develop digital content, including introductory videos about each of PHMC's historic sites and museums, and delivered virtual programs that remain available on our YouTube channel.

It is also essential that this history resonates with us. Across PHMC, we explore topics that have parallels to today or provide context for the present. We offer places for Pennsylvanians to gather with activities that are relevant to them, whether it is commemorating Black history or marking citizenship or honoring student achievement. We celebrate the individual communities across Pennsylvania and the unique qualities that distinguish them and the common features that are hallmarks of the Commonwealth.

The following report highlights some of PHMC's achievements of the last year, although there is room here for only a few of them. We hope this will inspire you to come explore Pennsylvania history with us. We can't wait to meet you and hear about what you find meaningful to you and your community.

The Pennsylvania State Archives (PSA) protects more than 250 million significant historic, legal, and financial documents for use by state agencies and the public.


These documents range from William Penn's Charter of 1681 to the digital media of recent governors and vital records such as historic birth and death certificates. PSA makes these documents available to the public—researchers, genealogists, scholars—both in person and online. PSA also operates the State Records Center, a cost-effective storage facility for the records of state agencies, and it trains state agencies and local governments to safeguard and manage records. PSA welcomed nearly 4 million online and in-person visitors in 2022–23.

PSA Moves to Newly Constructed Building

Construction of the new 145,000-square-foot Pennsylvania State Archives building at 1681 North Sixth Street in Harrisburg was officially completed, and the transfer of more than 88,000 boxes containing 250 million documents began before the close of the fiscal year. One of the final tasks in the long preparation for the move was accomplished this year with the final barcode labeling of the mobile, static, and freezer shelving in all the new building's archival storage rooms. Working in seven-person teams every morning beginning in February, all PSA staff rotated daily shifts to affix the labels until all 55,000 shelves were properly barcoded and ready to hold the collections. The new building nearly doubles the capacity of the previous facility. To provide maximum preservation of the documents, record storage areas will maintain a constant temperature of 60 degrees and 35 percent humidity, and additional spaces will maintain 50 degrees and even 20 degrees for special media, such as film. New features in the building include digital touchscreens for visitors to explore the collection, a self-service area accommodating 40 visitors with 16 public access computers and wi-fi, an exhibit room, a library of Pennsylvania history books, and free parking for 29 patrons.

Online Accessibility to PSA Collections Continues with Digitization Projects

The Pennsylvania State Archives (PSA) continued its ongoing effort to digitize its collections for convenient online access, with some projects nearing or reaching completion. By the end of this fiscal year, 21.3 million images were accessible through PSA's website and those of its partners—Ancestry.com and the State Library of Pennsylvania's POWER Library. Digitization of the motion picture collection progressed, with more than 90 percent of the project complete. Some digital copies of the films will be featured online, and others will be available in the research room of the new PSA building. Additionally, PSA completed the in-house digitization of its voluminous postcard collection. The 23,260 postcards depict buildings and streetscapes, businesses and industries, parks and scenic views from all 67 counties in Pennsylvania, spanning from the 1880s to the 1970s. All the digitized postcards are available online on POWER Library for free public use.

Governor and Family Attend First In-Person Charter Day Since the Pandemic

In March, at this year's Charter Day, more than 1,000 people came to The State Museum of Pennsylvania to see the Charter that England's King Charles II granted to William Penn in 1681, creating Pennsylvania. Among the visitors were newly inaugurated Gov. Josh Shapiro, First Lady Lori Shapiro, and three of their children. The Pennsylvania State Archives traditionally displays the original document once each year at the annual Charter Day commemoration, but this year's event was the first in-person display of the Charter since the COVID-19 pandemic. The 342-year-old document is written on parchment using iron gall ink, and the State Archives preserves it in a high-security vault in the new building, shielding it from strong light and environmental fluctuations.

Archives Assists Bestselling Author

People research the collections at the Pennsylvania State Archives for various reasons, from legal to genealogical. Writers and scholars come to PSA to find information in letters, diaries, records, maps and photographs in the collections as original research for their papers and publications, both popular and academic. Recently, PSA assisted *New York Times* best-selling author Ann Leary in research for her historical novel *The Foundling*, released in 2022. The book is a fictional account of young Mary Engle who works as a secretary in an institution for mentally disabled women in the 1920s. The character is based on Leary's grandmother who actually worked at what was then the Laurelton State Village for Feeble-Minded Women of Childbearing Age (Union County), whose records are held at PSA and were consulted by Leary in her research. In March, Leary returned to PSA and discovered several additional collections of records related to Laurelton that she plans to use in future book-related projects.

PSA Acquires Governor Wolf's Records, First Lady's Pandemic Project Photos

In its role as steward of the records of Pennsylvania government, the Pennsylvania State Archives houses and preserves the papers of past Governors of the Commonwealth. In these collections are such notable documents as Gov. George Leader's papers regarding civil rights and integration in Levittown, Gov. Dick Thornburgh's Three Mile Island files, and Gov. Tom Ridge's letter of resignation after 9/11 to head the U.S. Office of Homeland Security. This past year, as Gov. Tom Wolf's incumbency drew to a close, PSA worked with his staff to acquire his electronic and paper gubernatorial records as well as some of his personal papers, including school items, his Ph.D. dissertation, speeches, and blog posts. Also, the First Lady's Office transferred more than 1,300 photographs to PSA from Frances Wolf's *One Lens: Sharing Our Common Views* project, which involved Pennsylvanians contributing photographs that documented their experiences during the COVID-19 pandemic for a virtual exhibition in 2022.



The State Museum of Pennsylvania is responsible for maintaining a collection of more than 12 million artifacts that tell the stories of Pennsylvania's natural and cultural history.

These are the largest collections in the Commonwealth focused exclusively on the heritage of Pennsylvania, covering the fields of art, history, archaeology, geology, paleontology, and natural history. Listed in the National Register of Historic Places, The State Museum building boasts nearly 160,000 square feet of exhibit space filled with both permanent and changing exhibits.

55th Art of the State Celebrates Artistic Achievement in PA

The State Museum's annual juried exhibition, *Art of the State*, opened to the public on September 11, 2022, featuring 92 works of art by 92 artists from 31 Pennsylvania counties. The awards ceremony was held in person for the first time since the start of the COVID-19 pandemic. Artists received awards in five categories: craft, painting, photography, sculpture, and work on paper. Later, in January 2023, The State Museum announced the *Art of the State* Purchase Awards, two works that become part of the museum's permanent collection. One of the works chosen, *Bruke*, is a colored pencil portrait by Malcolm Corley, who was diagnosed with autism at age 3 and began to draw at an early age. The other award was for *Full Circle*, a fine art brooch by Matthew Coté that represents the impact of mass shootings on American culture.





▲ Exhibitions on Historic Revolutions Parallel Current Transitions

The State Museum mounted two changing exhibitions this year that focused on transitions in Pennsylvania life in the late 19th and early 20th centuries. *Horse2Auto: A Transportation Revolution*, which opened in December 2022, explored the gradual change from horsepower to gasoline-fueled automobiles in the Commonwealth through the history of three vehicles—a horse-drawn rural delivery mail carriage, a horse-drawn oil tanker, and a circa 1906 Sears Motor Buggy—drawing a historic parallel to the current transition to electric-powered vehicles. The second exhibition, *Pennsylvania Industry—A Bird's Eye View*, opened in January 2023 and featured a selection of T.M. Fowler's panoramic bird's-eye views of cities and towns in Pennsylvania to illustrate the impact of industrialization in the state between 1870 and 1920, supplemented with a digital exhibition and an extensive wall-mounted finding aid identifying key features in the aerial views.

Workshops in Archaeology Follows Pennsylvania's Pathways to the Past

The State Museum hosted its annual Workshops in Archaeology on October 29, 2022, Pathways to the Past. The program explored the idea of using archaeology to enrich historical narratives through Pennsylvania's trails, portages, and trade routes. Presentations focused on Native American foot paths created thousands of years ago, which became trade and exchange routes and later developed into roadways, and river valleys that served as transportation corridors for commerce and trade from precontact through the historic period, informing the locations of communities. Also discussed were other less tangible pathways, such as the Underground Railroad network that transported enslaved people to communities in Pennsylvania and elsewhere. The program provided an opportunity for participants to engage with the scholars who have researched these pathways, observe the use of lithics often traded along these routes, and learn about community preservation efforts.



State Museum Programs Promote Student Education and Achievement

In 2022–23 more than 26,050 schoolchildren visited The State Museum to learn about Pennsylvania history, culture, and natural history. Museum curators and educators, in addition to conducting tours and educational programs for public and private school groups, led a monthly program for homeschooled students and their families from October 2022 to March 2023, focusing on a different Pennsylvania subject each month. The homeschoolers experienced a guided gallery tour and a discussion about the day's topic and then participated in a hands-on family activity, giving them the opportunity to engage with museum staff, ask questions, and work together. In the spring, the museum hosted the South Central Pennsylvania Scholastic Art & Writing Awards exhibition, a display of students' winning projects presented with the Commonwealth Charter Academy, which has partnered with the museum to exhibit the work of talented student artists since 2013.

State Museum Art Featured in Three Exhibitions at PA Governor's Residence

The State Museum worked with the offices of Gov. Josh Shapiro and First Lady Lori Shapiro to mount three art exhibitions at the Pennsylvania Governor's Residence in the first half of 2023. Earlier in the year, museum curators installed a collection of watercolor scenes from more than 40 Pennsylvania counties by Harrisburg artist Nick Ruggieri, which he painted in the early 1970s in anticipation of the nation's Bicentennial; this exhibition was on view for postinaugural celebrations, school tours and other events. As part of a Black History Month event hosted at the Governor's Residence in February, the museum mounted *Voices of the Revolution*, a 1967 portfolio of 15 color woodcut prints by Philadelphia artist Edith Jaffy Kaplan, commemorating the postwar Civil Rights Movement. In May, the museum installed *Power of Place*, an exhibition of paintings from The State Museum's fine art collection, spotlighting Pennsylvania artists and the Pennsylvania places that have inspired their work, from rural hamlets to big cities.

The Bureau of Historic Sites & Museums preserves and interprets 23 historic sites and museums across the Commonwealth that together tell the story of Pennsylvania.

Known as the Pennsylvania Trails of History, these sites include battlefields, historic houses, and religious settlements, as well as theme museums focused on Pennsylvania's nationally significant role in the key industries of lumber, coal, oil, agriculture, and railroads. Although rooted in history, these museums interpret themes in relevant and contemporary ways, hosting citizenship ceremonies, highlighting the Commonwealth's traditions of immigration and tolerance, and celebrating the state's social, cultural, and economic diversity.

Pennsbury Manor Highlights Diversity in the Commonwealth

Pennsbury Manor, the site of William Penn's country estate in Morrisville, Bucks County, interprets the life and career of Pennsylvania's founder and the origins of the diverse Commonwealth he established. Adhering to this legacy, Pennsbury strives to ensure that its programs are serving and representing all Pennsylvanians. From August to November 2022 and then again from February to June 2023, Pennsbury hosted *Dreams of Freedom: The Threads That Hold Us Together*, an exhibition of quilts and mixed media honoring the life and contributions of Harriet Tubman, in commemoration of the 200th anniversary of her birth. Organized by Sankofa Artisans Guild, the exhibition included works by artisans from around the country. In April 2023 the site opened *nkwiluntâmên: I long for it; I am lonesome for it (such as the sound of a drum)*, a sound installation by Nathan Young (Delaware/Pawnee/Kiowa), funded by a grant from The Pew Center for Arts & Heritage. The outdoor audio experience takes listeners on a journey through the riverfront grounds, transforming the historic site with original, collaborative compositions. The music, voice, and environmental recordings invite audiences to meditate on enduring Indigenous relationships to land.



PA History 2 Go Videos Take Virtual Visitors to Trails of History Sites

In June PHMC officially launched PA History 2 Go, a series of 70 videos designed to attract virtual visitors to the Pennsylvania Trails of History sites and museums and deepen their understanding of Pennsylvania history. The project was funded by a grant from the Institute of Museum and Library Services (IMLS) through the Coronavirus Aid, Relief and Economic Security (CARES) Act. Each video explores a particular site or some facet of its history, offering not only a personal learning experience but also a springboard to future in-person visits and further learning and discovery. In addition to the videos already produced and hosted online at phmc.pa.gov, the initiative has secured PHMC with the necessary equipment and software to produce new videos that can be shared continuously.





Erie Maritime Museum Celebrates 25 Years

Over the past two and a half decades, the Erie waterfront has developed around the Erie Maritime Museum, a vibrant attraction that brings visitors and residents to the water's edge of Lake Erie. The museum is the homeport of the U.S. Brig *Niagara*, a faithful reconstruction of Oliver Hazard Perry's relief flagship during the Battle of Lake Erie in the War of 1812. Day sails on the *Niagara*, music and art events, changing exhibits, and presentation of the compelling stories of Erie's naval and environmental history are all part of the programs offered at the museum. Among its notable exhibits are a mast with full-size rigging to show the scale of the ship; the prow of the USS *Wolverine* (formerly *Michigan*), the U.S. Navy's first iron-hulled steamer, assembled in Erie and launched in 1843; and a display illustrating the devastation wrought by wooden ship warfare. On June 12, 2023, the museum marked its 25th anniversary. As part of the celebration, a recently acquired iceboat—a recreational craft with runners for moving over ice—was put on exhibit to enhance the museum's story of Erie's waterfront.

Pennsylvania Military Museum Partnerships Lead to Successful Programming

Partnerships are a vital component of the programs and exhibits held for the public by the Pennsylvania Military Museum (PMM) in Boalsburg, Centre County. In January 2023 PMM and The State Museum partnered with the Pennsylvania Farm Show, the Department of Military and Veterans Affairs (DMVA), and other nonprofits representing veteran interests and historic preservation to coordinate a 600-square-foot booth at the Farm Show exhibiting the World War II history of the Middletown Air Depot and the Farm Show Arena. During the war, the arena was used by more than 2,000 women to service Army Air Corps bombers and fighter planes. The booth included hands-on immersive experiences and seating areas for veterans to share their stories with the public, welcoming 4,345 unique visitors. PMM also held a conference on the role of women in the military from the Revolutionary War to the present to mark the 75th anniversary of the Women's Armed Services Integration Act, partnering with several Commonwealth agencies and local businesses.



Cornwall Iron Furnace Marks Anniversary of Mine Closing Through Community Events

In June 2023 Cornwall Iron Furnace, a Trails of History site in Lebanon County that is home to the only intact charcoal cold blast furnace in the Western Hemisphere, marked the 50th anniversary of the closing of the Cornwall iron ore mines with community events and the release of a new book, *Always More Production*. From the 1730s to 1973, the mines operated near the furnace to supply the raw material it needed for production. The Cornwall community is closely connected to the mines through family history and the actual experience of those living who worked at the mines. The site held a retrospective presentation that reflected on the legacy of more than two centuries of iron mining at Cornwall and a tribute at nearby Cornwall Elementary School that concluded with the recognition of those former miners in attendance as well as a wreath-laying ceremony at the miner statue in front of the school.

PA SHPO's programs include supervision of planning and construction grants for the continued use of historic properties; management of state and federal tax credit programs for the rehabilitation of historic buildings; maintenance of a publicly searchable database of historic and archaeological resources; delivery of survey programs for historic and archaeological sites; administration of the National Register of Historic Places, Certified Local Government, and Pennsylvania Historical Marker programs; and outreach to local communities and partners through the Community Preservation program and statewide historic preservation plan. Under the National Historic Preservation Act and the Pennsylvania History Code, PA SHPO partners with state agencies, developers, local governments, and citizens to review thousands of state and federal projects annually, ensuring that significant historic and archaeological resources are incorporated within project planning.

Cameron County Receives First National Register Listing

As of this year, each of Pennsylvania's 67 counties now has at least one property entered in the National Register of Historic Places, the official list of the nation's historic districts, sites, buildings, and structures worthy of preservation. In October 2022 the Cameron County Courthouse in Emporium became the first National Register listing in Cameron County thanks to SHPO's proactive initiative to recognize underrepresented themes and locations in its programs, preserving a broader history of Pennsylvania. The courthouse represents a significant contribution to the history of civic architecture in Pennsylvania. Designed by Amos S. Wagner and constructed by John W. Kriner in 1890, the courthouse is a three-story, Romanesque Revival-style building featuring round arches, a turret, and a five-story clock tower topped with a rare blindfold-free Lady Justice statue. The building retains a good degree of architectural integrity, with much of the original interior plan, materials, form, and massing intact to convey a historic understanding of its function.



SHPO Welcomes Columbia as Its 50th Certified Local Government

PA SHPO coordinates the Certified Local Government (CLG) program in Pennsylvania in partnership with the National Park Service to promote and support effective historic preservation programs and policies in participating municipalities. Designation as a CLG is a mark of distinction that provides communities with credibility, as well as access to technical assistance and grant programs. It indicates that the municipality follows best practices and views preservation as an integral part of its community and economic development. This year Columbia, in Lancaster County, became Pennsylvania's 50th CLG. An active center of industry in the 19th century, the borough contains many residential, religious, and commercial buildings designed in a wide variety of Victorian-era styles, with more than 830 located in the Columbia Historic District. Columbia is also the headquarters of the National Association of Watch & Clock Collectors (NAWCC), which operates the National Watch & Clock Museum, NAWCC Library & Research Center, and NAWCC School of Horology for training clockmakers.



SHPO Coordinates Funding to Preserve Historic Pennsylvania Barns

PA SHPO played a significant role in the development and implementation of a new source of funding to preserve historic barns. The Historic Barn and Farm Foundation of Pennsylvania (HBFF), a statewide nonprofit organization dedicated to providing educational resources for the long-term preservation, protection, and documentation of historic barns and agricultural heritage in the Commonwealth, launched a matching grant program to encourage the maintenance and repair of barns that are at least 50 years old, originally served an agricultural use, and retain a significant degree of historic character and materials. The grant program was developed as mitigation during the Section 106 consultation for a Federal Highway Administration-funded roadway project. Through this funding program, matching grant awards of up to \$2,500 will be distributed as a reimbursement after the project is completed in accordance with the agreed upon plan and preservation standards.



Stone Landscapes are Documented in SHPO's PASS System

Mysterious rows and walls and piles of carefully stacked stones exist in rural areas throughout Pennsylvania. Many were created by early European settlers as they cleared land for farms and communities; however, others are believed to have earlier Native American origins and some type of function. PA SHPO's archaeologists have explored these stone landscapes to discover clues about their age and purpose and record the locations in the Pennsylvania Archaeological Site Survey (PASS), the statewide inventory of approximately 25,000 archaeological sites that represents more than 16,000 years of Pennsylvania's history. Recording archaeological sites such as the stone landscapes is an important step in the consideration and potential protection of these sites under state and federal laws. The PASS records preserve basic information about the sites—the when, where and what—and are digitally stored in PA-SHARE, Pennsylvania's GIS and online project management system, where the data can be accessed for research by professional archaeologists.



The Bureau of Management Services supports the overall operation of PHMC through its divisions of Architecture & Preservation, Marketing & Media, Fiscal & Office Support Services, and General Operations.

Architecture & Preservation

manages facility planning, architectural and engineering design, and construction projects for all PHMC facilities. Active capital projects in the last year included the completion of the new Pennsylvania State Archives building and overseeing projects in design, including the construction of a roundhouse at the Railroad Museum of Pennsylvania and upgrades at Conrad Weiser Homestead, Daniel Boone Homestead, Erie Maritime Museum, Landis Valley Village & Farm Museum, Pennsylvania Military Museum, and The State Museum of Pennsylvania. The division also managed approximately \$3.5 million in Keystone Recreation, Park & Conservation Fund-supported projects at PHMC historic sites and museums.

Marketing & Media

supports PHMC through media relations, graphic design, photography, web administration, social media, and the publication of PHMC's quarterly magazine, *Pennsylvania Heritage*. Through social media this year, PHMC programs reached 90,356 followers on Facebook and 6,632 on Twitter. *Pennsylvania Heritage* published the last interview with Phillies baseball legend Dick Allen and features on the struggles for Black civil rights, the legacy of playwright August Wilson, archaeology at Fort Halifax, Elizabeth Drinker and the Quaker exile during the Revolution, the Plastic Club of women artists, and Gen. George C. Marshall, among others. The *Pennsylvania Heritage* website received 293,255 views and 190,563 visitors in 2022–23.

Fiscal & Office Support Services

is responsible for PHMC's more than \$52 million overall budget, including federal, state, and private funding sources. The division leads all PHMC's purchasing, contracting, revenue sourcing, corporate/purchasing credit card utilization, and commerce transactions and oversees all requests for proposal and procurement processes for acquisition of goods and services. The division utilizes SAP (the Commonwealth's accounting system), e-Grants, and a variety of other information and financial management systems to provide support services dedicated to the entire agency.

General Operations

directs the agency's information technology (IT) functions and manages the preparation of the agency's IT Strategic Plan ranging from SharePoint administration to managing large-scale projects like the Ticketing, Events, and Membership Management System (TEMMS) across all sites and museums. The division assists PHMC on human resource planning, recruitment, workplace health and safety procedures, agency project management, continuous improvement initiatives, and management and personnel studies or surveys to improve or create administrative methods and practices.
