ORDERED by the Pennsylvania Human Relations Commission

1. That the Respondent, George R. Ulrich, doing business as George's Cafe, and his agents and employees (who shall be so instructed by the Respondent) shall not directly or indirectly refuse, withhold from or deny to the Complainants and to other persons, because of their race, color, religious creed, ancestry or national origin, the accommodations, advantages,

facilities or privileges of the cafe located at 530 Maryland Avenue, York, Pa., or any other cafe operated by the Respondent within the Commonwealth of Pennsylvania.

- 2. That the aforesaid Respondent shall take the following affirmative action which, in the judgment of the Commission, will effectuate the purposes of the Pennsylvania Human Relations Act:
 - (a) Extend to the Complainants and to all persons, without regard to their race, color, religious creed, ancestry or national origin, full, equal and unsegregated accommodations, advantages, facilities and privileges of the cafe located at 530 Maryland Avenue, York, Pa., and any other cafe operated by the Respondent within the Commonwealth of Pennsylvania.
 - (b) Post and maintain, in a conspicuous place at the aforesaid cafe or any other cafe operated by the Respondent within the Commonwealth of Pennsylvania, where patrons entering same may easily see it, a copy of the Commission's poster relevant to equal accommodations, which is furnished by the Commission, and
 - (c) Notify the Pennsylvania Human Relations

 Commission at its headquarters office at 100 N.

 Cameron Street, 4th Floor, Harrisburg, Pa. 17101,
 in writing, within fifteen (15) days after service

hereof, as to the steps Respondent has taken to comply with this Final Order.

OPINION, COMMISSION'S DECISION AND FINAL ORDER

On December 12, 1968, a Complaint was filed with the Pennsylvania Human Relations Commission (hereinafter referred to as "Commission") by Benjamin Thomas, Jr. against George R. Ulrich, doing business as George's Cafe, alleging that on October 23, 1968, the Respondent refused, withheld, and denied to the Complainant, because of his race (which was Negro), the accommodations, advantages, facilities or privileges of his place of public accommodation; further alleging that the Respondent operated George's Cafe, which was open to, accepted and solicited the patronage of the general public and that such a place was a "place of public accommodation" within the meaning of the Act of October 27, 1955, P.L. 744 as amended, in Section 4 (1) thereof, known as the Pennsylvania Human Relations Act.

Investigation of the facts in the case resulted in the finding of probable cause to credit the allegations of the Complaint and the Commission ordered a Public Hearing to be held in the matter, assigning as Hearing Commissioners, Stanley A. Miller, Chairman, and Wilma S. Heide and Andrew G. Freeman.

No Answer in this matter was filed by Respondent.

The Public Hearing was held on May 27, 1969, in the Community Room of the York Bank and Trust Company, 107 W. Market Street, York, Pa., beginning at 10:30 A.M., and Notes of Testimony in said hearing were taken by Eugene W. Holbert of Mohrbach & Marshall Inc.

The Commission was represented by Stanton W. Kratzok, Esq., its Assistant General Counsel, and Victor Dell'Alba, Esq. appeared for the Respondent. The Respondent and his witnesses were present in Court. The Complainant did not appear.

This matter was heard together with John Edwards, Complainant, vs George R. Ulrich, Doing Business As George's Cafe, Respondent, Docket No. P-563, and Charles E. Carter, Complainant, vs George R. Ulrich, Doing Business As George's Cafe, Respondent, Docket No. P-564.

At the conclusion of testimony in Docket Nos. P-563 and P-564, motion for dismissal of this matter, Docket No. P-561, was made on the ground that there was no testimony in support of the Complaint.

Since there was no testimony offered to prove the allegations herein, it is therefore recommended that the Commission enter an Order dismissing the Complaint against Respondent George R. Ulrich, doing business as George's Cafe.

COMMISSION'S DECISION

AND NOW, , 1969, upon the Recommendation of the Hearing Commissioners and in consideration that there was no testimony offered in support of the Complaint at the Public Hearing of this case, the Pennsylvania Human Relations Commission, by unanimous decision, finds and determines that the Complaint of Benjamin Thomas, Jr. against George R. Ulrich, doing business as George's Cafe, be dismissed.
